

Dear FBI, IRS, Arizona AG's Office and Sedona Police,

We continue to affirm that Patton West is the head of a criminal racketeering gang which has operated in three western states over the past 30 years. We contend that Patton West is responsible for at least one murder, and according to the whistleblower and Patton West's ex-husband Jack West, several other murders. The answer is clear. The information on Watson's website, rendered Patton West's multi-million dollar a year fraud scam dead in the water in Montana. Before Patton West could relocate to Arizona and reincarnate herself as the planetary regent, she had to silence Watson by any means. Murder was tried first – it failed. Plan 'B' was put into operation in 2010. After [winning his fraud lawsuit](#) against Patton West, Watson travelled from abroad to Montana in 2010 to see how much the court was [going to award](#) him. Upon arrival at court, he was served with two defamation lawsuits (for telling the truth) by Patton West and her accomplice Reynolds. The truth is an absolute defense against defamation. However, the truth does not matter if you cannot afford to fund the cost of lawyers and air fares to travel to and from the USA to defend the lawsuits. Williams had promised in January, to provide all the money his cult gang leader Patton West would need to outspend Watson in court and force down his website, and that is exactly what happened.

**After Watson's website was forced down in 2010, Patton West and the cult, including Williams, relocated to Arizona where Patton West, aided and abetted by Williams, is selling fake cures for cancer. It is not just that Williams wants to hide Patton West's criminal past. By continuing to endorse her with a stream of fake testimonials he endorses her lies and propaganda for example about being a 'Planetary Regent' and the 'Mother of Ten Thousand Suns' etc.**

When information from Watson's websites started to appear online again, Williams doubled down on his treachery by posting a statement online in 2018 which asserted that the injunction he 'bought' with his money was something it was not. Note in the image below, Williams indicates that he is a board member of Patton West's latest fraud / extortion vehicle 'The Omni Institute.' Patton West is a vicious and cruel psychopath and quite possibly a serial killer. Here are four examples of Patton West's violent assaults upon members of her cult or cult member's children. Dr. Pat Cole MD repeatedly hit over the head with the heel of Patton West's shoe until blood ran down the victim's blouse. The [Whitefish Pilot](#) newspaper has details. Susannah Felder partially scalped by Patton West after Susannah questioned Patton West about an \$80,000 donation Patton West stole from the charity she later bankrupted. Beatrice McGuire had part of her ear ripped off after calling out one of Patton West's lies in front of an audience of scores of attendees to one of Patton West's gatherings. **6. The Rishi Collection. Fine Art, Sacred Heirlooms and Antiquities.** Fact. After Patton West's charity was [struck off](#) for fraud in January 2004, and with several lawsuits against her, she defrauded the charity out of its largest single asset; a property worth \$1,250,000 (as valued in 2002). This asset's ownership was transferred to a private trust fund she had set up for herself and her eldest son, Rob Meador. The purpose of the trust fund was to hide the asset from her creditors which did not work, as in 2008, a judge arranged for the sale of the property at a [Sheriff's Sale](#) to force Patton West to pay for \$2,000,000 worth of court fines and interest that she owed her creditors. Also in 2004, Patton West stole \$4,000,000 in artwork and valuables owned by the charity, which like the property, were largely funded by public donations. When questioned about the artwork and valuables in court under oath in 2009, Patton West denied their existence stating that they were lost or stolen or carted away.

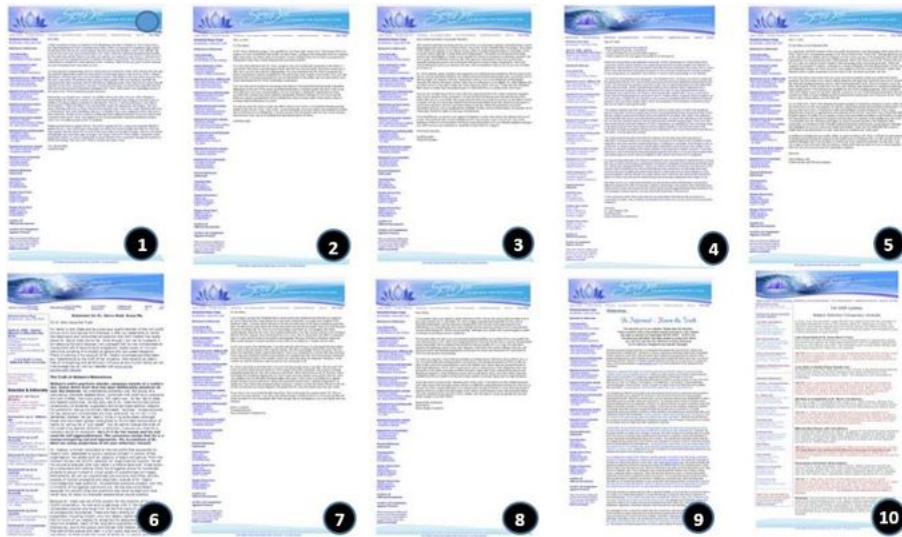
**7. ## Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

Patton West's response to news of her conviction for assault appearing in a local newspaper was to post a statement on her website denying the conviction. She even states that the court dismissed the 'bogus assault case' which is a total lie.

### Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

Like the rest of Patton West's testimony, her answer to the court was a lie. As the [Whitefish Pilot](#) newspaper article published that very day, makes clear Patton West was in debt. The following is a quote from the that news article.

Here in the Flathead, West ran into problems over several properties where she lived. On June 1, she was evicted from a \$2 million Lakeside waterfront home when she failed to pay a second \$50,000 down payment. She then moved into another Lakeside with her son and daughter-in-law. "All she got out of the house was her cat," said Larry Phillips, a Realtor with Land Rush Realty. When asked about the eviction, West said a few weeks away from home were worth the trouble. She claims to be negotiating a better deal on the property due to a water rights dispute. According to court documents, West is behind in payments on the second home.

A month later, a second newspaper article was published by the [Bigfork Eagle](#) newspaper. Which categorically showed that Patton West was not a billionaire, not a millionaire and not even solvent. The following is a quote from that article.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute. 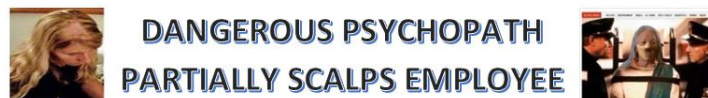

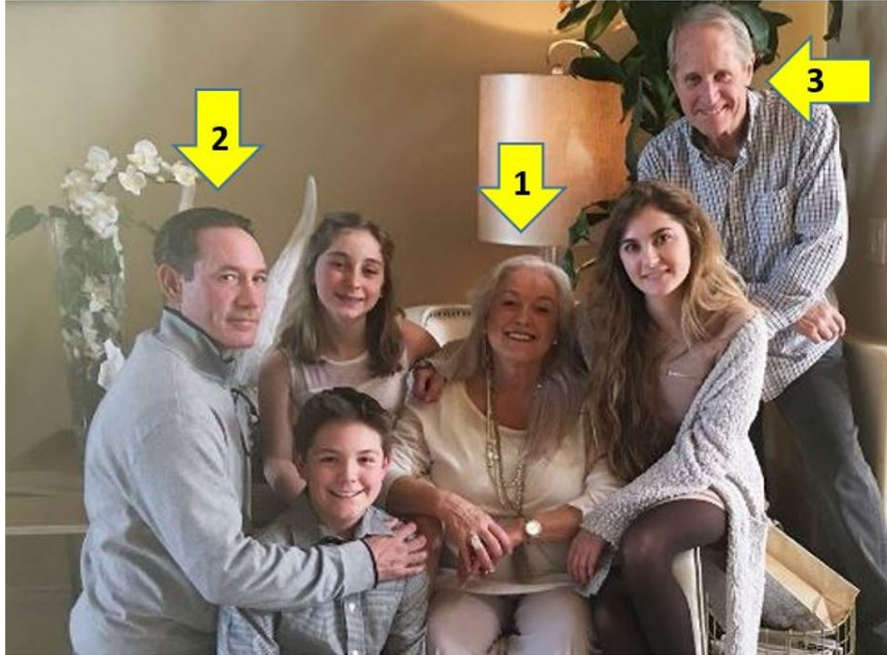

Whether civil court cases or employment tribunals, victims stand little chance of getting justice, as all Patton West has to do is to flood the proceedings with false witnesses who will all swear her innocence. If anyone still doubts that Devra Patton West is a hardened criminal / suspected serial killer, then listen to what she had to say to fraud victim, John Watson, when he announced he was going to sue her for fraud. The following are two excerpts which were taken from a [44 minute audio recording](#) of their meeting in March 2003.

**1. West says that the truth does not actually matter. \***

*\*If she can persuade the public via her website and social media postings that her lies are their truth. HELLO! IT'S A CRIMINAL RACKETEERING BUSINESS MODEL!*

*\*If she can persuade a judge and jury (with the help of 'liars for hire' Jack West, Geoffrey Reynolds CPA and Dr. Julio E Williams MD) that her lies are truth. **2. West says she feels stabbed in the back and f\*cked up the arse by Watson's insistence that West pay her the \$50,000 she owes him.\***

*\*Patton West says (shrieks) that if Watson sues her she will get so f\*cking down and dirty, huge expenses coming out of his pocket and not hers. Not hers because members of her cult / criminal gang will pay her legal expenses. In January 2007 senior cult member Dr. Julio E Williams MD sent a threatening email to Watson in an attempt to intimidate Watson into dropping his lawsuits against Patton West.*

In his threatening email, senior cult member Dr. Julio E Williams stated that he had set aside \$2,000,000 for Patton West's legal fees. In March 2007, John Watson received a [harrowing email](#) from one of Patton West's employees, also the subject of violent intimidation, which stated that Dr. Julio E Williams had just 'donated' \$100,000 to Patton West. Clearly, this was a 'down payment' on Patton West's legal expenses as in 2010 Patton West (and cult / gang member Geoffrey Reynolds) launched [multiple frivolous](#) (without merit) lawsuits against Watson two years after he won his [fraud lawsuit](#) against Patton West in 2008. The purpose of the lawsuits was to bankrupt Watson into silence where the 2007 murder plot had failed.

**Why would Dr. Julio E Williams MD, a total stranger to Watson, put up hundreds of thousands of dollars to fund Patton West's legal costs? Far from remaining free of wrongdoing, Patton West's acquisition of occult (hidden) knowledge between 1990 & 1991 while attending the [Robert Jaffe School for Energy Mastery](#) (itself a cult) leveraged her criminal tendencies. In possession of a secret weapon, Patton West formed a cult around herself and forced the sheeple to fundraise for 'save the world projects' which never came to fruition, as all the money went into her pocket. In addition to fleecing the rank and file members of her cult, Patton West sought to land bigger fish like Dr. Pat Cole MD, from whom she extorted Cole's entire net worth estimated at \$1.3 million. 1. They have been subject to classic CIA brainwashing and conditioning which involved breaking the target's will and then rebuilding them as obedient droids, who submit to the will of the guru. Ex- cult member, Debra Coffey, explained how this worked in a [statement](#) she gave to the whistleblower John Watson.
2. Most cult members have given up all their friends and outside interests and much of their capital, so have nowhere else to go.

Victims like the whistleblower John Watson, who refuse to go away empty handed after being defrauded, become the target of threats and intimidation. Below are the parts Williams & Reynolds played in Patton West's plot to murder Watson and when that failed, conspired with her to bankrupt him into silence.

**1.** Though Watson was a total stranger to Dr. Williams he, no doubt at Patton West's behest, defamed Watson in 2005, and then in 2007 sent Watson a threatening expletive laden email promising to make available \$2,000,000 of his own money for Patton West's legal fees.

We will leave it up to law enforcement and the psychiatrists to decide whether Patton West is just a hard-nosed vicious criminal or is criminally insane. However, we suggest that she is interviewed / arrested ASAP and held without bail while victims and witnesses are interviewed. If she were at large while this process was being carried out, she would simply target potential hostile witnesses with her secret weapon. Apparently lies and propaganda are all allowed under religious freedom laws even if the obvious motive is mail and wire fraud, racketeering and murder.*

3. Dr. Julio E Williams MD has provided his own home as a venue for prospective buyers of fake cures to come and meet his “virtual well spring of living divinity.” Dr. Julio E Williams MD remains a willing participant in fraud and extortion.
