On August 9 2007, while giving an interview to a local newspaper, senior cult / gang member Geoffrey Reynolds CPA announced that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children. However, the criminal code is very clear about a conspiracy by two or more persons who act together to intimidate or attempt to murder a person or persons.

18 U.S. Code § 241 - Conspiracy against rights

If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or..

They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.

When the plot to murder Watson failed, Patton West, Williams & Reynolds put Plan 'B' into effect, which was to launch multiple frivolous lawsuits against Watson, with the aim of 'outspending' him in court. Defrauding the public out of cash donations based on a fake life story / bio is just the tip of the iceberg. Patton West's (1) business model involves theft, fraud, extortion and murder. However, Patton West has a huge advantage over Tony Soprano in that the weapon she uses to facilitate theft, fraud, extortion, intimidation and murder, is not recognized as a weapon by legal statute. This explains why Patton West is still at large after 30 years of organized crime. As with the Mafia, 'if you mess with the dough, you gotta go.' 2. When the murder plot failed and Patton West's campaign of violent intimidation against Watson failed to stop him, Patton West put Plan 'B' into operation. 

The next time Patton West, Williams & Reynolds attend court, it will be a criminal court. When that happens, the court will learn that in addition to being a 'board member' of 'Omni Institute for the Divine Sciences,' that Patton West is currently using to facilitate organized crime, they'll learn that Dr. Julio E Williams fulfilled the same role with the corporations she used to facilitate crime in Montana. Below is what the [Bigfork Eagle](#) newspaper had to say about Patton West's businesses in August 2007.

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.


Between 2007 & 2009, Patton West acquired two arrest warrants (1) & (2), a [conviction for assault](#) and was forced to sell her assets at a [Sheriff's Sale](#) to pay past creditors \$2,000,000 in court fines and interest. At the very same time, Dr. Julio E Williams MD was busily 'marketing' Patton West to the Montana public as a saint, as part of a massive fraud scam. Just as he is doing now in Arizona. Below is an excerpt from the 'gushing' statement Williams posted on Patton West's website. Clearly Dr. Julio E Williams MD is mentally ill or he has been a willing accomplice in racketeering and murder for the past 20 years.

Again, we make the case that Williams knew all about [the lies](#), [the crimes](#), her [fake life story](#), the [false career opportunities](#), the [fake miracle cures](#) and the [fake testimonials](#). Williams is directly involved in selling the fake miracle cures, even to the extent of [providing his own home](#) as a venue for the crimes to take place. And many of the fake testimonials are from him!

2A. FIRST BONUS CRIME FROM WILLIAMS. On Patton West's website, alongside Williams' gushing sycophantic testimonial for his cult / gang leader, was the image depicted below.



Patton West called this property 'The Living Waters Healing Center'. However, the 'healing center' did not exist and the property being depicted in the image belonged to Robert and Tabby Ivy, who did not give Patton West permission to use it in her brochures or on her website. This is what the owners said about the matter when interviewed by the [Whitefish Pilot](#) newspaper on July 12 2007.

A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim. "Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."


