



Above: The images above are evidence that Patton West is mentally ill and or criminally insane. Patton West's behavior clearly indicates a narcissistic personality disorder and gives us all an insight into the delusional fantasy world she exists within.

That is because it is all part of a massive fraud / extortion scam occasioned with violence and, according to her ex-husband, several murders.

As a revered executor of the Divine Plan, she is assigned the "Great Work" of guiding humanity through an extraordinary time of global upheaval and profound transformation that charts a new course for a thriving, peaceable fellowship amongst souls, peoples and nations.

The following are two obvious examples of outright lies (see above). All apparently allowed under religious freedom laws. Even though the obvious motive is fraud.

1. She is 'sanctified' to embody the role of the 'Regent of the New Americas.' This, in spite of being chased out of New Mexico in 1995 at the point of a gun. This, in spite of being forced to leave Montana in 2010 after two arrest warrants, a conviction for assault and being forced to pay \$2,000,000 in court fines and interest to past victims of crime. This is either a miracle or total bullshit.

2. As a revered executor of the Divine Plan, she is assigned the “Great Work” of guiding humanity etc. Do you think the Divine Plan and “Great Work” involves countless acts of theft, fraud, extortion, mental and physical abuse, one murder, a well-documented attempted murder (of a whistleblower) and several suspected murders? She is either telling the truth or this is more bullshit and part of a well-oiled criminal plan. Or she is mentally ill!

Convening the supra genius of the enlightened state of embodied mastery, she leads a new era for world service, that sets a new standard for prospering all spectrums of world betterment.

What was once, but a shimmer of hope and aspiration, is now divine destiny becoming manifest.

1. As a “regent of the spiritual hierarchy” etc. This is just bullshit like her assertion that she is [The Regent of the Masters](#) (i.e. above Jesus Christ), [The Western Regent](#) (spiritual overlord to the western hemisphere), [The Mother of Ten Thousand Suns](#), [The Mataji](#), [Divine Mother](#), she has been preparing [to lead humanity for thousands of years](#), is [holding open the gates of time](#) and who received her two doctorates [from the Christ in person](#) etc.

2. Five years from now, Patton West will be recognized as one of America’s most vile and despicable villains. A ruthless and cold blooded criminal who, using her occult hidden knowledge has robbed, defrauded extorted money from, and mentally and physically abused countless victims. Then, there are the several suspected murders her ex-husband, Jack West, maintains she is guilty of. This, confirmed by the whistleblower John Watson who Patton West tried to murder in 2007.

Above: With Millions of dollars from organized crime over three decades Patton West can afford to live in luxury at the expense of those she has robbed, defrauded and extorted money from. Her life story is a lie; her fake delusional persona is created out of the mind of a deeply disturbed psychopath. The outfits, fake diplomas and all the other trappings of her fantasy reality look like a Hollywood film set. Your role, should you choose to take it, is to play the role of supine serf to the self proclaimed Regent of the New Americas. However don't tell the Empress she has no clothes. Women have been beaten and mutilated for less.

In March 2003, a business consultant and fraud victim at Patton West's hands was asked to attend a 'private' meeting with Patton West. The meeting was asked for by Patton West shortly after John Watson announced he was going to sue Patton West for defrauding him. During the meeting, Patton West [admitted defrauding Watson](#) but said she did not see herself writing out a check for what she owed him. When Watson asked about their agreement, Patton West stated that [her agreements were worthless](#) and, as for the truth, Patton West told John Watson that, and I quote, "[It doesn't matter what is actually true.](#)" What she meant was that the truth does not matter if she can persuade the public that HER LIES ARE THEIR TRUTH. Patton West admitted to [disposing of people like Kleenex](#). When Watson said he was not going to back down, the creature currently posing as 'Divine Mother' had the following to say. You can hear her say this in her own voice because Watson recorded the conversation.

In 2006, fraud victim John Watson turned whistleblower, put up a website to counter the lies, propoganda and [defamations of Watson](#) that Patton West and members of her cult were posting on her website. Watson's website included details of the many crimes that Patton West had committed in New Mexico and Montana, or was in the process of committing in Montana (see long list above).



Above from left to right: In July 2007 the Whitefish Pilot leads on Patton West's assault on her business partner Dr. Cole MD. The Bigfork Eagle follows with a similar story in August 2007. In April 2008 Patton West is found guilty of assaulting Cole. In October 2008 Patton West is found guilty of defrauding John Watson. Patton West denies all wrongdoing.

After Watson contacted a local newspaper and shared his information in 2007, the [Whitefish Pilot](#) newspaper published a detailed list of some of the crimes being committed in Montana by Patton West at that time. The article led with Patton West's vicious assault on her business partner Dr. Pat Cole MD. This was followed a month later by a similar news article published by the [Bigfork Eagle](#) newspaper which showed Patton West to be a pathological liar. A pathological liar masquerading as a billionaire, while having a \$2,360 lien against her for unpaid employment insurance and while being evicted from two rental properties in quick succession. This in turn was followed in 2008 by an article published by the [Ravalli Republic](#) newspaper, which focused mainly on Watson winning his fraud lawsuit against Patton West.



Above: Psychopath, narcissist and pathological liar Patton West photographed lounging around her mansion wearing an Indian Swami outfit. Like her many self awarded titles and accolades it is all part of the propaganda intended to support the illusion that she is something she is not. She has come a long way from the '80's & '90's a pot growing, drug dealing, con artist and bankrupt. No matter how much lipstick you apply to this pig it is still an evil vicious criminal and a suspected serial killer.

Watson's website and all the negative publicity from the three newspaper articles, rendered her criminal racketeering business model dead in the water in Montana. Patton West's criminal business model relies on the public swallowing the lies and propaganda about her being a 'divine' being. Once the community in which Patton West is embedded within understands that all her titles and accolades are fake, her two doctorates (PhD & D.D.) are fake and that her life story is a fantasy, they are less likely to walk into the trap. With no one in Montana believing the 'divine being' propaganda used to underpin Patton West's fake identity, she and her cult had no option but to move to a third western state where they either do understand 'white collar' crime or do not have the resources to prosecute it. However, before Patton West could relocate her criminal racketeering business model to Arizona and reincarnate herself with another fake identity, she had to force down John Watson's website and permanently 'silence' him.

In mid-August 2007, Patton West made a failed attempt to murder John Watson. A murder plot that cult / gang member Geoffrey Reynolds shared with a news paper reporter a week earlier in what he thought was an 'off the record' conversation.



The only thing that separates Patton West from other gangsters and serial killers is her choice of weapon. Al Capone wore expensive Italian suits and masqueraded as a businessman. Al Capone used a gun or a knife which could be traced back to him.

Patton West being a criminally insane narcissist, wears King sized bedsheets and masquerades as a 'divine' being. The advantage Patton West has is that she uses an occult (hidden) weapon that cannot be traced back to her. So, the preferred method to 'silence' Watson was to use the [shamanic weapon](#) to murder Watson. Because Shamanism and the occult is not recognized as a weapon under legal statute, she could not be prosecuted, even though her accomplice Geoffrey Reynolds announced Watson's murder a week before it was supposed to happen!

MANY VICTIMS TERRORIZED INTO REMAINING SILENT AND SOME MURDERED.

However, her frequent use of the occult against those who oppose her, including her employees and family members is very real. In March 2007, then employee Rebecca West (no relation to Patton West) wrote to John Watson asking for help with Patton West's "shamanic witchcraft." Go here to read her harrowing email entitled '[Help Me.](#)' Go to paragraph three but on the way, read about the crimes being committed against her employees who were given the choice to join her cult as low paid or no paid slaves or be fired. According to Patton West's ex-husband Jack West, several individuals who have opposed his wife have 'died suddenly.' These extra judicial killings cannot, in the ordinary course of events be linked to her, especially as the victims she targets could be hundreds or thousands of miles away.



Above: Center: Patton West a narcissist occult killer who has embedded herself within spiritual communities in New Mexico, Montana and now Arizona. Patton West on-line persons is a total fantasy but she is confident that she can intimidate, make ill, injure or murder anyone who challenges her version of reality with the truth.

After 30 years of using her secret 'weapon' the psychopath has left behind a trail of evidence (and victims). Three decades of racketeering (theft, fraud, extortion, violent assaults and murder) with little or no downside to Patton West. The sheer volume of victims, and their reluctance to go to the police or to civil courts for restitution, can only make sense if one accepts that the victims and witnesses are afraid to go to the police, afraid to testify against her and afraid to go public. There is compelling evidence of the use of an occult weapon against victims like Dr. Cole, Rebecca West, Jamie Haywood and many more. Victims like [Mike Hendrickson](#) defrauded out of \$200K, [Dave Kushner](#) defrauded out of \$30K. Victims like [Marion Cantwell](#), kidnapped, beaten, held captive and forced to make a donation of tens of thousands of dollars. These victims will shed light on other victims. I bet there are scores or hundreds. The occult weapon is also used to [subvert civil and criminal court cases](#). The Kendal Haywood and Jamie Haywood child custody cases are two that come to mind. Patton West's home life is sordid beyond belief, as is spelt out in another expose' of one of her web pages entitled '[Enlightened Householding.](#)'

Clearly, the murders occur on a regular basis, as within 10 months of joining Patton West's cult / criminal gang in September 2006, new kid on the block Geoffrey Reynolds announced Watson's impending murder to the local press.

When her attempt to murder Watson failed, Patton West mobilized two senior members of her cult / criminal racketeering gang Dr. Julio E Williams MD & Geoffrey Reynolds CPA. Though neither knew Watson, they both agreed to join Patton West's conspiracy to 'silence' Watson. The conspiracy was funded by cult / gang member Dr. Julio Williams MD who pledged \$2,000,000 of his own money for Patton West's legal fees. Reynolds' contribution was to make totally false statements to a Montana court in what was a \$10,000,000 extortion scam mounted by the cult / gang against Watson. This all happened shortly after Watson [won his fraud lawsuit](#) against Patton West in 2008. Their role in Patton West's conspiracy is spelt out in detail [this previous bulletin](#).



Above: Williams & Reynolds were total strangers to Watson but both totally under the control of Patton West. On her orders both agreed to be complicit in Watson's murder and when that failed both conspired to bankrupt Watson into silence. Motive? Millions of dollars a year that Patton West would lose if the public in Arizona had access to the truth about her past.

Because Watson had moved abroad in 2005, he could not afford to travel backwards and forwards to defend Patton West's and Reynolds' lies. As a consequence, Watson's website was forced down and Patton West and the cult got to relocate to Arizona with no information up on the web to counter Patton West's obvious lies and propaganda. Clearly, everything on Patton West's website is designed to suck in victims of fraud and extortion. The other advantage Patton West has over most criminals is that her lies and propaganda appear to be protected under 'religious freedom' laws. Even though the obvious motive is fraud. At the very least, based on the information we have revealed in this bulletin Patton West is guilty of mail and wire fraud.

Here is how the current con works....

Those attending 'private sessions' or 'private audiences' if deemed to be wealthy, are made ill using the same occult knowledge Patton West uses to murder those who oppose her. She then offers the target, she has made ill, the cure for hundreds of thousands of dollars. They pay. The illness goes away. Patton West gets richer and awards herself more titles and accolades! Dr. Julio Williams MD is directly involved in this fraud / extortion scam and has provided his own home as a venue for the sale of 'miracle cures.' In spite of the scores of victims of theft, fraud, extortion and mental and physical abuse Patton West, a card carrying psychotic, insists that she is a blessing to all souls and an instrument of mercy.
