

## G REYNOLDS CPA – WHAT HE KNEW ABOUT ONE ‘SUCCESSFUL’ MURDER, ONE PLANNED MURDER AND ONE FAILED MURDER ATTEMPT.




*Above: Geoffrey Reynolds CPA a pathological liar, guilty of racketeering and complicity to commit murder while a member of Patton West's cult / criminal gang. Because the campaign of intimidation Reynolds announced in 2007, against the whistleblower, his wife and children, is ongoing the only way to stop it is to send Reynolds and his accomplices to trial.*

Reynolds cannot escape his membership of Patton West's cult / criminal racketeering gang between 2006 & 2014. Patton West is a dangerous psychopath, murderer and suspected serial killer. The weapon she uses to terrorize, intimidate and murder those who oppose her is not regarded as a weapon under legal statute. This both explains why she is not in jail serving life to 100 years for racketeering, and why she portrays herself as a minor deity. Below are a list of serious crimes that Reynolds was aware of, was complicit in or chose to commit himself.

**1. MURDER.** Reynolds was aware of the 2005 murder of student / cult member Lisa Swidler, who having witnessed two serious crimes committed by Patton West against other cult members, left the cult. Lisa, a young mother of two small children under the age of ten, died suddenly and shortly after leaving the cult and before she could report these crimes to the police. The first link is to the headstone of Lisa Swidler – murdered by Patton West. The second link is to a recording of victim, Dave Kushner, explaining how he was defrauded out of \$30,000. The third link is to a recording where Dave Kushner explains how victim, Marion Cantwell, was kidnapped, falsely imprisoned and beaten until she agreed to give up part of the sale proceeds of her house to Patton West. Upon release, Marion was told that if she went to the police she would be murdered.

**2. ATTEMPTED MURDER.** Reynolds was aware of the murder of Lisa Swidler in 2005 and knew that Patton West had murdered with apparent impunity (so far). On August 9 2007, Reynolds, while being interviewed by a local newspaper, announced the impending murder of a fraud victim turned whistleblower who went public about Patton West's crimes spree in Montana.



The first link below is to an image that shares Reynolds' conversation with the news reporter. Reynolds obvious foreknowledge of Patton West's intent to murder John Watson. The second link is to webpage which indicates that after the failed 2007 murder plot, Reynolds agreed to be a main player in Plan 'B.' This was a \$10,000,000 criminal conspiracy to bankrupt John Watson into silence by launching multiple frivolous (without merit lawsuits, that they assumed rightly he could not afford to defend.

Having 'silenced' Watson and forced down his website, Patton West, Reynolds and the rest of the cult were free to relocate to Arizona where they now operate. In addition to announcing Watson's impending murder on August 2007, Reynolds also announced a campaign of violent intimidation against Watson, his wife and children. This continues to this day. Reynolds has received over 500 emails from Watson about the ongoing campaign of intimidation. Reynolds ignores these emails because he knows Patton West has 'successfully' murdered several victims, has intimidated and brutalized scores, if not hundreds, over the past 31 years or more. These emails when presented at Reynolds' trial for racketeering and attempted murder will prove his complicity in these crimes.

**3. PLANNED MURDER.** Patton West sees herself as an 'apex predator.' Her personality cult, a front for organized crime, attracts spiritual seekers who get sucked by lies and propaganda. Patton West presents herself as an enlightened being when in reality, the evidence shows she is a psychopathic, suspected serial killer. Once victims have swallowed the 'kool aid' and been brainwashed and conditioned they are 'harvested.' If the psychological violence does not work, Patton West resorts to physical violence. The first link is to a newspaper article that shows what happened to one wealthy victim, Dr. Pat Cole, who was viciously assaulted by Patton West in the process of extorting \$1.3 million from Cole. The second link is to a statement given by Carlida Finch, an employee of Patton West's, who overheard Patton West talking about Cole's murder (if Cole did not hand over her wealth).

### Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

*Above: Patton West the only 'spiritual' teacher on the planet who uses abuse, violence and a hammer (to break bones) to propel students towards enlightenment. That said she may only use that technique against the wealthy students whose bank accounts and possessions she is trying to liberate – in the name of enlightenment of course!*

The third link is to a statement by another employee, Rebecca West, who was a work colleague of Geoffrey Reynolds. The statement by Rebecca clearly shows that Reynolds knew exactly what was going on around him but did nothing. The fourth link is to a series of statements Reynolds posted on Patton West's website which denied that Patton West had assaulted Cole. Patton West convicted of assaulting Cole in April 2008.

**4. MASSIVE FRAUD.** Reynolds knew that Patton West's corporation was a front for organized crime. Reynolds knew that he and the other directors were appointed by Patton West as her proxies and as such, had zero discretion to make decisions. Knowing this, Reynolds still applied to the government for a \$30,000,000 grant / loan to fund a Spa Complex. Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.

*Above: Of the six businesses that GEOFFREY REYNOLDS oversaw in Montana between 2006 & 2010 only one remained in good standing. Two were never registered, two were involuntarily dissolved and one was involuntarily revoked. These entities were front companies for organized crime. Using the front company Reynolds personally money laundered \$436,000 extorted from Cole and fraudulently applied for a \$30M loan.*

Reynolds did this knowing that Patton West was going to use some of the money to pay her debts which ran into millions. The first link is to an email from an employee that clearly states that the funds, were they to be granted, would be used to pay off Patton West's debts. The second link is to an email from Patton West's step mother from who Patton West defrauded \$30,000 from. The email clearly shows Patton West was going to use part of the \$30M to pay off her debts. The third link is to a web page that contains Reynolds online resume. Scroll down seven eighths of the web page to Reynolds' 'Selected Accomplishments.' In which he claims to have \$30M in wrap loans. This did not happen and yet, the truth does not matter to a pathological liar like Reynolds. This may explain why his online resume has been removed. The fourth link is to a posting in which Reynolds states how proud he is to be associated with Patton West and how she has been guiding his life for many years.
