

In view of the **continuing campaign of intimidation** against the whistleblower, mounted by domestic terrorist / criminal gang leader Devra Patton West, we have decided to send you four emails a day until there is clear evidence of a criminal investigation into these matters. Matters that involve theft, fraud, extortion, violent assaults, attempted murder and at least one suspicious death. Up until recently the proceeds of financial crimes were money laundered through Devra West's 'business' by Geoffrey Reynolds CPA who was so confident of Devra West's ability to get away with murder that he announced the whistleblower's impending death to a Bigfork Eagle news reporter in August 2009, some weeks before Devra West made her failed attempt to kill him. What Geoffrey Reynolds CPA actually said to the reporter, in what he thought was an 'off the record' comment, was that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family.

**Devra West has been doing this kind of thing to victims and their families for at least 25 years; with those victims and witnesses who go public (or don't pay up quickly enough) becoming the subject of the kind of treatment Geoffrey Reynolds described as being the fate of the whistleblower.**

One of the emails will detail the whistleblower's journey through Devra West's guru / cult / extortion business model and the lengths that she and the senior members of her cult went to silence him after he went public (attempted murder and criminal conspiracy) - this email to be sent daily. The other two emails, which will rotate on a daily basis, will highlight other crimes committed by Devra West (and her accomplices) against scores of victims inducted into the cult largely through the efforts of Julio Williams MD – a senior member of Devra West's cult who is responsible for marketing her to the public and recruiting new victims.

**A Sufi Cult**

From 1998 to 1999, I was a member of a Sufi order that has gone by various names. Some of the group's names are:

Shadhiliyya, Shadhuliyya, Shadhuli, Shaduli, University of Spiritual Healing & Sufism, **Jaffe Institute, School of Energy Mastery** **1.**

The Sufi healing workshop I took involved a lot of deep emotional releasing. I was so opened up that on the final day of the workshop I "took the promise" to be a Sufi in the Shadhiliyya order, even though I barely knew what that meant.

After I took the promise, a member of the group, Hamid, approached me and said that **I needed to give some sort of donation to show my commitment to the path.** He said that it needed to be a substantial amount. Bizarrely, he told me that there would be an animal sacrifice made on my behalf. **I seem to recall giving somewhere around \$600, which was no small change to me at the time.** **2.**

We were told that all sorts of things were "against God". Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path.

Jaffe responded months later **and threatened that I could become sick and die from something like cancer for leaving.** That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it. **3.**

I once knew a girl who worked in the office for one of these spiritual groups that "healed" people. After a few years she quit in disgust. She was a smart girl, and she realized that the people in the clinic were dying at the same rate as anyone else with those diseases. there was NO EFFECT. The fake "doctor" at the New Wage healing clinic knew that as well. He knew they were dying like flies on a daily basis.

**But hey, making \$500,000+ a year in income is pretty tempting. too bad the money is coming from desperate, wonderful people who don't want to die, who are willing to sell their homes on any bogus New Wage treatment that promises them a healing.** **4.**

Then after their death their family is left with nothing.

**Only the most ruthless and sociopathic stay in that business for years.** If you are a decent person, after a few years at most you realize you are exploiting dying people, and you quit, your conscience can't take it. **5.**

So the ones who keep doing it for years, know it doesn't work due to the death stats, but the money is just too good.

And its very true that cultic type situations are very complex psychologically. **I bet probably 99% of what goes on we never hear about, as those who are victimized blame themselves, and never talk about it.** **6.**

At least the internet allows people to get the word out now.

**I can confirm that they practice shunning because I woke up to what was going on and left Islam altogether in 2005.** I never heard from any of my "beloveds" (that's what they call each other when you are in the organization, paying for Sidi's books, and giving them money) after converting to my current religion. **Even people that I considered among my best friends ignored my emails and voice mails.** **7.**

Let's analyze some of the comments that are made on this website by ex-members of that cult which as we shall see resemble exactly the behaviors used by Devra West in her own cult. I have numbered the comments I want to draw attention to.

1. The website identifies the 'Robert Jaffe School for Energy Mastery' as a Sufi / Islamic cult.
2. As with all cults, members are pressured to give donations to show their commitment to the path / teacher. In the case of Devra West, her 'students and employees were **constantly pressured** to "donate" to the Master Teacher.

3. Upon leaving the cult, ex-members are told / threatened with death. After witnessing two serious crimes in 2005 committed by Devra West, student [Lisa Swidler](#) died suddenly (believed murdered to keep her quiet).
4. The leaders / fake healers are making huge sums of money out of the misery of others who they prey upon. A quote that Devra West gave the [Whitefish Pilot](#) in 2007 about her 'healing' abilities shows that she was / is doing the same!
5. Only the most ruthless or sociopathic stay in the business. [Satya](#), Devra West's classmate at the Robert Jaffe School of Energy Mastery between 1990 & 1991 described Devra West as a deeply disturbed psychopathic person / personality.
6. The strict code of secrecy is designed to keep criminal activity by the leader(s) away from the public, the police and the authorities. In Devra West's case, she lies about the circumstances of 'victims' leaving the cult and has the [senior members](#) of her cult do the same.
7. The practice of shunning is to isolate those leaving from those who remain. Also to stop those remaining from contradicting the leaders lies, deceit and propaganda. In 2003, a wealthy elderly member of Devra West's cult, called Lucy, made the mistake of socializing with the whistleblower and his wife after he had left the cult. Lucy was forced to hand over to Devra West a valuable heirloom, a painting that had been in her family for generations, as a fine. Devra West promptly sold it and converted it into cash.

To be perfectly clear, after leaving the 'Robert Jaffe School for Energy Mastery' cult between 1990 and 1991, Devra Patton West put everything she had learned there into building her own cult over the following 26 years. The criminal cult / criminal business model is simple. Devra West moves into an area, embeds herself like a parasite into a community, sets up her shingle as an Ascended Master / 'Divine Being' with flashy websites advertising her as such. The fact that her websites are full of lies and propaganda including, fake testimonials, a totally false 'life journey' / bio which includes two fake doctorates is ignored, because under religious freedom laws these lies are allowed to stand!




All that remains is for the spiritually confused (those who believe they need a teacher to guide them) to turn up to be converted, after brainwashing and conditioning, into low paid or no paid slaves or in the case of the wealthy - cash cows! Here is an image of how Devra Patton West's guru / cult / extortion business model has worked over the past 25 years.



Put simply, 'new blood' is inducted into the cult and at some point those trapped inside the cult are converted into cash! This can happen over years of being forced to "donate" their personal funds until there is nothing left, or it can happen suddenly, as in the case of Dr. Pat Cole MD a wealthy member of Devra West's cult. Those without wealth are simply used as low paid or no paid slaves; envelope stuffers used to further the cult leader's own business interests. What follows are the two main methods Devra West uses to relieve the wealthy members of her cult of their life savings.

The Fraud Scam works like this. The spiritually confused attend meditation meetings, consultations or group intensives where the wealthy are identified by ex-husband and accomplice Jack West, which may subsequently result in a private audience. Or the spiritually confused (and hopefully wealthy) respond directly to the invitation [on her website](#) to have a consultation or a private session, or a private intensive.



After gaining the target's confidence with a blend of clairvoyance and ritual magic, Devra West then decides which way she is going to 'skin the cat' so to speak. There are only two approaches; the soft approach, as used on heiress Corinne Coffin AKA Tanmayo, or the hard approach, as used on Dr. Pat Cole MD.

**The soft approach.** This can take the form of Devra West telling the target that she and the target, (nearly always women) were sisters in another lifetime and that during that life time, the 'target' betrayed her, with the result that she is now being given the opportunity to make amends by giving a large financial donation to her. Devra West will say that their meeting was not by chance and that the Ascended Masters had brought them together to

give the target a chance to make amends and burn off some karma. Devra West will go on to say that if the target does not respond and take up the generous offer to pay her \$500,000 to set matters right, the Ascended Masters will give the target a sign by visiting upon her a series of debilitating migraine headaches. Those that do not cough up the funds within a short time period, are visited with a series of migraine headaches so severe, that they render the target unable to function. The target becomes a believer and pays up!

Or as with the 'Robert Jaffe School for Energy Mastery' cult, Devra West tells the 'targeted' individual that they have some dreadful illness like a brain tumor that she can cure for a large fee. If the target does not pay up within a few days, Devra West uses her occult abilities to target the individual with shamanic core impacting attacks which manifest in the victim as severe debilitating migraine headaches. The victim pays up and within days, miraculously the victim is 'healed' of their nonexistent brain tumor!

While working for Devra West as a consultant in 2002, when she was calling herself the Ascended Master Devra Ji, the whistle-blower was informed by two of Devra West's other employees, Diane Stoner (secretary) and Kathleen Francisco (housekeeper) that Devra West had extorted received a donation for \$500,000 in this way. **The hard approach.** Is to recruit a wealthy 'target' into one of Devra West's great 'save the world' fund raising causes; none of which are ever meant to come into reality, but are used as a 'fund raising' focus by West to get the money flowing. If the target does not come forward with the required amount of funding (for her good causes – nearly always herself) the target is isolated and then mentally and physically abused by the senior members of Devra West's cult, as described here by ex-student [Debra Coffey](#). All of this is choreographed by Devra West, and if the overt violence fails, then the target becomes the subject of a campaign of under the radar occult violence designed to intimidate them into emptying their bank accounts into Devra West's.

These are the two approaches that Devra West used when calling herself the Ascended Master [Devra Ji](#) in Victor MT (between 1995 and 2004) and when she was calling herself the Ascended Master [Surya Ma](#) (between 2005 and 2010). Given the way her website is set up and the way she, and the [senior members](#) of her cult ([Julio Williams](#) and **Jack West**) are still working the same well-oiled scam. Clearly, nothing has changed, apart from more expensive air brushed photos and on the website and even more outrageous lies from Devra West to suck in the sheeple.

### **One Man's Journey through the Meat Grinder that is Devra West's cult.**

To give you an idea how 'well oiled' this criminal conspiracy is and how no crime, including murder, is off limits, let's follow the path of one victim through the meat grinder that is Devra West's cult / organized criminal conspiracy. The whistleblower was recruited in early 2002 via a meditation group run by Devra West's then husband, Jack West, who still performs the same function today – see below here.



Occult Thief Devra Patton West sits on her throne and lords over the sheeple as they hang on her every word. Jack West, Devra West's ex-husband accomplice in organized crime since the 1970's, sits amongst the new intake just as he did in 2000 when the whistle-blower was recruited from a meditation group he chaired.

His role is to meet, greet and circulate amongst the potential recruits to the cult to see which is wealthy, which has influence and who would be useful as low paid or no-paid labor. This well-oiled criminal conspiracy has not changed in its approach in two decades or more and why should it? As Devra and Jack West's guru / cult / extortion business model has netted tens of millions of dollars a year for **world service** and yet no records exist of funds going anywhere except to fund her lavish lifestyle costs.

The whistleblower, a management consultant and Tanmayo (Corrine Coffin) a wealthy Brazilian American heiress, were both recruited by Devra West to join her in a project that she stated was intended to make 'banking' more altruistic. As stated above these 'good causes' were never intended to come to fruition, but just to give the wealthy members of her cult along with rank and file cult members some objective to fund raise around. In this case, the whistleblower's role was to set up a number of for-profit and nonprofit corporations to which Tanmayo was going to donate \$1,000,000 in seed capital.

The center piece of this group of companies was a for-profit corporation called Millennia Mind Inc., to which most of the seed capital was headed. The share capital at inception was 51% Devra West, 25% Tanmayo and 24% for the whistleblower. After working for 6 months on the project (with the promise of pay and shares later) and after completing all the tasks he had been set with, Devra West announced one day in late July of 2002, that she had spoken to God the previous night and that she had been told by God that 'share capital' was a thing of the past; therefore, he would not be receiving any shares or any pay for the work he had done.

**Her audacity was so breathtaking. It was obvious to the whistleblower that she had done this kind of thing many times before to other victims and had obviously gotten away with it – at that time, the whistleblower did not yet know why she had gotten away with it.**

In effect, and after working for 6 months for nothing, the whistleblower had been constructively dismissed without pay and shares. The whistleblower's mother in law was dying at this time, so he put this matter to the back of his mind – she passed later that year and in March of 2003 the whistleblower announced that he was going to sue Devra West for fraud; a lawsuit he won in 2008. What follows is a catalogue of some of the tactics used by Devra West and her cult against the whistleblower; tactics that included lies, deceit, dirty tricks, threats and intimidation from cult members, occult 'under the radar' violence directed

at him and his family by Devra West, attempted murder by Devra West and a criminal conspiracy to bankrupt him mounted by Devra West. Here in chronological order are the tactics used against the whistleblower.

(1). Devra West, then calling herself the Ascended Master Devra Ji, lied to the cult as to the reason why the whistleblower left suddenly. According to Devra West's then personal secretary, [Barbara Constantino](#), Devra West lied about the departure of every victim of fraud, theft, extortion or violence to deflect the blame away from herself on to her victims.

(2). Devra West immediately publicly denied to everyone that she has ever entered into any business agreements with the whistleblower while [writing to her lawyer](#) asking that the lawyer write to the whistleblower to resign as a director shareholder of those 'non-existent' business agreements. Here [a letter](#) from her then husband, Jack West, acknowledging to the Immigration and Naturalization Service (INS) that the whistleblower was employed setting up corporations and that he was being paid a salary. Here are two links to a [personal guarantee](#) and [correspondence on a Corporate ID package](#) that both Devra West and the whistleblower gave to a design agency in Colorado in the matter of the design work they were doing for [business cards](#), stationery and brochures. Why would the whistleblower be a party to a personal guarantee or have a business card if he was not a principle?

Below is a statement Devra West would later post on her website. Of course, Devra West is not a doctor of anything - unless you count the two doctorates that she asserts that the [Christ awarded her](#) in person!

**Millennia Mind Dispute with John Watson:**

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

**TRUTH: No business contract between Dr. West and John Watson has ever existed. The legal dispute was fabricated by Watson to leverage an extortion scam. Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.**

(3). In March of 2003, after declaring he was going to law, Devra West asked to meet the whistleblower privately at his home to discuss the 'dispute.' Fearing some kind of stunt, the whistleblower arranged to tape record the meeting. You can listen to the entire recording of the meeting by going [here](#). Long story short, the 44 minute meeting consisted of Devra West trying to browbeat the whistleblower into not suing her for fraud. During the meeting, Devra West stated that that she had defrauded the whistleblower but did not see herself writing him a cheque! She also stated that if he took her to court she would get so fu\*king down and dirty, huge expenses coming out of his pocket but not hers (because the cult would pay all her legal expenses); you can hear her say this in her own voice by going [here](#). She also stated that [her 'agreements' were worthless](#) and that she disposes of people [like Kleenex](#). Follow the links to hear her make these two statements in her own voice.

(4). In November 2003, as a result of a letter that the whistleblower had sent to the Secretary of State for MT detailing the massive fraud being perpetrated by Devra West and her husband, Jack West, their charity 'The Circle of Divine Unity' was struck off the register, leaving the Wests with no regular income and no ashram from which to continue their guru / cult / extortion business model. West did not miss a beat. She immediately stole the property belonging to the charity, worth then \$1,250,000, and put it in a trust fund for her and her eldest son, Robe Meador, and stole \$4,000,000 worth of artwork and valuables from the charity, which like the property were largely paid for by public donations. The artwork and valuables emerged ten years later from a lock up (after the statute of limitations on theft had expired) only to be auctioned off and offered for sale from West's current website. As stated, Devra West did not miss a beat and after all, why let a good crisis go to waste? So, knowing she would have to move anyway, the pathological liar wrote to her cult announcing that she was evolving / transforming from the 5<sup>th</sup> dimension to the 7<sup>th</sup> dimension. She also announced that she was changing her name from the Ascended Master Devra Ji to the Ascended Master Surya Ma and that she was moving from Victor MT to (Shamballa) Lakeside MT and that only 12 disciples who were prepared to give 66% of their net worth to her good causes would be allowed to accompany her to Shamballa!

Here are two excerpts from a missive she sent out to the members of her cult.

Dear Ones,

It is with much joy and gratitude that I write to you to offer news of a most blessed personal transition that I am under going. Having fulfilled the necessary factors of purity of motivation, discernment of circumstances, and discipline of focus, I am uplifting into the vibration of Shamballa to begin to take my place upon the Council of Twelve at Planetary levels. **1**

The process has been somewhat painful physically, but blissful at all other levels, as my nervous system is ongoing a revamping. I will require a far more rarified "vibrational container" to complete the transition. **2**

As a result of this transition, my world work in its greater expanse of influence will begin to spread its wings and although I feel like a fledgling in this new place, I also feel such gratitude of heart. I feel like I am coming home to what I have always known to be true. I am also entering True Time as a result. I am making the transition from Master Teacher to Global Guardian in the truest sense. **3**

My shift from fifth dimensional being, to seventh dimensional being is rapidly reshaping my "immediate personal world" if one might frame this shift in personal / impersonal terms. The shift is actually a shift into greater impersonality and yet also greater sense of Self within the Great Self. **4**

And this....

My directives for this time are absolutely clear, making it necessary for me to anchor a Shamballa Pillar in northern Montana at Flathead Lake. This will require that I move to a new location and this location has been revealed and prepared by the Masters. Therefore, I will be moving from Na Ka' Shela to the Flathead Lake as my sanctuary for world service, where I will be in seclusion much of the time, until such time that group formation is achieved at Na Ka' Shela and the proper and required "container" can be offered to me on your parts. 5

Presently, the balance of truth between myself as Master Teacher and the group has yet to be fulfilled, demonstrated and anchored. No less that 66% fulfillment of Truth in Balance between disciple and Master Teacher on the part of no less than twelve persons can serve as my container. There is no preconceived idea as to who these twelve persons will be. Purity of heart, mind and purpose in service to the Master Teacher's work and thus the work of the Ashram as assigned by Brotherhood of Light will be the determining factor. 6

As I transit to the vibration and function of Global Guardianship as an externalized Chohan of the Brotherhood of Light, the existing gap in balance on the part of the group that has been the case in the past is not acceptable, nor advised, nor allowed. The difficulty in vibrational differential is too great at this time, although it remains my deepest hope that this can soon be corrected. 7

Dr. Pat Cole MD, a wealthy heiress, was one of the members of the cult that was allowed to accompany Devra West to Shamballa and in so doing, had implicitly agreed to give up 66% of her net worth to cult leader / psychopath Devra Patton West. Remember that name - Dr. Pat Cole MD.

(5). One of the whistleblower's friends (still a member of the cult) did break the 'shunning' rule and inform the whistleblower that after the March 2003 meeting, Devra West went back to her compound, gathered all the employees (cult members) together and insisted that they manufacture fictitious, derogatory statements about the whistleblower that Devra West could use against him in a court of law or be fired. One employee / cult member [Anandra George](#) later wrote to the whistleblower's lawyer retracting the false statement she had been forced to write, and another employee, [Tanya Hurley](#), (Devra West's housekeeper) repudiated the false rumors that Devra West was spreading about the whistleblower's interaction with female members of the cult.

(6). In 2005, three of Devra West's then cult members **Julio Williams MD**, Jennifer Cornell MD and **Pat Cole MD** published a [defamatory statement](#) about the whistleblower on Devra West's website. None of them knew the whistleblower personally, so it is likely that Devra West wrote the statement herself or dictated it to them. Having members of her cult stand between her and her enemies is a tactic Devra West uses frequently, as we shall see going forward. It also established beyond any doubt that Devra West was running a cult and that members of that cult, like Julio Williams MD, would do her bidding no matter how immoral or illegal. The 'testimonial below being a good example!

(7). In 2005, Lisa Swidler, a friend of the whistleblower's and a senior member of West's cult, died suddenly and inexplicably after trying to leave the cult. At the time, the whistleblower and his wife assumed that she died of natural causes as a result of some

awful illness that they were unaware of. However, later that year, the whistleblower was contacted by ex-cult member Dave Kushner, who explained that he had been defrauded out of \$30,000 by Devra West who refused to pay a short term loan that Lisa had negotiated.

The whistleblower knew that Lisa was a straight arrow, so assumed rightly that Devra West, after getting what she wanted, reneged on the agreement that she had made to repay the loan. This turned out to be the case, even though Devra West had signed a written agreement. Dave Kushner also explained that his friend Marion Cantwell, another ex-member of Devra West's cult, had been kidnapped, held captive and beaten until she agreed to give up part of the proceeds of the sale of her home. She was eventually released and told that if she went to the police she would be murdered.

(8) In January 2007, the whistleblower received what can only be described as a 'threatening' email from senior cult member and financier of organized crime, Julio Williams MD. Below, is a short version of it; you can read the full email by going [here](#).

In March 2007, the whistleblower, who had a website up to counter the lies and propaganda being published by Devra West and her cult, started to receive a series of harrowing emails from [Rebecca West](#) (no relation to Devra West). The emails confirmed the whistleblower's suspicions, which were that Devra West was using the same cult tactics

against employees and students to her unaccredited school that she had used in 2002. Here is the opening paragraph from one of those emails entitled 'Help Me.'

**After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).**

The above reference to more than 30 employees coming and going reflects the 'revolving' door policy Devra West has to employees. If they submit to her will and become low paid or no paid members of her cult they can stay. If they refuse to submit to her will and join the cult they are fired before the 90 days is up after which Devra West has to pay employment insurance!

(10). In January 2002, the whistleblower was duped into working for 6 months, on the promise of pay and shares believing that he was dealing with a respectable person. Similarly, Geoffrey Reynolds CPA, another professional person unaware that they were joining a cult, was recruited by Devra West in September 2006 and moved from Cave Creek AZ to Lakeside MT, oblivious that his predecessor had resigned. His predecessor had resigned rather than be forced to 'manufacture' false invoices to make it look like the \$1.3 million Devra West had extorted from Dr. Cole MD had been received as receipts from 'normal' business activity, rather than from the receipts of organized crime. Unfortunately for Reynolds, he was duped into loaning the Ascended Master his life savings amounting to \$300,000 shortly after commencing his employment; no doubt at the time believing that he was helping Devra West with her 'world service' efforts! Here is what Rebecca West had to say about the plight of the newly employed 'finance controller' Geoffrey Reynolds CPA.

**"This attitude is pervasive and includes her current finance controller [Geoffrey Reynolds CPA], whom she has extorted from him over \$300,000 since Sept 06'. He is very afraid of losing his money, wife, and children yet does not understand why I cannot come back to work and just let it roll off my back. ***I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available. Again the crux is finding a law firm willing to take the case without a hourly payment of services.***

***With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her.***

***I am aware that the only person still financially supporting Devra (the finance controller [Geoffrey Reynolds CPA] is out of money), is Dr. Julio Williams and he gave her \$100,000 last week.***

***Tanmayo's (coca-cola heiress) son contacted the finance controller yesterday demanding the monies his mother contributed be returned. This phone call is the straw that broke the camel's back for the finance controller [Geoffrey Reynolds CPA] who has finally realized that he can no longer ignore the very bad situation he has gotten himself into by loaning Devra \$300,000.***

Shortly after commencing his 'employment' with Devra West and after loaning her \$300,000 and after moving his family from Arizona to Montana, Geoffrey Reynolds CPA must have realized that he had gotten himself into a very difficult situation – as Rebecca West makes clear in her emails - excerpts from which are quoted above. At that point, Reynolds had a huge moral / ethical decision to make which was whether to resign, go to the police, go to law to try to recover his life savings or become a pawn / stooge / member of Devra West's cult and do as she asked, in the hope of getting his money back.

The same person pulling Julio Williams's strings, the same person pulling Jack West's strings – cult leader Devra Patton West.**

On July 12 2007 and August 9 2007, the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers respectively, published stories about the crimes being committed in the Lakeside area of MT by Devra West and her accomplices. The center piece of both articles being the vicious assault on Dr. Pat Cole MD by Devra West. (12). The whistleblower had moved from Victor, MT to Halifax, Nova Scotia in July of 2005; believing that being on the other side of the continent, he would be out of the reach of Devra West and her cult – how wrong he was. In December 2006, both he and members of his immediate family, became the victims of a campaign of occult shamanic attacks at the hands of Devra West. In August 2007, **Devra West attempted to murder the whistleblower** using occult means, and she was nearly successful. At that point, the whistleblower realized that his friend, Lisa Swidler, had not died of natural causes in 2005 but was likely **murdered by Devra West** to keep her quiet.

(in what he thought was an 'off the record' comment) that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. Reynolds was clearly referring to the murder attempt and to the campaign of occult attacks directed at his wife and children that followed his statement. Here is a statement that asshole Geoffrey Reynolds CPA made to the Bigfork Eagle, speaking on behalf of his 'employer' Devra West on August 9 2007. 


**It is obvious that psychopath Devra Patton West has put to use the knowledge she gained while a member of the '[Robert Jaffe School for Energy Mastery](#)' cult between 1990 & 1991.**



Put simply at its core Devra Patton West's "business model" is a well-oiled criminal conspiracy which is hidden inside a cult which is in turn hidden inside a quasi-religious outer shell. The appearance of being a religious organization allows Devra West to tell the most outrageous lies about herself, allows her to morph theft, fraud and extortion into "donations" and violence into "therapy." For the most part of all of this crime is kept hidden inside the cult.

This vile despicable creature Devra Patton West, a deeply disturbed psychopathic person / personality, has now been operating in the Cave Creek / Carefree area of Arizona for 5 years. You can bet that some of those attending her **consultations, private sessions** and **private intensives** have, after paying hundreds of thousands of dollars, been miraculously cured of illnesses that were given to them by Devra West! You can bet that during 'private' sessions Devra West has convinced many female victims that they were sisters in a past life and that the victim betrayed her and therefore needs to make reparations in this lifetime in the form of huge cash "donations."

I suspect that dozens if not scores of victims of extortion have taken place in this way over the past 5 years or so but we'll not know about them because for the most part these victims will be sworn to secrecy, in fear of their lives if they go public or just embarrassed that they were conned by the only living Rishi on the planet (gag).

**This is the journey of just one victim through the meat grinder that is Devra West and her cult! There are scores more victims, perhaps hundreds. Victims of theft, fraud, extortion, violent assault attempted murder and at least one murder and perhaps many more.**

**I demand that the FBI open a murder investigation into the sudden death of Lisa Swidler and the two attempts on the life of the whistleblower! Or is murder no longer a crime?**

**Below are 30 more examples of 'world service' from this occult thief / suspected serial killer Devra Patton West. The following examples, in reverse chronological order, occurred during Devra Patton West's incarnation as the Ascended Master 'Surya Ma' in Lakeside Montana between 2005 and 2011.**

1. Arrest Warrant for [Felony Theft](#) December 16 2009.
2. Judgement against Devra West (and son Chris Haywood) [for fraud](#); both had ignored the court proceedings brought against them by 'Top to Bottom Construction.'
3. Arrest Warrant for [Criminal Check](#) Fraud April 16 2008.
4. Conviction for Assault April 2008; Newspaper article [announcing conviction](#), Devra West's [written admission](#) of April 17 2006 that she had assaulted Dr. Cole MD, West's denial and subsequent [clarification by newspaper](#) that West was guilty.
5. [Judgment](#) handed to the whistleblower in October 2008 by a Montana court finding that Devra Patton West had defrauded him; newspaper article in [Ravalli Republic](#) announcing judgment.
6. On 20 May 2008, Devra West became the subject of a [Sheriff's Sale](#) to force her to pay \$2,000,000 in court fines and interest to her creditors arising from her earlier ['world service'](#) efforts as the Ascended Master Devra Ji between 1995 and 2004.
7. In 2007, Devra West's criminal activities became the subject of two newspaper articles published in the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. While these two articles are informative, they do not truly show the scope of West's criminality, most of which is hidden inside the cult.

8. The fraudulent depiction of a multi-million dollar lakeside property on her website and in her brochures as belonging to her; this property described as 'Surya Ma's Abode' in reality, belonged to Robert & Tabby Ivy, who over a two year period repeatedly asked Devra West not to use images of their property. See July 12 2007 [Whitefish Pilot](#) news article for details.

9. Also on July 12 2007, Devra West appeared in court as a witness for her son in his attempt to get custody of his infant daughter from his estranged wife. During her appearance in court, Devra West described her businesses as [multi-billion dollar enterprises](#) even though at the time, she had a lien against her for [unpaid employment insurance](#) and was in the process of being evicted from two rental properties in quick succession.

10. While in court, she was asked by counsel about the many ex-employees that had posted statements on the whistle-blower's website, alleging that they were mentally and physically abused by her. The Master Liar's response was to say that many of those mentioned on the whistle-blower's site were [fictitious or fabricated](#). Below is a graphic which shows how her 'business model' works; the photograph contains most of the employees (and some students) that Devra West says do not exist!

11. Devra West, with the aid of senior cult member [Geoffrey Reynolds CPA](#), had fraudulently applied for \$30,000,000 in CPEA grant money; when the grants were denied Devra West, owing millions in court fines, decided to 'harvest' one of the wealthier members of her cult – Dr. Pat Cole MD.

12. Devra West is a vicious and violent criminal who uses her occult knowledge to terrorize both victims and witnesses into silence. Here is a short excerpt from a harrowing email [entitled 'Help Me'](#) that Rebecca West (no relation to Devra West) sent to the whistleblower in March of 2007 – Rebecca being a friend of Dr. Cole's and a witness to Devra West's brutality towards her.

***"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?"***

Clearly, the con artist Devra West could not allow news of her brutality towards members of the herd trapped inside her cult to escape into the public domain it might interfere with her multi-million dollar a year fraud scam ['world service'](#) efforts!

Also in 2007, the whistleblower was contacted via his website by Michelle Fetveit, a Lakeside MT neighbor of Devra West's after she got into a 'water dispute' with Devra West. As with Rebecca West (and countless other victims) Michelle reported being the subject of 'occult' attacks and was also woken up at 3.00 am each

morning. The whistleblower has never met either of these women and yet they both report being subject to the exact same phenomena – the common denominator being Devra West. Follow [this link](#) to hear what Michelle Fetveit had to say.

13. Around this time Devra West, already a Master in what she calls the malleable fluidity of reality (lies, deceit and propaganda) announced that she was single handedly [holding open the gates of time](#)! This in addition to an earlier statement to her students insisting that her two doctorates were [presented to her by the Christ](#) in person.

14. On or around the 14 April 2006, Devra Patton West viciously assaulted Dr. Pat Cole MD who was both a 'student' and business partner of Devra West's. The assault was part of a well-orchestrated campaign of violence aimed at extorting \$1.3 million from Dr. Cole, which Devra West succeeded in doing. This story, along with many other crimes being carried out by Devra West at the time, is covered by two news articles that were published by the [Whitefish Pilot](#) & [Bigfork Eagle](#) on July 12 2007 and August 9 2007 respectively; see point (7) above.

15. Following the assault, which shocked many of the witnesses present, Devra West issued a written statement to her entire mailing list seeking to justify the assault by saying that the victim was a Nazi in the WWII death camps in another lifetime and that though the assault was severe, it was at all times administered with grace. Here is a link to the missive she sent out after the assault it is entitled ['The Law of Severity on the Path to Purification'](#) evidence enough that Devra West is a dangerous psychopath. Devra West would later deny that she had assaulted Dr. Cole MD, fail to turn up for court hearings and was found guilty by the courts in April 2008.

**The following examples, in reverse chronological order, occurred during Devra Patton West's incarnation as the Ascended Master 'Devra Ji' in Victor Montana between 1995 and 2005.**

16. In 2005, after her Victor MT charity was struck off, desperate for funds and owing \$2,000,000 in court fines and interest to creditors Devra West, still posing as the Ascended Master Devra Ji, [wrote to her mailing list](#) in an attempt to bully the individual rank and file cult members into giving up to 66% of their net worth to her. Within that missive she made the following statement:-  
**"It will be your privilege to seed my financial transition."**

17. In 2005, some eighteen months after issuing legal proceedings against Devra West for fraud, the whistleblower became the subject of a campaign of defamation, character assassination and dirty tricks at the hands of Devra west and her cult. This took the form of a [defamatory statement](#) posted on Devra West's website by three of her cult members amongst them Dr. Julio Williams MD. He also received a [threatening email](#) from Julio Williams MD, stating that he was personally going to fund Surya Ma's legal expenses to the tune of \$2,000,000 and that the whistleblower should not "fu\*k with him or else."

The whistleblower was also advised by a friend still in the cult, that Devra West had ordered her employees to 'manufacture' false statements about the whistleblower or be fired for refusing! [This link](#) leads to an email from a member of the cult, who later retracted her false statement.

18. Ingrid Bayer, a teacher at Devra West's unaccredited school, wrote to the whistleblower stating that her 6 year old son had been abused by Devra West; here is a short excerpt from Ingrid's statement which can be read in full by following [this link](#).

***"I am a firsthand witness to the physical and emotional abuse from Devra as I experienced it myself, as well as witnessing the abuse of my 6 year old son by Devra."***

Perhaps Ingrid's 6 year old son represented a threat to the beast's 'world service' efforts?

19. Lisa Swidler, student and confidant to Devra West, died suddenly and mysteriously of 'natural causes' after witnessing two serious crimes that were committed by Devra West against two other students to West's unaccredited school. Lisa broke away from the cult and died shortly after, leaving behind two small children under age ten. The whistle-blower believes she was murdered by Devra West to keep her quiet.

20. Sometime in 2005, Devra Patton West without a business container to run her fraud scam from and heavily in debt, allegedly kidnapped student [Marion Cantwell](#), held her captive, beat her and only released her after Marion agreed to 'donate' tens of thousands of dollars from the sale of her home to Devra West. I suspect this money was not for 'world service.'

21. [Dave Kushner](#), a student of Devra West's, was defrauded out of \$30,000 by Devra West this money supposed to be a two week bridging loan. Dave Kushner never got a penny back and Devra West refused to ever speak to him about it. Rather than become a murder victim Dave Kushner decided not to go to the police or to court for restitution even though he had a signed agreement from Devra West in respect of the loan! As Devra West made clear to the whistle-blower in 2003 [her agreements are worth nothing!](#)

22. In 2004, student Mike Hendrickson was defrauded out of \$200,000, as after signing a note at the bank to guarantee the charity's overdraft of \$200,000, Devra West emptied the bank account and put the \$200,000 in a personal trust fund for herself and her eldest son, Rob Meador. Mike is mentioned in the [Whitefish Pilot](#) news article; he too chose to walk away rather than become a potential murder victim.

23. At around this time, the whistleblower received [an email from Judy Morris](#), an ex-student / cult member, that was part of Devra West's European group of students informing him that many of the European students had taken out loans

and mortgages to give money to Devra West. They were told, and I quote, "The more they gave the more God would love them."

24. Around this time, according to another student, Elaine, who wrote to the whistleblower in 2009 about a conversation in 2004, Devra West bragged about her ability to attract wealth – no mention of 'world service' here is an excerpt from Elaine's email.

***While Devra is obviously a pathological liar, she unwittingly reveals herself quite frequently because she can't keep her own mouth shut and so loves to brag. This was more than five years ago -- in the course of bragging about her ability to attract wealth, she explicitly stated she doesn't have any bank accounts because she didn't need them in order to be wealthy. She then pointed out that at that very moment she was wearing \$250,000 worth of emeralds. And she implied she had a lot more than what she was wearing. She's so sure she's smarter than everyone else, I doubt the jewels are very far away and I strongly suspect she has at least a million in jewellery.***

Maybe the jewelry, precious metals and the millions in artwork and valuables stolen from the Montana charity will be combined to fund her 'world service' efforts?

25. In 2004, having had her charity, The Circle of Divine Unity, struck off for fraud in November 2003, Devra West perpetrated a massive fraud on that charity which resulted in her stealing a property from the charity paid for by public donation worth \$1,250,000 (2003 valuation) which she put into a personal trust fund for her and her son Rob Meador. Former board member of that charity [AJ White](#) describes the theft of \$80,000 from that charity by Devra West and the conversation she had with Devra West about the charity's finances during which Devra West stated that all the money belonged to her!

26. At the same time, Devra West stole \$4,000,000 (2002 valuation) of artwork and valuables and hid them in a lock-up until the statute of limitations on theft passed, at which time in 2014, these items appeared at auction in Cave Creek AZ and as for sale from her website. In a statement given under oath (she is a compulsive liar) while being [deposed in October 2009](#) Devra West stated that the artwork and valuables on a list shown to her by the lawyer did not exist, were not hers and if they did exist were stolen.

These are the very items that were being auctioned by her in 2014 or as for sale from her website; many of these stolen items they are still being advertised for sale as the 'Rishi Collection' from her website under the ['art gallery'](#) tab. Who says organized crime does not pay?

27. On November 23, 2003, Devra West's charity 'The Circle of Divine Unity' was struck off the Montana charity register after rampant fraud was discovered by Devra and Jack West who were found to be using public money given as donations

for certain projects being used to fund their lifestyle costs including the purchase of jewelry by Devra West.

28. In March of 2003, Devra West asked for and was given an opportunity to meet with the whistleblower in private at his property in Victor MT. Notionally the meeting was to see if they could settle their differences without going to law; fearing some kind of trick or stunt by Devra West the whistleblower made an audio recording of their encounter which turned out to be nothing more than Devra West threatening him if he went to law. Here are some of the highlights; follow the links to learn exactly what kind of **'world server'** Devra West really is!

**[You are f\\*cking over a spiritual teacher.](#)**

**[I'll get so f\\*cking down and dirty, huge expenses coming out of your pocket not mine!](#)**

**[My agreements mean nothing.](#)**

**[I dispose of people like Kleenex.](#)**

29. In 2002, while attending a function held in Montreal by Devra West, student **[Beatrice McGuire](#)** was viciously assaulted by Devra West to the extent that she needed plastic surgery to repair a torn ear. The reason for the attack was that Beatrice challenged some of the obvious lies being spouted by Devra West. Although the attack took place in front of scores of witnesses, Devra West later stated that her recollection of the incident was different to that of the victim's. None the less, Devra West had her charity pay the medical costs of repairing Beatrice's ear.

30. In 2000, employee **[Susannah Felder](#)** was viciously attacked by Devra West with the result that Susannah was partially scalped by Devra West. Apparently Susannah had challenged Devra West about an \$80,000 donation that Devra West had stolen from the charity to pay for her son's legal fees. Ex-board member, AJ White's statement deals with this, the theft of the \$80,000 and the assertion that all of the money raised publicly was for Devra West's personal use and not for the stated intentions given when the funds were raised.
