

Subject: Devra Patton West AKA Rishi Devra - Absolute Evil Masquerading as Good

Dear FBI, this bulletin gives two examples of Devra West's use of violent intimidation against two of her daughter's in law who were both, at separate times, seeking custody of their infant female children. It also shows how Devra West uses members of her cult to give false witness statements, in an attempt to subvert the legal process for the purposes of obtaining the children for her porn loving, wife beating drug abusing son who has an FBI record.

**Occult Thief / Suspected Serial Killer Devra Patton West – Compelling Evidence of Racketeering, Attempted Murder and Use of Occult Violence Against Witnesses Including Two Ex-Family Members!**



In case you are new to these bulletins, small time con artist, pot grower and ex-bankrupt Devra Patton West declared herself to be an Ascended Master after attending the [Robert Jaffe School of Energy Mastery](#) (itself a cult) between 1990 & 1991. Fellow student [‘Satya’](#) described Devra West as a deeply disturbed psychopathic person / personality who conned her out of \$6,000. [Jeremy Samuelson](#) who knew Devra West before she elevated herself to the status of a minor deity, describes how she and then husband Jack West conned him out of \$10,000.

**FBI / IRS - EVIDENCE OF MURDER, ATTEMPTED MURDER, RACKETEERING AND THE INTIMIDATION OF VICTIMS & WITNESSES BY DEVRA PATTON WEST.**

Suffice to say that once Devra West acquired the occult (meaning hidden) knowledge she sought, she was able to elevate her criminal activities to a whole new level that would be the envy of most criminals for three reasons.

1. The occult (Shamanism in West's case) is not regarded as a weapon by legal statute which means that over the past 27 years, Devra West has used this weapon relentlessly against those she sought to defraud or extort money from. Against victims and witnesses she sought to intimidate into silence and in extreme cases, those she sought to murder, like for instance, Lisa Swidler - a student who witnessed two serious crimes being committed by Devra West, left the cult and died shortly afterwards of 'internal bleeding.' Naturally the coroner, lacking the link to Devra West and the motive for her sudden and mysterious death, ruled Lisa's death as by 'natural causes.'



The whistleblower's death would also have been ruled 'death by natural causes' had Devra West's attempt to murder him been successful in 2007. That she intended to murder the whistleblower is not in doubt as fellow cult member [Geoffrey Reynolds CPA](#), so confident she would succeed in the murder, informed the press of his impending death while being interviewed by a newspaper just days before Devra West tried to kill him!

Those that doubt the existence of occult knowledge capable of causing someone's death remotely, need to do their own research. Suffice to say, that an alarming number of people connected to Devra West (and at odds with her) attest to being the victim of occult attacks. Below is a short excerpt from a harrowing email sent to the whistleblower entitled '[Help Me](#)' by Devra West's ex-office manager, Rebecca West, (no relation to Devra West) after becoming the victim of a campaign of psychic attack by Devra West because she, Rebecca, was a hostile witness to Devra West's [vicious assault](#) on Dr. Pat Cole MD. Devra West was eventually convicted of the assault in April 2008.

*"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. **I need support in how to deal with her shamanic witchcraft. Can you tell me more?"***

Rebecca was not the only 'hostile' witness to be on the receiving end of these attacks by Devra West as during this time, in March 2007, no less than 7 victims went to the Flathead police claiming they were being targeted in this way by Devra West as part of a campaign by her to intimidate witnesses into withdrawing their statements. The police were sympathetic but made it clear that as the 'weapon' being used was not recognized as a weapon under legal statute there was nothing they could do.

**Devra West knows this and relies upon the fact that she is free to use what amounts to a license to kill with impunity. This 'ability' to intimidate, injure, maim and murder is the basis upon which she claims to be a God!**

As you will read below, this 'weapon' is also used against those females who also become family members by marriage to West's son, Chris Haywood.

2. **'Religious Freedom Laws'** allow Devra West to get away with the most blatant and obvious lies which include claiming that she is holding open the gates of time and that the Christ gave her two doctorates in person! Her entire web site, which includes her totally fake 'life journey,' is a total fiction and yet based on these totally false representations Devra West is asking the public

to donate single contributions of up to \$500,000! Apparently, there is no such thing as ‘**mail and wire fraud**’ if the criminal / cult / racketeering business model presents itself to the public as quasi-religious organization! Long story short, Devra West can and does promote herself as the ‘Planetary Regent’ even though all the evidence shows she is an occult thief and quite possible a serial killer.

3. Along with her occult knowledge comes the ability to manipulate the weak minded and those lacking integrity and a moral compass; chief amongst these are the three senior members of her cult / criminal racketeering gang.

These individuals are ‘wheeled’ out to deny her criminal activities and to provide her with false witness statements when required during her many appearances in court. As we shall see below Geoffrey Reynolds CPA, recruited by Devra West in September 2006, was used in this way on multiple occasions after being duped by her into loaning her his life savings of \$300,000 after which Reynolds became a willing accomplice in money laundering, complicity to commit murder and criminal conspiracy.

**So in summary, Devra West, a deeply disturbed psychopathic person / personality has a license to kill with impunity which is she uses regularly, is a prolific liar (but is protected under religious freedom laws) and is surrounded by weak minded men who are in effect ‘liars for hire’ and willing accomplices in a murderous criminal racketeering business model.**

**This multi-million dollar a year ‘business model’ has operated ‘successfully’ in three western states over the past 27 years, with most of the victims of serious crime being members of her own cult. Devra Patton West's 'well oiled' guru / cult / extortion business has been 'perfected' over a quarter of a century since she declared herself, in 1991, to be an Ascended Master after completing a two year 'energy mastery' course at the 'Robert Jaffe School for Energy Mastery.' The occult (secret) knowledge that this, deeply disturbed psychopathic person / personality acquired is used by her to commit crimes, intimidate victims into remaining silent and also to control the weak minded (i.e. Geoffrey Reynolds CPA, Dr. Julio Williams MD and her ex-husband Jack West).

Geoffrey Reynolds CPA, Julio Williams MD and Jack West are fully 'paid up' accomplices in her criminal conspiracy; a criminal business model that has, after scandals and adverse publicity, seen her change her name and physical location (NM, MT and now AZ) three times in the last two decades!

Finally let us hear from the Planetary Regent herself who, upon being told by the whistleblower in March 2003 that he was going to sue her for fraud, made the following statements in a meeting unaware that the conversation was being recorded.

1. [If you sue me I'll get so f\\*\\*king down and dirty, huge expenses coming out of your pocket and not mine \(because cult members would pay for her legal expenses\).](#)
2. [Yes I dispose of people like Kleenex.](#)
3. [My agreements are not worth anything.](#)
4. [The truth does not actually matter \(if you can convince the public and a court of law that your lies are truth!\).](#)

In the whistleblower's case, getting so down and f\*\*king dirty meant forcing cult members / employees to write totally false statements about the whistleblower that she intended to use in court against him; one such statement written by an employee was subsequently retracted [in an email sent](#) to the whistleblower's lawyer. It meant a campaign of 'under the radar' occult attacks directed at the whistleblower that started in December 2006 and which continues to this day. An attempt to murder the whistleblower, telegraphed to the press by scum bag Reynolds in August 2007, and when that failed [Geoffrey Reynolds CPA](#) agreed to front a criminal conspiracy which involved him [making totally false statements](#) to a Montana court that, because the whistleblower could not afford to defend them, led to a \$10,000,000 default judgement for basically telling the truth!

Long story short, Devra West, true to her word, got f\*\*king down and dirty and in the end 'outspent' the whistleblower and bought the result she wanted. All aided and abetted by Geoffrey Reynolds CPA, a bottom feeding low life who had never met the whistleblower and could not possibly have defamed him because Geoffrey Reynolds lived and worked in Cave Creek AZ until he was recruited by Devra West in Lakeside MT, September 2006. Everything he knew about the whistleblower was given to him by Devra West post-September 2006.

In other words, Geoffrey Reynolds agreed to be a **'false witness'** and a **'liar for hire'** for Devra West, either because he was blackmailed into it on promise of the return of his life savings, or just because [Geoffrey Reynolds](#) CPA is a low life scum bag. But this was not the first time that Geoffrey Reynolds was 'wheeled' out by Devra West as a **'false witness'** a **'liar for hire.'**

**CHRIS HAYWOOD – DEVRA WEST'S SON.** Let us now review two court cases that involved Devra West's porn loving / wife beating son Chris Haywood who in both cases sought custody of two infant female children from his two ex-wives. Two court cases where Devra West tried (and succeeded in one case) in perverting the course of justice in favor of her son. In both cases Devra West used her occult knowledge to target her son's estranged wives with 'under the radar' violence and recruited false witnesses, 'liars for hire,' from her cult with, in both cases, the clear intention of undermining both custody hearings in favor of her son.

A son who had an FBI criminal record for forgery, dangerous substance abuse and traffic violations! A son that had joined with Devra West in an attempt to defraud a contractor that they had hired to do work on a property and then refused to repay. A contractor that was doubtless targeted with 'under the radar' violence like all the other victims that refuse to go away empty handed. Check out [the lawsuit that Mathew West](#) (no relation who was doing business as 'Top to Bottom Construction') won against Devra and Chris Haywood.

**In the case of Chris Haywood, clearly the apple does not fall far from the tree!**

Let us now look at two custody cases, in reverse order as they occurred, both involving Devra West's son Chris Haywood. The second of those two custody battles was between Chris Haywood and his estranged wife, Jamie Haywood – the hearing occurred on July 12 2007 the very same day that a newspaper article was published in the [Whitefish Pilot](#) detailing some of Devra West's criminal / racketeering activities in the Flathead Lake area of Montana.

In what is now a familiar pattern, two pieces of evidence give credence to the fact that Devra West was working behind the scenes using her occult knowledge to intimidate her son's estranged wife, Jamie Haywood, into giving up custody of her infant daughter. The second piece of evidence designed to manipulate the trial was the use of at least one false witnesses i.e. 'liar for hire' [Geoffrey Reynolds CPA.](#)

1. Below is an excerpt from an [email Jamie Haywood](#) sent the whistleblower the day before the hearing.

*I finally found this website and have been searching for you and Pat Cole due to the fact that my daughter and I have been subjected to this nasty woman. I thought that I was going crazy and thought there was something wrong with my daughter. Until my mother took me to see a true 'guide' and this wonderful*

woman told me that I had a spell put on me. She then started to test where it was, lo and behold in the left front side of my brain. Yea something to make me go crazy and whatever else! And that's not all; she also put one in my 11 month old daughter's internal organs. So this 'guide' took some time and finally removed these wicked spells off of me and my daughter then she told me that I would be protected.

This woman (Devra West) is now involved in the divorce case and in some way or another has been able to take my daughter from my possession. Chris has our daughter and is living in our so called home (Pat Cole's house) which they will be evicted from shortly. Pat's house was foreclosed by Wells Fargo Bank and they have to be out in 15 days. Devra West is also living with Chris at Pat's house because Ms West was evicted from her 2.6 million dollar home on June 29, 2007.

Between the 2 of them, they have tried to break me down and all the way down. From verbal abuse to physical abuse. I have been with this wicked family for 6 years now and am so happy to get out alive and with my mind intact.

Jamie Haywood clearly explains, in her own way, that both she and her daughter are the subject of a campaign of occult attacks from Devra West designed to intimidate her into giving up her daughter to her husband Chris Haywood a violent, abusive, porn loving member of the West crime family. It is clear from Jamie's statement that the purpose of these attacks was to either terrorize Jamie into giving up her daughter or cause her to react in a way that made the authorities believe she was an unfit mother. This modus operandi was exactly as described by Geoffrey Reynolds CPA to the reporter of the Bigfork Eagle on August 9 2007 less than one month of this court hearing. Reynolds's exact words, in what he thought was an 'off the record' conversation, was, and I quote, "The whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family."

2. As the list of witnesses clearly shows, 'liar for hire' Geoffrey Reynolds CPA, totally under Devra West's control after he loaned her \$300,000, was 'wheeled' out as a witness for Chris Haywood. In Reynolds's statement to the court he admits that he has only known Devra West since September 2006, some 9 months, but agrees to be a character witness for her son!

On this occasion, and in spite of all Devra West's efforts to subvert the court proceedings Jamie Haywood regained custody of her daughter and escaped the West crime family. However this exact strategy was used, a few short years earlier, against Chris Haywood's first wife Kendall and in that case it

worked. To be clear, by using a combination of ‘under the radar’ occult violence against Kendall and at least one false witness from the cult, a doctor, Devra West was able to obtain custody of her granddaughter from her daughter in law Kendall with the result that Kendall’s daughter ended up growing up with her porn loving / wife beating ex-husband. However, before we go there and look at it in detail let us look at the transcript from ‘Chris Haywood Versus Jamie Haywood’ 12 July 2007 hearing to see exactly what life was like for the two women as members of the West crime family by marriage to Devra West’s son!

First of all, let us establish once and for all that Devra West is a **pathological liar**, as most psychopaths are, by comparing the answers she gave under oath in court with the FACTS.



**DEVRA WEST COMPULSIVE LIAR.** [In Part 1 of the Transcript - On page 6, line 5](#) Devra West is asked about her businesses and goes into a long reply about four corporations she says she owns. In reality, as the [Bigfork Eagle](#) newspaper article published less than one month later makes clear only one company is in ‘good standing.’ Here is a quote from that news article.

*“Out of six businesses mentioned in West's literature, **only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millenium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute.**”*

[On page 10 of the transcript, line 15](#) Devra West is asked if it is fair to characterize her businesses as multi-billion dollar concerns to which she replies, and I quote, “Correct.” And yet as the Bigfork eagle newspaper articles states:-

*‘Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, **West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.**’*

Is it likely that a billionaire would be evicted from a rental home, bounce a deposit cheque on a home purchase or have trouble paying a bill amounting \$2,287? No of course not Devra West is a prolific liar.

[On page 23 of the transcript, line 24](#) counsel asked Devra West about the website that the whistleblower had up at the time and which contained a huge library of evidence that clearly indicated that she was running a criminal / racketeering business model. [On page 24 line 7 to 21](#) Devra West proceeds to lie about her ex-employees many of who allege they were mentally and physically abused by her – she maintains that many of them are fictional and fabricated people that do not exist! Follow [this link](#) to view a list of the employees that Devra West says do not exist, and [this link](#) to read some of their written statements, and [this link](#) to listen to some of their audio statements. Devra West, after falsely stating that the whistleblower worked for a tabloid newspaper in London, goes on at the bottom of the page to say that the whistleblower is totally motivated by financial gain when in reality he had been defrauded by Devra West and his only motivation was justice. He won his lawsuit against Devra West for fraud in 2008 – here is a link to the newspaper article announcing his win in court.

[On page 25 of the transcript, line 1 through to page 28, line 25](#) Devra West distances herself from the vehicle / container she created for her criminal / racketeering business by asserting that members of her cult set it up and that she only acted as a board member for a period of time and yet if one looks at the lawsuits during the time period they were all without exception naming Devra West as the defendant!

[On page 29 of the transcript, line 1](#) counsel asks Devra West if she is verbally and physically abusive towards her employees to which she replies emphatically NO! And yet the evidence clearly shows otherwise; below here two examples of violent assaults (just the tip of the iceberg).



#### **Susannah Felder – Partially Scalped.**

In late July 2001, while I was on a business trip to Denver, Susanna Felder, a committed assistant for over 9 years and editor of Devra's writing, called me. She called me in severe distress as she had gotten into a heated discussion with Devra on whether or not I should be put on the BOD – there was no Foundation BOD at that time. Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head.

AJ White Former - Board Member of Devra West's 'charity' The Circle of Divine Unity.

A witness to the above assault was ex-board member AJ White; you can read her statement about the assault and Devra West's theft of \$80,000 from the charity to pay her son's legal fees by going [here](#).



#### **Beatrice McGuire – Part of her Ear Ripped Off.**

I was present in Montreal in which Ms. West tore a woman's ear. The woman was kneeling in front of Ms. West and had quietly challenged her authority. Ms. West reacted physically. Evidently the woman's ear had been grabbed too hard and then torn. She underwent reconstructive surgery for the injury.

Debra Coffey – Student and Teaching Assistant.

A witness to the above assault was ex-student Debra Coffey who not only saw the assault but admitted that she was part of a group of students who would work with Devra West to target victims within the cult with mental and physical abuse as part of their 'conditioning.'

[On page 29 of the transcript, line 15](#) Devra West is asked if she assaulted Dr. Cole MD to which she replies “Absolutely not, no way no how, absolutely not!” And yet there were several witnesses who saw Devra West viciously assault Dr. Cole MD as described in the [Whitefish Pilot](#) newspaper article of July 12 2007 the very day she stood in court denying it!

“She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes, she threatened to kill me with a gun to my head, ‘blowing my brains out.’” Photos taken after the alleged beating were submitted to the sheriff’s office.

But the best evidence that Devra West, a deeply disturbed psychopath, did assault Dr. Cole comes from evidence she herself provided when on April 16 2006 she wrote to the entire mailing list of her cult in an attempt to justify the assault. In a missive entitled, ‘[The Law of Severity on the Path to Purification](#),’ Devra West, asserting that this message was downloaded from the long dead Ascended Master El Morya, admits assaulting Dr. Cole MD, admits the assault was severe and in true psychopath style, says that the beating was administered by her with grace! Devra West goes on to say that because the victim was a Nazi in the WWII death camps (in another lifetime) that the beating was justified and long overdue. No mention of the \$1.3 million dollars extorted from Dr. Cole MD. Below is a short compilation of some of the comments made by Devra West in her missive to her cult – you can read the full version by following the link above.

## *The Law of Severity on the Path of Purification*

Response to the Call of **Master Surya Devi for Review**

April 17, 2006 From Master El Morya of the Shamballa Councils

What must be taken into account in all matters of review on the part of the Shamballa Councils is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

**DAUGHTER IN LAW JAMIE HAYWOOD** - Now we know what a pathological liar Devra West is let us now have a closer look at her home life and just how closely her son's criminally insane behavior matches her own. Let us now review some of the evidence Jamie Haywood gave under oath about her life with the West crime family.

[On Part 2 of the Transcript - Page 86, lines 9 to 25](#) we hear from Jamie that she was underage when Chris Haywood got her pregnant and that he forced her to have an abortion because at the time he was going in the middle of a custody case with his first wife Kendall and that he felt it might go against him if the court knew he had got an underage girl pregnant!

[On page 87 of the transcript, lines 1 to 21](#) Jamie attests to the facts that Chris Haywood drank copious amounts of alcohol and did drugs.

### *The Rare Gift of the Enlightened Radiance*

[On page 88 of the transcript, line 1](#) Jamie attests to the fact that Chris Haywood broke her nose.

[On page 90 of the transcript, lines 2 to 14](#) Jamie attests to the fact that she has seen Devra West physically and verbally abuse employees and also states that she was present when Devra West assaulted Dr. Cole MD.

[On page 90 of the transcript, lines 15 to Page 91 line 9](#) Jamie attests to being present during a fight between Devra West and her son Chris Haywood during which Chris Haywood held his mother's throat while forcing her against a wall while she licked his face from top to bottom!

[On page 92 of the transcript, lines 3 to Page 93 line 13](#) Jamie describes how at eight and a half months pregnant she was forced to pick Chris Haywood up from a bar ten miles away and that on one occasion he was so drunk and belligerent that she stopped the car and got out and he drove off leaving her there. She goes on to explain how the cops picked her up and took her home.

### *Divine Grace Healing For Body, Mind and Soul*

[On page 94 of the transcript, lines 1 to 25](#) Jamie describes how Chris Haywood took marijuana, cocaine and alcohol and how in a separate violent incident she and Chris Haywood ended up in a violent confrontation while travelling in the car with their two small children (one from Chris Haywood's previous marriage to Kendall). Long story short Jamie ended up with a black eye which apparently was still on view when she attended court.

[On Page 119 of the transcript, line 17 to Page 120 line 5](#) Jamie talks about the email she wrote to the whistleblower and confirms that she and her infant baby were the subject of a campaign of occult attacks (by Devra West). 

In the past Devra West's criminal / racketeering business model has always operated on a number of levels.




1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.



19. [Mike Hendrickson](#) – Student defrauded out of \$200,000 by Devra West when the overdraft he guaranteed at the charity's bank was emptied into a personal trust fund for Devra West and her eldest son Rob Meador.

6. Defendant in [fraud case](#) brought by 'Top to Bottom' Construction.
7. Vicious Assaults on female members of her cult i.e. Susannah [Felder & Beatrice McGuire](#), [Jamie Haywood](#) and [Dr. Pat Cole MD](#).
8. The Students who took out loans for Devra West after being told, "[They would be closer to God.](#)"
9. West's son's [criminal record](#). Like mother like son?
10. [Arrest Warrant](#) for felony theft.

It is clear that Devra West's criminal business model is entirely predicated on her ability to use 'under the radar' violence against the victims she targets.
