This is how this lunatic describes her criminal racketeering business model. Unfortunately for her, there is more than sufficient documentary evidence about her ‘metamorphosis’ over the past 25 years to show that what is being described by her on her websites is all lies, deceit and propaganda. Her ‘life journey’ is totally false and is part of a massive deception designed to suck in ‘spiritual’ seekers to become the next raft of victims for her well-oiled criminal / racketeering business model.

Receive the steady influx of divine light as the Master Teacher Surya Ma holds open the Gateways of Universal Time at all new levels of potency for an ongoing increase of spiritual attunement, personal clarity and higher guidance, as new light is shed on specific world events and the spiritual attunements that will anchor your higher life purpose in the greatest degree of empowerment.

Not so far-fetched for the **'Regent of the Spiritual Hierarchy for the Western Hemisphere'** is the assertion that her two fake doctorates were awarded to her by the Christ in person! And here from the horse's mouth, is a statement Devra Patton West made to the [Whitefish Pilot](#) newspaper on July 12 2007, after news broke of her vicious assault on a local female doctor.


West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. (1) She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said. (2)

According to her biography, West went back to school at age 38 after raising her children. She graduated from the College of the Redwoods in 1994 with degrees in social science and humanities. (3)

Further proof of Devra West's mental illness and, like most psychopaths, that she is a pathological liar came on July 12 2007. 
Question. Question. Is it fair to describe your businesses as being billion dollar concerns? **Answer.** Yes. Of course Devra Patton West is quite mad but does her mental illness, when combined with her obvious criminal behavior, indicate that she is criminally insane?

Her [life story](#) is a total pack of lies which fails to mention:-

1. Her bankruptcy.
2. Her [conviction for assault](#).
3. Her two arrest warrants (one for [felony theft](#) and one for [criminal check fraud](#)).
4. Nor does it mention the fact that she was forced to become the subject of a [Sheriff's Sale](#) at which all her possessions were sold to force her to pay her creditors \$2,000,000 in court fines and interest.
5. Nor does her life story mention the fact that she was a frequent visitor to the courts as the defendant in [fraud related lawsuits](#).
6. Nor does it mention a string of vicious violent assaults against other women.

THIEF, FRAUDSTER, EXTORTIONIST, PATHOLOGICAL LIAR AND VIOLENT PSYCHOPATH.

However under religious freedom laws, though mad as a March Hare, Devra Patton West can tell as many lies about herself and her past as she wishes, as she continues to net millions of dollars a year from her well-oiled criminal / racketeering business model that she has now operated 'successfully' in three western states i.e. NM, MT and currently AZ.


Her mental illness stems from two psychosis - the first, a God Complex and the other, Narcissism, each defined as:-

[God complex](#)

A psychosis based in uncontrolled [narcissism](#), inflated arrogance and a perceived [need](#) to subjugate and/or ridicule other individuals deemed to be [inferior](#) or unworthy.

[Narcissism](#)

A Personality Disorder where you have an abnormal desire for one's [self](#), where you [lack](#) empathy, and unconscious inadequacy of self-esteem, due to regression of child development. Also a delusion that you are more important than [everyone](#) else.

This feeling that she is superior and more important than others, mixed with an obvious lack of empathy leads to her desire to control and manipulate others. In Devra West's case, this is taken to the extreme as in the past 27 years she has formed a cult around herself with those trapped inside treated no better than medieval serfs and who were the subject to mental and physical abuse. This psychopathy no doubt stems from her own repressed childhood, but what about her criminality and total disregard for local, state and federal laws? Let us now marry her obvious insanity to long held criminal tendencies.

EVIDENCE OF CRIMINAL INSANITY. There is proof that Devra West was a small time crook / fraudster back in the 1970's & 1980's - here is what Jeremy Samuelson had to say about Devra West and his then friend Jack West when he wrote to the whistleblower in 2007.

She subsequently married my land partner Jack West, a timid man with little experience with women. Suffice it to say she overwhelmed him and was soon "running him."

She had a jewelry making business with him (they were also marijuana growers) I unfortunately loaned them \$10,000 and was of course never repaid; I had trusted Jack who was a moral man until she twisted his mind. There are many others who remember Deborah West as a powerful personality, willing to do whatever to achieve her ends.

She never had any spiritual powers then or even claimed to and absolutely no one thought her a healer. It just goes to show that there is always someone willing to believe.

If Devra West has become as dangerous as you say- I want to congratulate you on your efforts. I saw what Devra was doing was back in 1994/5. I had met Devra at the Robert Jaffe School of Energy Mastery in 1990/91. We were classmates, friends (?) for several years through that work.

I left the small group in Santé Fe that was rallying around her and her 'transmissions' in 1995. I felt/saw that they were ego driven and distorted. Two of her followers (and then friends of mine) came to visit me in my home in Santa Fe and said that if I did not accept her as an ascended master that I was blocking the energies. The visit validated my concerns about her transmissions and I saw even more clearly how delusional all of this was and that many of my friends/colleagues were under her

"spell".

I lost many friends/colleagues who remained under her spell for many years-many of whom were bright sensible evolved people who had no idea that they were dealing with a **deeply troubled psychopathic person/personality.** (Devra had earlier convinced me to give \$6,000- to a scheme she either > invented or was involved with.) In retrospect- Devra is/was a brilliant, powerful, **manipulative, delusional psycho/socio path** and it saddens me to see that her illness and her destructiveness and manipulation of others has escalated over the years. So from two witnesses who never met, we have the same story. A brilliant powerful, charismatic and manipulative, delusional psycho / socio path. Who, both in the case of Jeremy Samuelson and Satya, was able to manipulate them both into giving her thousands of dollars which she had no intention of ever repaying. This criminal behavior was a precursor to many more similar episodes, but before we get to that, let me explain how this mentally ill / criminally insane person went from ripping off victims one at a time to becoming the leader of a multi-million dollar a year criminal / racketeering business model.

I do not have the space, time or inclination to try to persuade readers that the occult (hidden secret knowledge) exists and is real – if you are a non-believer then do your own research or remain ignorant, I am not on a crusade. The occult knowledge that Devra West gained while attending [‘The Robert Jaffe School of Energy Mastery,’](#) turned this small time crook into the leader of an organized criminal / racketeering gang with the ability to use the occult to:-

1. Commit serious financial crimes.
2. The ability to intimidate and silence victims and witnesses who might be tempted to go to the police, to the law courts or to go public about her criminal activities.
3. Where necessary, murder those who oppose her with impunity.

- (1.) That Devra Patton West has committed a string of serious financial crimes is not in doubt, as there is more than sufficient evidence in the form newspaper articles and court documents that attest to this.

That Devra Patton West's criminal / racketeering business model is predicated on her occult abilities which she uses to terrorize and intimidate victims and witnesses alike is also evident from the statements of some of the many victims. Let us review what a couple of those witnesses had to say:-

Firstly Rebecca West, no relation to Devra West, but an employee of hers at the time Devra West was in the process of using both overt and covert (occult under the radar) violence to extort \$1,3 million from Dr. Pat Cole MD – a friend of Rebecca's. Here is a short excerpt of a harrowing email entitled '[Help Me](#)' that Rebecca wrote to the whistleblower in March 2007. I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?

Secondly, this excerpt [from an email](#) from ex-daughter in law of Devra West's, Jamie Haywood.

Hello. My name is Jamie Haywood, Chris Haywood's ex-wife. And Devra West's ex daughter in law. Well actually I am in the middle of the divorce.

I finally found this website and have been searching for you and Pat Cole due to the fact that my daughter and I have been subjected to this nasty woman. I thought that I was going crazy and thought there was something wrong with my daughter. Until my mother took me to a true guider and this wonderful woman told me that I had a spell put upon me. She then started to test where it was, lo and behold in the left front side of my brain. Yes something to make me go crazy and whatever else. And now that's not all of it she also put one in my 11 month old daughter's organs. So my lady took some time and finally removed this wicked spell off of me and my daughter.

Though Jamie Haywood is semi illiterate it is clear what her meaning is just as it is clear what Rebecca West's meaning was when she appealed for help with Devra West's shamanic witchcraft. Remember Devra West herself professed to have been trained in shamanic visioning when being interviewed by the [Whitefish Pilot](#) news reporter.

When I was young there was this silly joke going around school which was "What do you call a gorilla with a machine gun?" The answer was "Sir." Giving occult knowledge to someone like Devra West,

who is clearly criminally insane, is like being in the presence of a gorilla with a machine gun – one false move or a word out of place and you could find yourself dead.



Devra West's many interactions with the police and her many appearances in court, both civil and criminal, have taught her that she is quite beyond the reach of the law. The failure of the legal establishment to successfully indict her for crimes ranging from theft to murder has led to the belief by this criminally insane person that she is indeed a God. For example, in July 2007 several, as in 6 or 7 witnesses (Rebecca West included) phoned the Flathead police to say that they were the victim of occult 'under the radar' violence being directed at them by Devra West in an attempt by her to intimidate them into changing or withdrawing their witness statements against her.

While the police believed what the witnesses said, they explained that because the weapon Devra West was using against them was not regarded as a weapon under 'legal statute' there was nothing they could do to stop the attacks but suggested the victims mount a lawsuit against Devra West on the basis of 'intent to cause harm.'

(3.) Further evidence of Devra West's ability to act against victims and witnesses alike came in the form of the sudden death of ex-student, Lisa Swidler, who in 2005 was witness to Devra West defrauding student Dave Kushner out of \$30,000 and in that same year kidnapping, falsely imprisoning and extorting thousands of dollars from ex-student, Marion Cantwell.

Shortly after these events occurred, Lisa tried to escape from the cult and died shortly after of internal bleeding, leaving behind two small children under the age of ten – dead men cannot talk and it is believed that Lisa knew of the whereabouts of the many skeletons that Devra West wanted to keep hidden.

MORE EVIDENCE OF CRIMINAL INSANITY. Fast forward from 2005 to August 2007, at which time senior cult member Geoffrey Reynolds CPA was being interviewed by the [Bigfork Eagle](#) newspaper. Apart from being well briefed and answering the reporters' questions with well-prepared lies, Reynolds, in what he thought was an 'off the record conversation' let the reporter know that the whistleblower would be dead within 12 months for going public about Devra West's cult / criminal racketeering business model. Clearly Geoffrey Reynolds knew that Devra West was going to use her occult knowledge to murder the whistleblower, just as she had murdered Lisa Swidler two years earlier.

As made clear by Jeremy Samuelson and Satya, Devra Patton West is a Master at manipulating others into doing her bidding we know that she persuaded Jeremy Samuelson, Satya, ex-student Dave Kushner, ex-student Marion Cantwell and ex-student Mike Hendrickson into loaning her money and never repaid any of them. Similarly, she was able to persuade her weak minded accomplices to provide false witness against both Dr. Cole MD, who she viciously assaulted and successfully extorted \$1.3 million from and do the same with the whistleblower, who she defrauded hundreds of thousands of dollars from.

MORE EVIDENCE OF CRIMINAL INSANITY. We know that Devra West did assault Dr. Cole MD because she admitted it in the letter she wrote to those on her mailing list on the 17 April 2006, which was within days of the police being called and Devra West being charged with assault. Below is a short excerpt containing some of the comments made by Devra West in the missive she sent to her mailing list entitled ['The Law of Severity on the Path to Purification.'](#)

The Law of Severity on the Path of Purification
Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul

I already noted above in this email, that this missive was an attempt by the criminally insane Devra Patton West, while posing as the Ascended Master 'Surya Devi,' to justify the vicious attack of Dr. Cole MD by saying that the victim was a Nazi in the WWII death camps (in another lifetime!). In the excerpt above, Devra West, while posing as Surya Devi, purports to have received a channelled message from another long dead Ascended Master El Morya, within which El Morya states, and I quote from above:-

"At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted."

Let us now here from the victim to see if she thought that the beating administered by Devra West was administered with grace!

This from an interview Dr. Cole gave to the Whitefish Pilot newspaper:-

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."

Photos taken after the alleged beating were submitted to the sheriff's office.

It gets worse, in that another employee of Devra West's came forward to the authorities and confided that she overheard Devra West planning Dr. Cole's murder. Below is an excerpt from her statement of fact.

Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

MORE EVIDENCE OF CRIMINAL INSANITY. Dr Cole MD was not the only victim of a vicious assault by Devra Patton West in 2000. 

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West’s trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West’s trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.






