Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortle issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

(4A) Theft of \$5,000,000 plus from 'The Circle of Divine Unity' charity in 2004. It is worth noting that not all of Devra West's assets were put up for sale in 2008 to pay past victims of fraud, \$2,000,000 in court fines and interest. After her charity was [struck off for fraud](#) in November 2003, Devra West stole the [Victor MT](#) property belonging to the charity, worth \$1,250,000 (in 2003) and put it in a trust fund for her and her son, Robert Meador. That trust fund was 'broken' by a judge in 2008 as part of the '[Sheriff's Sale](#)' (see above point 4) and the property she stole from the charity in 2004 was used to pay part of the \$2,000,000 she owed her victims.

However, approximately \$4,000,000 in artwork and valuables (as valued in 2002) belonging to the charity and paid for largely by public donations, were also stolen by Devra West and put into a storage unit where they remained for ten years - until after the statute of limitations on theft expired after which they appeared at auction in Cave Creek AZ and [on her website](#) as part of her 'Art Collection.' While being questioned under oath in 2009, Devra West was [shown a list of artwork and valuables](#) that the whistleblower had produced with Devra West's then bookkeeper, Cheryl O'Brien. Devra West remembered seeing the list but stated that items on the list must have been stolen or given away. She also stated that none of those items belong to her! So how come the items listed are now displayed on her website?

ORDER

IT IS THEREFORE ORDERED that Plaintiff John Watson's *Motion for Sanctions* is hereby **GRANTED** to the extent that West's answer is ordered stricken, and default judgment is entered in favor of Watson on his breach of contract and tort claims.

IT IS FURTHER ORDERED that a bench hearing on the amount of damages to which Watson is entitled is set for the 2nd day of October, 2008, at 9:00 o'clock a. m., as the first setting, for three (3) hours.

IT IS FURTHER ORDERED that Watson is entitled to his reasonable expenses including attorney fees incurred in bringing this motion and in preparing his proposed Pretrial Order. Counsel for Watson is directed to file an itemized statement of his fees within 20 days of the date of this order. A hearing on the reasonableness of the fees claimed will be held in conjunction with the bench trial on the date set forth above.

¶1 Pursuant to Section I, Paragraph 3(d)(v), Montana Supreme Court 1996 Internal Operating Rules, as amended in 2003, the following memorandum decision shall not be cited as precedent. It shall be filed as a public document with the Clerk of the Supreme Court and its case title, Supreme Court cause number and disposition shall be included in this Court's quarterly list of noncitable cases published in the Pacific Reporter and Montana Reports.

¶2 Chris Haywood (Haywood) appeals an order in the Eleventh Judicial District Court denying his motion to set aside a default judgment against him. We conclude the District Court did not err in denying Haywood's motion and affirm its decision.

¶3 Haywood and his mother Devra West (Devra) reside in Lakeside, Montana. Haywood states that he is the project manager for Sanctuary Environments, LLC (Sanctuary), a business which is involved in buying and remodeling homes and then selling them for a profit. In December 2006, Haywood contracted with plaintiff and appellee Matthew West (West), d/b/a Top to Bottom Construction, to have West build a concrete patio and deck at Devra's house which is located at 525 Political Hill in Lakeside.

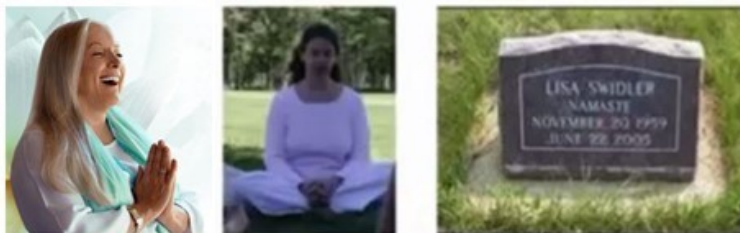

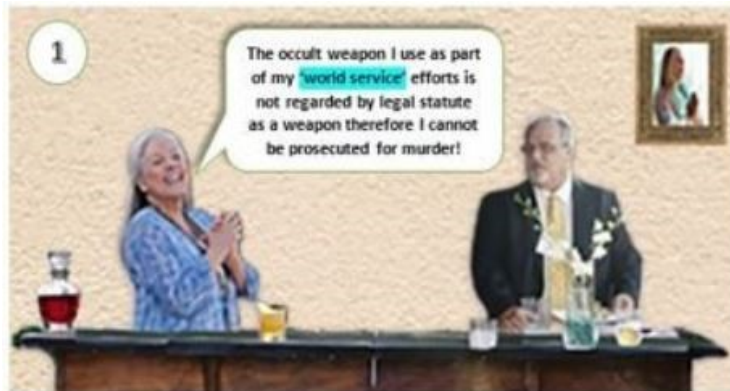

(9) The sudden unexplained death (suspected murder) of witnesses to Devra West's criminal activity.



Ex-student, Lisa Swidler, witnessed ex-student [Dave Kushner](#) being defrauded out of \$30,000 and was witness to ex-student [Marion Cantwell](#) being kidnapped and held captive until she agreed to make a 'donation' of thousands of dollars from the sale of her home to Devra West's good causes. Lisa tried to escape the cult and shortly after she left, died of internal bleeding which the coroner decided was death by natural causes. (9A) Attempted Murder of the whistleblower. Further evidence that Devra West is the head of a criminal / racketeering business that uses murder as a weapon came on August 9 2007, when senior cult member Geoffrey Reynolds CPA was interviewed by the reporter for the [Bigfork Eagle](#) newspaper. In what he thought was an 'off record' comment, he informed the reporter that the whistleblower would be dead within 12 months or in jail for reacting to what Devra West was going to do to him.

There are a number of reasons why Devra West has managed to stay out of jail for the past 27 years. The following is just some of those reasons.

1. The occult (hidden) weapon she uses to commit serious crimes and to terrorize and intimidate victims and witnesses into silence is not recognized by legal statute as a weapon. This is the reason why Geoffrey Reynolds felt confident enough to announce the whistleblower's murder two weeks before Devra West made her failed attempt on his life.

2. Under religious freedom laws, Devra West can make as many crazy claims about her divinity, however obvious it is that she is in fact, a card carrying Satanist and quite possibly a serial killer. Though to be fair, if the weapon she uses to commit murder is not recognized as a weapon, we cannot legally describe the sudden death of her victims as murder – but they still die suddenly under suspicious circumstances!

3. Devra West's cult / criminal / racketeering gang contains many low life scum willing to give Devra West, the leader of their cult, false witness statements making it very difficult for victims to get justice, which explains why 90% do not go to the police or the law courts.

In the case of Devra West's vicious assault on Dr. Pat Cole MD, a local female doctor, business partner and member of her cult, West first admitted the assault to her mailing list saying that as the victim was a Nazi in the WWII death camps in another lifetime the beating was justified and long overdue. Her written admission of guilt entitled '[The Law of Severity on the Path to Purification](#)' sent out on April 17 2006 also stated that while the beating meted was severe it was at all times administered with grace!

Of course when the two newspaper articles were published in the [Whitefish Pilot](#) and the [Bigfork Eagle](#) detailing her criminality in the Lakeside MT area, she vehemently denied assaulting Dr. Cole MD even though the police were called and she was charged with assault. At the time, members of her cult / gang, notably [Geoffrey Reynolds CPA](#), [Julio Williams MD](#) and her ex-husband [Jack West](#) were frantically making statements of denial from her website where they all vilified the press for reporting the story and at the same time accused the victim Dr. Cole of trying to extort money from Devra West!

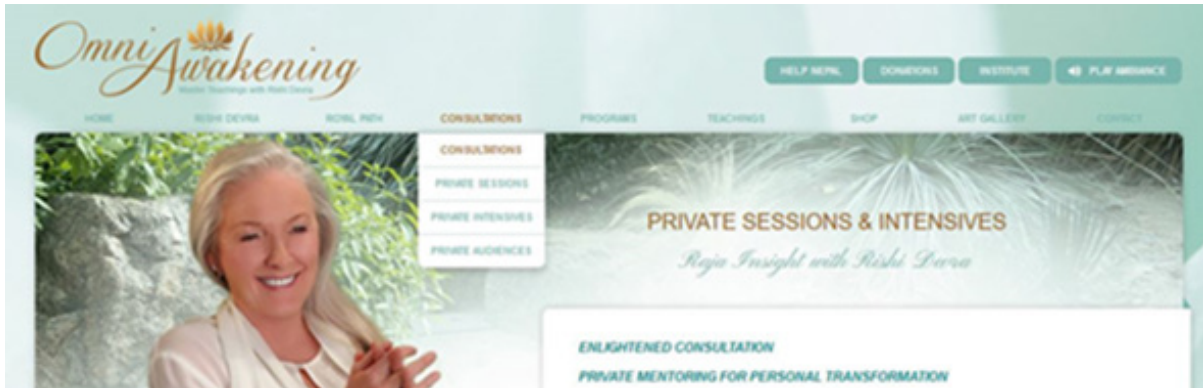

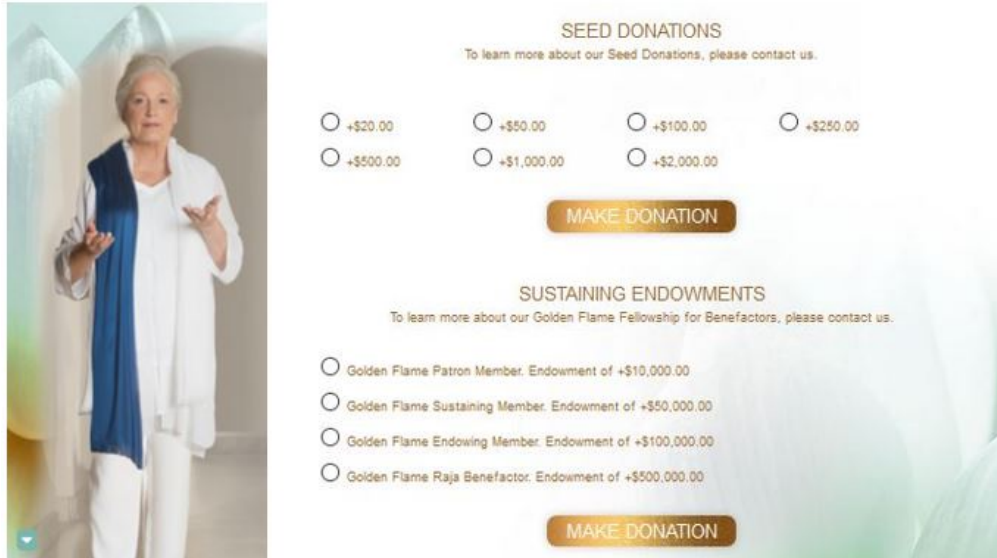
Step 2. You will be targeted and duped / manipulated / pressured into believing one of the following two scenarios.
