**Above left and right, tens of thousands of dollars are used to promote Devra West via her website and social media as a 'divine being' when the reality is quite different. Embraced and recognized by spiritual heads and enlightened masters, she is regarded as a 'Lotus Born Soul' by pundits and yogic masters. The Rishi retained her sense of divine presence from birth and even as a toddler was cognizant of incarnating into a physical body with a higher destiny to fulfill. Her link to the divine worlds was encouraged by her paternal grandmother, a devout charismatic healer and clairvoyant, who taught her to navigate the spirit world of masters and angels throughout her childhood, with past life recall and the ability to see into the future as her commonplace occurrence.*

*She received her first spiritual initiation at the age of seven, being spontaneously flooded with wave after wave of light, experiencing the direct presence of the Great Masters. 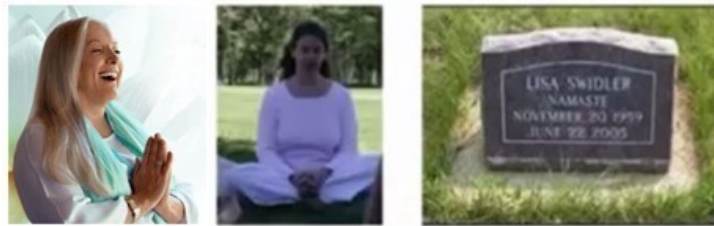

The senior members of her cult, Reynolds, Williams and ex-husband Jack West, are each willing accomplices in her criminal racketeering business model. You know that Devra West is running a criminal / racketeering business model when individuals like Geoffrey Reynolds are persuaded, as willing gang members, to act as stooges against Devra West's enemies. In the case of the whistleblower, who left West's 'employ' in August 2002, Reynolds did not know he existed, as he only joined West's employ in September 2006 and joined her in Lakeside MT from Carefree AZ. It is obvious to all, that all the information Reynolds gained about the whistleblower was acquired after his employment / membership of the gang commenced, post September 2006. And yet, Reynolds agreed to be complicit in a plot to murder the whistleblower in 2007 and when that failed, waited three years to 2010 to jointly serve the whistleblower for defamation. As you will see, if you review [this document which includes Reynolds's pleadings to the court](#), Reynolds could not have been defamed by the whistleblower between 2002 and 2006 as according to Reynolds own website he never moved to Lakeside MT to take up his employment with Devra West until September 2006.

Like Rat Reynolds, and on the direction of cult / gang leader Devra West, Williams is used to intimidate victims and witnesses of crimes committed by Devra West. Below is an excerpt from an email written by Julio Williams to the whistleblower in 2007. This, intended to intimidate the whistleblower into withdrawing his lawsuit against Devra West for fraud – which the whistleblower won in 2008.

Another example of what Jack West does in the cult can be ascertained by reading [this statement](#) from an ex-board member of West's so called charity which was [struck off for fraud](#) in November 2003. Ex-board member, AJ White describes how after employee Susannah Felder challenged Devra West about an \$80,000 donation she stole from the charity, Devra West partially scalped her during a vicious attack. Jack West's role was to lie about the circumstances of the attack in an attempt to blame the victim for partially scalping herself!

Unfortunately for Devra West, and in spite of the efforts of liars for hire like Reynolds, Williams and ex-husband Jack West, there is more than sufficient documentary evidence about her so called 'metamorphosis' over the past 25 years to show that what is being described by her on her websites is a pack of lies, deceit and propaganda. The senior members of the cult are used to deny the truth should news of Devra West's criminality leak outside the cult into the public domain. This happened in July 2007, when news of Devra West's vicious assault on Dr. Cole MD became the subject of two newspaper articles.

**One victim's harrowing story, who only avoided being murdered because she agreed to make a 'donation' of \$1.3 million. How many more victims are there like her whose stories are hidden within the cult. Pat Cole's story only came to light after the whistleblower shared details of Devra West's criminal / racketeering gang with the press in Montana forcing her to relocate to Arizona where she now operates with a new identity.**

In brief, Devra West assaulted ex-student Dr. Cole as part of a campaign of violence designed to extort \$1.3 million from her. West admitted the assault in a letter she wrote entitled '[The Law of Severity on the Path to Purification.](#)' to her cult on April 17 2006; another witness to the crime, [Carlida Finch](#), overheard Devra West talking about murdering Dr. Cole MD and made a statement to the authorities. West was eventually [convicted of that assault](#) in April 2008.

However, when the [Whitefish Pilot](#), the first of two newspaper articles to focus on the assault, were published in July of 2007, the senior cult members [Geoffrey Reynolds](#), [Julio Williams](#) and ex-husband [Jack West](#) all published statements of denial on West's website. In Reynolds' case, he posted four statements of denial; even though at the time, he was desperately trying to force a copy of West's written admission of guilt (that she had assaulted Dr. Cole MD) from the whistleblower's website! Here is the statement of denial from Jack West posted on Devra West's website on exactly the same day as all of the other statements of denial.

**Do you think that this is a spiritual group focused on 'world service?' Or like me and countless others do you believe that these individuals are all acting together in a criminal / racketeering business model predicated by West's knowledge of the occult which allows her to prey on wealthy spiritual seekers with impunity.**

Why impunity? Because over and over again victims go to the police only to be told that the 'weapon' Devra West is using to commit these crimes (and intimidate victims and witnesses into not going to the police) is not regarded as a weapon by legal statute! Knowing this the senior members of her cult, Reynolds, Williams and Jack West believe Devra West to be immune from prosecution. Reynolds felt so

confident that he shared the murder plot in what he thought was an 'off the record' conversation with the press reporter working for the [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers. Which is why, even though Reynolds, Williams and Jack West are well aware of the following they still sell / market Devra West to the public as the second coming.

## **THIS IS HOW ORGANIZED CRIME WORKS. THIS IS WHAT CRIMINALS DO WHEN THEY ARE CHALLENGED OR 'OUTED' PUBLICLY!**

Take the whistleblower who was defrauded out of pay and shares in 2002; just one of countless victims to pass through the meat grinder that is Devra West's criminal / racketeering business model. After attending a private meeting with Devra West in March 2003 at which he announced he was going to sue Devra West for fraud she stated the following:-

**WARNING** foul mouthed Sage of Sedona, foul mouthed Rishi of the West.

She subsequently used other members of her cult / criminal gang to try and intimidate him into backing down – which he refused to do winning his lawsuit in 2008. Below here is a sequence of events that happened all orchestrated by Devra West with cult / gang members playing their parts as directed by her.

**1. DEFAMATION.** Senior cult / gang member Julio Williams posts a [defamatory statement](#) on West's website in 2005; he was joined by two other cult / gang members all three signing off on the statement even though they were all strangers to the whistleblower.

**2. FALSE WITNESSES.** Devra West announced in 2005 that she would get [so f\\*cking down and dirty](#) if the whistleblower sued her for fraud and one of the ways she did that was to get members of her cult / criminal gang to write totally false statements about him that she would use in court against him. This is [an email](#) from one of the cult members who wrote to the whistleblower's lawyer retracting her false statement.

**3. THREATS & INTIMIDATION.** Senior cult / gang member Julio Williams MD sent the whistleblower an [email](#) (included above) basically telling the whistleblower that he had allocated \$2,000,000 to Devra West's legal expenses; the email also told the whistleblower not to f\*ck with him or else! Who behaves like this in real life – who would insert themselves in real life between two warring parties? Answer a gang / cult member showing their loyalty to their leader.

**4. MURDER ATTEMPT.** If criminal gangs / cults cannot silence you with threats and intimidation they will move to murder. On August 9 2007 senior cult member [Geoffrey Reynolds CPA](#), in what he thought was an 'off the record' conversation with the reporter, told the [Bigfork Eagle](#) that the whistleblower

would be dead within 12 months or in jail for reacting to what Devra West was going to do to him. The reporter took the threat seriously enough to pass it on to a federal agent.

**5. CRIMINAL CONSPIRACY.** When the murder attempt failed, the attempt made two weeks after Reynolds's prediction, the cult / criminal gang's multi-million dollar a year criminal business model went into hibernation as no one in Montana was buying the Devra West 'divine being' routine anymore as it was obvious from her actions that Devra West was the leader of a criminal / racketeering gang. However in 2010 when the whistleblower arrived at court in Montana (having emigrated to Nova Scotia in 2005) to see what the court was going to award him for winning his fraud lawsuit against Devra West both Devra West and her accomplice Geoffrey Reynolds served him for defamation for telling the truth!

Long story short, and leaving aside Devra West's claims she was defamed because the whistleblower had posted copies of her arrest warrants on his website, Geoffrey Reynolds, never a party to these proceedings, went in front of a Montana court [and stated in his pleadings](#) that he too had been defamed by the whistleblower between 2002 and 2006 even though his employment with West commenced in September 2006 and prior to that he had lived in Cave Creek AZ and was totally unaware that the whistleblower existed.

**Again Reynolds is a stooge / tool who was manipulated into lying to the courts so as to avenge West's very public defeat in court in 2008 for defrauding the whistleblower.**

**6. MORE LIES FROM GANG MEMBER GEOFFREY REYNOLDS CPA.** One of the other victims circa 2007 / 2008 was Dr. Pat Cole MD. Cole was a wealthy student / business partner of Devra West's and was the victim of a series of violent assaults which culminated in the police being called in April 2006 with West being convicted of the assault in April 2008. A few paragraphs above here we set out the four statements of denial (that Devra West had assaulted Dr. Cole MD) that Geoffrey Reynolds posted on his gang / cult leader's website. ## *Spiritual guru pleads guilty in assault*

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.



#### **4. 2008 Judgement awarded against Devra West for defrauding the whistleblower.**

**ORDER**

IT IS THEREFORE ORDERED that Plaintiff John Watson's *Motion for Sanctions* is hereby **GRANTED** to the extent that West's answer is ordered stricken, and default judgment is entered in favor of Watson on his breach of contract and tort claims.

IT IS FURTHER ORDERED that a bench hearing on the amount of damages to which Watson is entitled is set for the 2<sup>nd</sup> day of October, 2008, at 9:00 o'clock a. m., as the first setting, for three (3) hours.

IT IS FURTHER ORDERED that Watson is entitled to his reasonable expenses including attorney fees incurred in bringing this motion and in preparing his proposed Pretrial Order. Counsel for Watson is directed to file an itemized statement of his fees within 20 days of the date of this order. A hearing on the reasonableness of the fees claimed will be held in conjunction with the bench trial on the date set forth above.

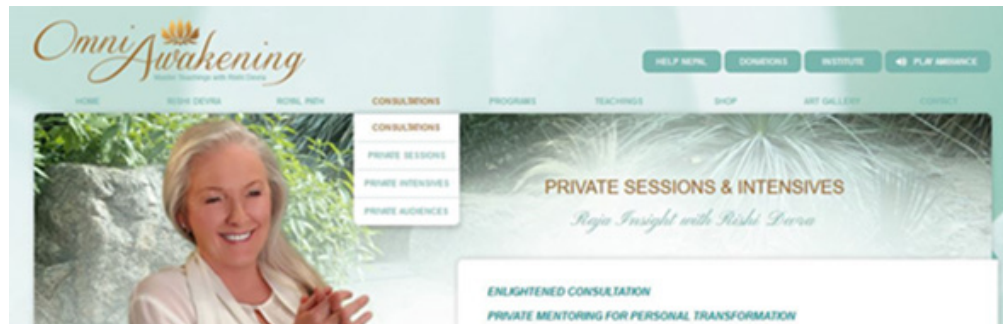

Haywood states that he is the project manager for Sanctuary Environments, LLC (Sanctuary), a business which is involved in buying and remodeling homes and then selling them for a profit. 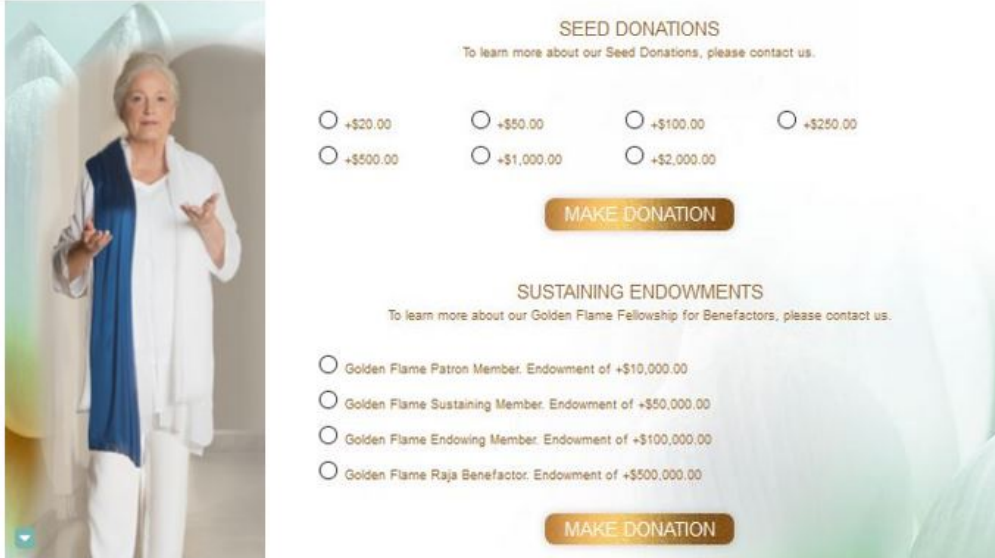

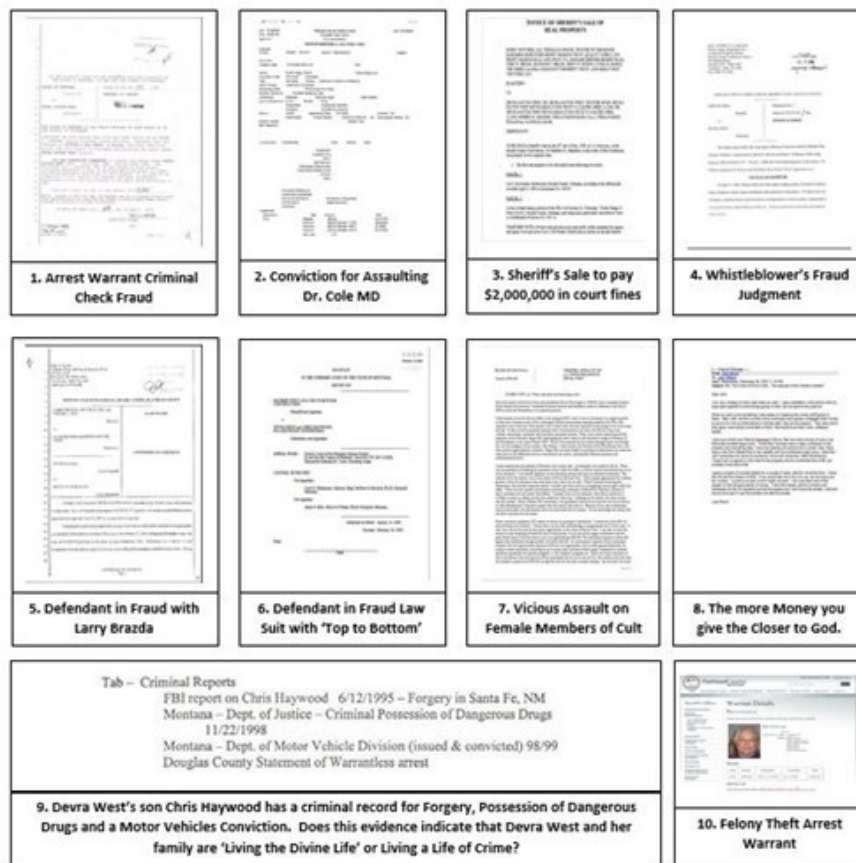
