Dear FBI, IRS and Sedona & Scottsdale Police Departments,


We make a further submission to you all, in the hope that you will launch a murder investigation and/or an investigation under RICO legislation into the activities of Devra Patton West and her accomplices listed below here. We are certain based on the evidence, a fraction of which is presented below here, that Devra Patton West is not a guru, but is masquerading as one only for the purposes of committing multiple serious crimes - including acts of theft, fraud, extortion attempted murder and we believe at least one murder as detailed below.

We are certain of two things; one the information we have provided in these bulletins should it be acted upon would result in successful prosecutions against Devra West and her accomplices for many of the predicate offenses listed in the RICO legislation. Two; we are certain that Devra West's current activities in Arizona where she is offering 'Divine Grace Healings' and 'Dispensation of Karma' for hundreds of thousands of dollars a go, is a front for more sinister activities of the kind previously implemented in Montana and New Mexico before that. Put simply, once West has identified who the wealthy punters are, she targets them to attend meetings, makes them ill and then offers to cure them for a large fee. There are witnesses to this 'sting' being carried out in Montana where the fee was \$500,000.

Devra West believes that she is totally beyond the reach of the law, and so far, she has been proven right. She has gotten away with countless crimes against victims with little cost to herself and when the area in which she is operating gets too hot for comfort, she simply moves to another western state where they do not understand 'white collar' crime or simply do not have the resources to prosecute it. Our campaign is partly driven by the fact that Devra West continues to mount a campaign of intimidation against the whistleblower, John Watson and his family, and partly driven by the need to see justice for the murder of Lisa Swidler. The whistleblower is ready and willing to turn state's evidence against Devra West and her accomplices.

To recover her losses, Devra Patton West proceeded to ‘harvest’ several individual members of her cult as well as ‘cash in’ on a massive fraud she had been planning and perpetrating against the charity she ran. This resulted in her defrauding the public and the state of Montana out of \$7,000,000 plus in public donations. Ex-board member of the charity, [AJ White](#), touches on this matter but the whistleblower has chapter and verse.

Ms. West, a card carrying Satanist, narcissist and psychopath ruled her cult like a medieval baron. Inside the cult, state and federal laws did not apply. The slightest infraction of her rules meant either a beating or a large fine. After West was defrauded out of \$650,000 the usual steady flow of financial crimes against rank and file cult members turned into a torrent as West sought to recover her losses. Below are some of the larger individual victims – all cult members and all too afraid to go to the police, law courts and or go public.

Dave Kushner – Defrauded 2005.

In 2005, and because Devra West does not communicate directly with the peasants in her cult, she had her student / teacher Lisa Swidler act as a go between to negotiate a loan from student [Dave Kushner](#). The terms of the agreement were that Devra West agreed to repay the loan within 14 days. However, after signing the agreement and receiving the funds, she reneged upon the agreement. In an earlier meeting with the whistleblower, which he recorded, Devra West admitted that [her agreements were worthless](#). It is a pity that Dave Kushner did not know that!

Marion Cantwell – the victim of Kidnap, False Imprisonment and Extortion 2005.

In 2005, the next person to be 'harvested' was cult member, [Marion Cantwell](#), who having recently sold her home was kidnapped, held captive, beaten until she agreed to hand over tens of thousands of dollars from the sale proceeds of her home to Devra West. After agreeing to 'donate' tens of thousands of dollars to Devra Patton West's good causes, Marion was released and threatened with murder if she went to the police, the law courts or went public.

Mike Hendrickson – Defrauded out of \$200,000.

Another cult member to be harvested by Devra West was Mike Hendrickson; a partner in a Colorado accountancy firm and a long time student of Devra West. After agreeing to sign a guarantee for the charity's bank account in the amount of \$200,000, Devra West proceeded to transfer the \$200,000 into a personal trust fund for her and her eldest son, Rob Meador. Mike was left with no choice but to honor the guarantee and transfer \$200,000 to the bank from his savings to cover the amount West had stolen from the charity. This matter is mentioned briefly in the 2007 news article published by the [Whitefish Pilot](#) newspaper.

Lisa Swidler – Murdered 2005.

In 2005, Devra West, above left, murdered the person above right Lisa Swidler. Because the victim on the right was a member of a cult led by Devra Patton West, other members of the cult, too afraid to come forward, remained silent as to the motive for the murder. The motive for murder was that Lisa Swidler was a witness to the crimes committed by Devra West against both [Dave Kushner](#) and [Marion Cantwell](#).

The weapon used by Devra West to murder the person on the right is not regarded as a weapon by legal statute so a successful prosecution was unlikely to succeed. A fact that the person on the left has relied upon for the past 27 years while operating her murderous criminal racketeering business model in three western states i.e. NM. MT & currently AZ.

The State of Montana, the IRS and scores of individual donors – Massive Fraud 2004 / 2005.

In January 2004, Devra West's charity, 'The Circle of Divine Unity,' was **struck off** the Montana charity register for fraud. As a consequence, and in addition to the individual victims of theft, fraud and extortion, Devra West enacted a massive fraud against the state of Montana, the IRS and the public who had donated millions of dollars to 'The Circle of Divine Unity' charity believing that the money was going to the charitable causes espoused in her literature and on her website. Instead the following happened:-

1. The Theft of a property worth \$1,250,000 in 2004. In 2004/5 Devra Patton West, having bankrupted her own charity with her expensive lifestyle (one example was her **buying a \$2,000 pearl necklaces** on the charity's credit card) claimed the charity's major asset, a property worth \$1,250,000, in lieu of several fake loans she had placed against the charity. The property, along with the \$200,000 she stole from the charity's bank account, went into a property trust for her and her eldest son Rob Meador only to later be sold at auction in a **Sheriff's Sale** to pay \$2,000,000 in court fines and interest that Devra West owed to victims of earlier crimes.

2. The theft of \$4,000,000 in artwork and valuables. In 2004/5, Devra Patton West stole artwork and valuables paid for by public donation from her charity. The items, valued at \$4,000,000 in 2002, went missing after her charity was **struck off** for fraud but turned up ten years later in Arizona after the statute of limitations on theft had expired. In 2009, while being deposed by the whistleblower's lawyer Devra West, a pathological liar, denied that the above mentioned items existed and suggested that they had been "carried off." **Follow this link** to read the statement Devra West made to the whistleblower's lawyer in 2009 under oath.

Dr. Pat Cole MD – Threatened with Murder, Viciously Assaulted and the victim of Extortion in the amount of \$1.3 million 2006/7.



Below is the statement the victim, Dr. Pat Cole MD made to the [Whitefish Pilot](#) newspaper on July 12 2007:-

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims Devra West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

In addition to Cole's statement to the press about her treatment, the following statements from [Rebecca West](#), [John Mark Young](#) and [Carlida Finch](#) attest to Devra West's mental and physical cruelty towards Dr. Cole MD. Below is a short excerpt from Carlida Finch's statement to the authorities wherein she states that she overheard Devra West planning Cole's murder.



Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

Devra West justified the assault to her cult by asserting that the victim was a Nazi in the WWII death camps in another lifetime! Below is an excerpt from the missive she wrote to her cult pretending to be channeling the contents of this big lie from the long dead Ascended Master El Morya.

She has offered up very resource and body, mind and soul

The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is all a huge deceit by West to justify her actions to the rest of the brainwashed and conditioned members of her cult. 
Robert & Tabby Ivy – Victims of Fraud 2006 to 2007.



An important part of Devra West’s criminal racketeering fraud scam is to represent herself to the public at large and potential investors and donors (future victims) as a wealthy business woman. The reality at the time was that during 2006/7 timeframe, Devra West was in quick succession evicted from two rental properties, was the subject of a lien for unpaid employment insurance and was the defendant in multiple fraud related lawsuits. Here is what the [Bigfork Eagle](#) newspaper, published on August 9 2007, had to say about these matters:-

Out of six businesses mentioned in West's literature, only one remains active and in good standing with the Montana Secretary of State office -- Sacred Environments LLC. Two were never registered -- Divine Unity Foundation and Millennium Mind Institution; two were involuntarily dissolved -- Surya Enterprises Unlimited and Global Guardianship Initiative; and one was involuntarily revoked -- Sacred Archive Institute. Besides being evicted from her Bayside home in Lakeside and bouncing a check for the purchase of the well-known Osprey House on Angel Point, West has a \$2,287 lien against her for failing to pay unemployment taxes for her Montana employees.

One of the ways she created the illusion that she was a wealthy business woman during this timeframe was to fraudulently misrepresent images of other persons property on her website and in her brochures as belonging to her. This, done for the obvious purpose of deceiving others into buying into the illusion that she was a well to do business woman, instead of the reality, which was that she was the head of a criminal racketeering gang.

Below here is a statement the real owners of the property gave to the [Whitefish Pilot](#) newspaper about this matter, the article published July 12 2007:-

A third Lakeside property -- the well-known Osprey House on Angel Point, owned by Robert and Tabby Ivy -- is promoted in the Surya Ma Enterprise brochure as the "Surya Devi VIP Retreat Spa." Tabby Ivy refutes that claim.

"Devra consistently misrepresents her involvement with our house, erroneously saying she has an offer on it, but we have had no formal offer nor accepted any from her," she said. "After I saw our house in her brochure, I walked into her office and said, 'I don't want my house on any of your marketing materials.' For two years, she claimed she was going to buy our home. She wrote a bad check for several million dollars to the Realtor, and that was our experience with her."


Let me remind you that the above two newspaper articles in the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers were published within a month of each other i.e. on July 12 & August 9 2007. And yet while appearing in court on July 12 2007, the very day that the [Whitefish Pilot](#) newspaper article was published (showing that she was close to bankruptcy for the second time) Devra West gave the following statement under oath while giving evidence on behalf of her porn loving wife beating son Chris Haywood who also has an FBI criminal record.

The above lie was recorded on page 29 of the transcript. Devra West was eventually convicted of assaulting Dr. Cole MD in April 2008 as the news article in the [Whitefish Pilot of 24 April 2008](#) attests; copy below.

The Whistleblower John Watson – Victim of fraud, attempted murder, a criminal conspiracy to bankrupt him and an eleven year campaign of occult 'under the radar' intimidation (ongoing) directed at him and his family.



In January 2002, the whistleblower John Watson, was recruited into what he later became to realize was a cult via a meditation group run by Devra West's ex-husband, Jack West, for the express purpose of recruiting and entrapping new blood into Devra West's cult. This method of recruitment along with ['meet up'](#) groups advertised on social media is still used today in Arizona. After being recruited as a business consultant (like many before and since) the whistleblower was tasked with setting up a number of for-profit and non-profit corporations which he proceeded to do on the understanding that when the work was done he would be rewarded with pay and shares in the for-profit corporation known as Millennium Mind Inc.

On completion of the work, Devra West announced that God had spoken to her and told her that shares in corporations were a thing of the past, and as a result of that conversation (with God) the whistleblower would not be paid for the 6 months work he had completed or be granted shares in the Millennia Mind Corporation that he had formed using his own New York accountants. Devra West, having used and abused and constructively dismissed the whistleblower, went forward with the Millennia Mind project after the Corinne Coffin, the third partner in the project, went ahead and invested \$750,000 into the project.



“She is a blessing to all souls”

The whistleblower came to understand that a core part of Devra West’s criminal racketeering business model was to recruit employees and consultants to work on projects that were never intended to be completed or come to fruition but were just ‘templates’ to rally new recruits around to fund raise for her while at the same time she focused on trying to brainwash and condition them into joining her cult as no paid or low paid slaves submitting to her total control. After realizing that Devra West had no intention of honoring the agreements she had made with the whistleblower he decided to launch a fraud lawsuit against Devra Patton West which he announced to her early in 2003 – several months after his constructive dismissal by her in August 2002. [A lawsuit he won in 2008.](#)

The following events occurred after he announced he was going to sue Devra West for fraud. These events show beyond any doubt, that Devra West is not a guru but a dangerous criminal masquerading as a guru, using religious freedom laws as a cover for her lies, deceit and propaganda.

1. Devra West requested a private meeting with the whistleblower at his home in March 2003, which unbeknown to Devra West, the whistleblower recorded. You can listen to the entire recording by going [here](#). During the meeting she admitted defrauding him but did not see herself writing out a cheque for what she owed him. Other highlights of the meeting were the following statements by Devra West which show her in her true light:-

WARNING FOUL MOUTHED PLANETARY REGENT!

1. [The truth does not actually matter \(if you can convince the public and a court of law that your lies are truth!\).](#)
2. [If you sue me I’ll get so f**king down and dirty, huge expenses coming out of your pocket and not mine \(because cult members would pay for her legal expenses\).](#)
3. [Yes I dispose of people like Kleenex.](#)
4. [My agreements are not worth anything.](#)

2. Devra West announced during their meeting (see point 2 immediately above here) that she would get so down and f*cking dirty. An email sent from ex-cult member [Anandra George](#) years later to the

whistleblower's lawyer revealed that following their meeting all of West's employees were forced to write false statements about the whistleblower on pain of being fired.

3. Intimidation was directed at the whistleblower in the form of statements posted on West's website in 2005, by three members of her cult (two of whom had never met the whistleblower). These statements were a blatant character assassination of the whistleblower's character while at the same time declaring Devra West to be the second coming. The statements were posted by [Messrs. Williams, Cole and Cornell](#).

4. In January 2007 senior cult member Julio Williams MD, not content to be a party to the defamatory statement posted on Devra West's website (see above), and fearing that the whistleblower's lawsuit was gaining traction, wrote a [threatening email](#) to the whistleblower a short excerpt of which is below here.

> Sent: Saturday, January 06, 2007 2:58 PM
> Subject: The line in the sand has been drowned!

Hear me very clearly now "THE LINE IN THE SAND HAS BEEN DROWN".

I have personally allocated Two million dollars for Dr. West defense and legal expenses. If you want to continue with your insanity go head but just know that you will have to go through me first. If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down.

Mr Watson, You will have your date in court. You fuck with me and you will meet your match.

5. In March 2007, the whistleblower started to receive a series of harrowing emails from [Rebecca West](#), no relation to Devra West, which graphically explained the circumstances she and Pat Cole found themselves trapped inside Devra West's cult. As explained in previous bulletins, Devra West advertises fake jobs and on the basis of what appear to be good employment opportunities, applicants travel from all over the US to take up those vacancies only to have their pay cut by 20% on day one then also told that the health benefits that were advertised were also not available. The new employees were given a stark choice: accept the lower pay and no health benefits or travel back across the US to where they had come from!

Those that stayed and took up their employment with Devra West, were then brainwashed and conditioned into joining her cult and submitting to her will or being fired before the end of the first 90 days after which West would have to pay employment insurance. The following excerpt from Rebecca West's email entitled '[Help Me](#)' makes it very clear that Devra West had a 'revolving door' policy to employees and consultants alike. Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred.

It is clear from the above and the rest of the [emails sent by Rebecca West](#) and scores of other witnesses that Devra West was running a cult which was disguised as a quasi-religious organization, which was in fact a well-oiled criminal racketeering business model with Devra West at its head. After receiving these emails from Rebecca West and others trapped inside the cult, the whistleblower took the decision to go public about Devra West's criminal racketeering business model and shared what he had learned researching his lawsuit with two local newspapers the [Whitefish Pilot](#) & [Bigfork Eagle](#) which published stories about West's criminality on July 12 2007 and August 9 2007 respectively. A further news article about the whistleblower's win in court against Devra West was published by the [Ravalli Republic](#) in October 2008.

6. On August 9 2007, while being interviewed by the [Bigfork Eagle](#) newspaper, and during what he thought were 'off the record' comments, senior cult member Geoffrey Reynolds CPA announced that the whistleblower John Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. The reporter Constance See for the [Bigfork Eagle](#) took his comments seriously enough to share them with the IRS criminal investigator who was looking at Devra West's finances at the time.

We have made it clear in other bulletins that the secret of Devra West's power over others is her use of occult knowledge that she obtained while attending the '[Robert Jaffe School for Energy Mastery](#)' between 1990 & 1991. It is her ability to cause pain, suffering and even death at a distance with plausible deniability which is the source of her power over the members of her cult and over low life scum like Geoffrey Reynolds CPA, Julio Williams MD and ex-husband Jack West who are willing accomplices in what is clearly a murderous criminal racketeering gang.

Clearly, [Geoffrey Reynolds](#) knew that Devra West was going to use her occult knowledge to murder the whistleblower, just as she had murdered Lisa Swidler two years earlier.



Devra West's criminal / racketeering business model is entirely based on her ability to commit murder multiple times and not be called to account. Clearly Reynolds was briefed about the murder of Lisa Swidler and thought that the murder of the whistleblower would also be a 'slam dunk.'



Several days after Reynolds made his statement to the press Devra West made a failed attempt to murder the whistleblower her motive was twofold:-

1. After the whistleblower went public about Devra West's cult and her criminal activity in Montana, it rendered that state useless for her activities because after all the negative publicity no one was buying the 'divine being' routine anymore which formed the basis of her narcissistic fraud scam.

2. Until the mountain of incriminating evidence that was posted on his website was forced down there was little possibility that Devra West could resurrect herself with a new name and new identity in yet another western state where they either do not understand 'white collar' crime or do not prosecute it due to lack of resources.

With the murder plot a failure, West & Reynolds bided their time until they could implement 'Plan B' which they did in 2010. While attending court to see how much he was to be awarded for [winning his fraud lawsuit](#) against Devra West in 2008, the whistleblower was served for defamation by West & Reynolds - for [telling the truth](#). It shows how committed to West's criminality [Geoffrey Reynolds](#) was, that he was prepared not only to go before a Montana judge and make totally false statements about himself and his relationship to the whistleblower, but that having done that, he was then perfectly willing to 'front' the pair of frivolous lawsuits so that Devra West could remain in the shadows.

Remember, Geoffrey Reynolds traveled from Cave Creek AZ to join West's employ in Lakeside MT in September 2006, and yet in Reynolds' pleadings to the Montana court below, he states clearly that he was defamed by the whistleblower between 2002 and 2006??



As one can see below from an excerpt of Reynolds’ resume taken from his own website (full copy available [here](#)), at the time he made these false claims to the Montana court in 2010, Reynolds did not join Devra West’s employ until September 2006, and so did not know that the whistleblower existed until he was briefed about West’s vendetta against the whistleblower after September 2016.

The civil courts rarely dispense

justice; their function is to 'practice' the law. In most cases, as with the whistleblower, the litigant with the most money ends up 'buying' the result they want and in the process the lawyers, judges and others involved in the process earn a good living as is described perfectly by this illustration below.




In Devra West's case, she made it perfectly clear to the whistleblower in March of 2003, that if he took her to court and sued her for fraud, that she would use every dirty trick in the book and that the cost of fighting the lawsuit would come out of his pocket, not hers, because other members of the cult, like Julio Williams who had pledged \$2,000,000 to her legal fees, would pay her costs.

This is what criminals do. If they cannot intimidate you or murder you - they go to law and use their unlimited financial resources to 'buy' the law they want.

After forcing down the whistleblower's websites and believing all information about Devra West's past was buried, the occult thief / suspected serial killer, Devra Patton West and her cult, proceeded to launch the latest iteration of their guru / cult / extortion business in Arizona. Where Devra Patton West, currently operating as the Ascended Master Rishi Devra, is currently targeting the spiritual and metaphysical communities of Sedona & Scottsdale.

Below is a brief summary of Devra West's criminality between 2005 & 2010 while masquerading as the Ascended Master 'Surya Ma.'




1. Arrest Warrant for [Criminal Check Fraud](#).
2. [Conviction](#) for Assaulting Dr. Cole MD & [News Article](#) announcing same.
3. Becoming the subject of a [Sheriff's Sale](#) to force her to pay her creditors \$2,000,000 in court judgments and interest.
4. Whistleblower's [judgment](#) against Devra West for fraud.
5. Defendant in [fraud case](#) brought by Larry Brazda and others.
6. Defendant in [fraud case](#) brought by 'Top to Bottom' Construction.
7. Vicious Assaults on female members of her cult i.e. Susannah [Felder & Beatrice McGuire](#), [Jamie Haywood](#) and [Dr. Pat Cole MD](#).
8. The Students who took out loans for Devra West after being told, "[They would be closer to God.](#)"
9. West's son's [criminal record](#). Like mother like son?
10. [Arrest Warrant](#) for felony theft.

Before reviewing the latest lies, deceit and propaganda being used against the spiritual and metaphysical communities of Sedona & Scottsdale AZ let us explore the 'playbook' that is used by Devra West and her cult / criminal racketeering gang against past victims and against the public as West and her gang seek to convince everyone that she is a divine being and that scores of victims of theft, fraud, extortion and violence are at fault.

Here are some of the elements Devra West and her cult use in pursuit of Devra West's criminal agenda.

1. First of all Devra Patton West's stock in trade is lies. As mentioned above during the meeting with the whistleblower she made it very clear that [The truth does not actually matter \(if you can convince the public and a court of law that your lies are truth!\)](#). Keep repeating the lie over and over again until people come to believe it just as Hitler and his propaganda minister Goebbels did.



2. Dogma. A point of view put forth as authoritative (as truth) without adequate grounds. Devra West's whole 'divine being' paradigm is a lie and a deceit and is seen to be so if one reviews her actions against the dogma she espouses on her website and espoused by cult members like [Julio Williams MD](#).

3. She uses the strategy of Projection against her victims. A definition of 'projection' is as follows. The attribution of one's own ideas, feelings or actions to other people. Especially the externalization of blame, guilt or responsibility. Below here are two examples of projection used by Devra West during her reign of terror as the Ascended Master 'Surya Ma.'

Example 1. After viciously assaulting Dr. Pat Cole MD, after the police were called and after 2 years where she was offered a plea deal by the courts, Devra Patton West was finally convicted of assault in April 2008. Here is a link to the [24 April 2008 news article](#) about her conviction and here is a link to [the court documents](#) evidencing her conviction for assault. Here is a link to Rebecca West's (no relation to Devra West) harrowing email entitled '[Help Me](#)' wherein she talks about the fact that Devra West has extorted \$1.3 million from Dr. Cole (and others.) Devra West's response to the news article about her conviction was to project her crimes onto the victim in this case Dr. Pat Cole MD. Below is a statement Devra West published on her website in response to the news of her conviction.

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

Above: Pathological liar Devra Patton West actually accuses the victim of mounting a conspiracy against her she goes on to announce that "all allegations have been expunged from the records" anticipating the fact that after 6 months misdemeanor assault records are removed from the defendant's criminal record. She goes on to tell lie after lie about Dr. Pat Cole hoping that by destroying Cole's reputation that the public will believe her lies.

Example 2. After the whistleblower received [judgment against Devra Patton West](#) for defrauding him in 2008, a fact that the [Ravalli Republic published a news article about](#) Devra Patton West in another example of 'projection' issued the following statement from her website.

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Firstly, Devra West states that the whistleblower's victory against her was a technical error! Secondly, Devra West goes on to project her criminality onto John Watson by asserting that he had issued many threats against her and that he was responsible for many criminal acts against her and her family. Of course in reality the only threats issued were those against the whistleblower in the form of Julio Williams threat not to f*ck with him and that he had given Devra West \$2,000,000 for her legal fees to fight the fraud lawsuit that the whistleblower had issued against her. The second threat was the one Geoffrey Reynolds CPA, another senior member of her cult / criminal gang, had passed on to the [Bigfork Eagle](#) reporter on August 9 2007. Reynolds stated loudly and clearly that Devra West was going to murder him or hoped to he would be sent to jail for reacting to what she was going to do him and his family.

She goes on to state, under the column TRUTH that no business contract had ever been made between her and John Watson. And in another example of 'projection' West accuses John Watson of being leveraging and extortion scam against her! She further states that all business proposals made by John

Watson were declined and yet it was Devra West who made all the business proposals! If all business proposals were declined then how does Devra West explain [the letter from her then husband Jack West](#) to the INS confirming that John Watson was employed by Devra West setting up for profit and nonprofit corporations! How does she explain the request by the Cactus design agency for both Devra West and John Watson to give a [letter of guarantee](#) for the work they were doing designing the brochures and [business cards](#) for Millennia Mind Inc. the latter showing John Watson as a director of the company. And finally how does Devra West explain the letter she wrote to her lawyer, [Tabbarachi](#), asking him to sever their business arrangements. She cannot! Other than the fact that she is a pathological liar.



Above: Narcissists are renowned for using 'psychological projection' to blame other people, even when it is entirely apparent that they are the ones in the wrong.

Even her personal secretary of 5 years, [Barbara Costantino](#), in a letter she wrote for the whistleblower explained Devra West's tactic of rewriting history after each victim leaves the cult to make it look like Devra west was blameless and the victim was at fault.

4. The use of liars for hire to provide her with false witness statements and testimonials.

That Devra West is clearly at the head of a criminal / racketeering business model is not in doubt that she is also clearly coordinating the actions of the senior members of her gang / cult in an attempt to deny / cover up her crimes is also not in doubt. Why else would senior cult members [Geoffrey Reynolds CPA](#), [Julio Williams MD](#) and ex-husband [Jack West](#) all issue statements of denial on Devra West's website within days of her conviction for assaulting Dr. Pat Cole MD being made public in the local newspapers?

...and the karmic resolution of divine dispensation.

Both the above statements are totally unproven lies; all part of an elaborate criminal racketeering fraud scam that is occasioned by violence and murder. And all flying under the radar right under the noses of the FBI, IRS and local police forces.

6. A Murder weapon not regarded as a weapon by legal statute. Devra West and her then husband Jack West were before 1990 small time crooks defrauding individuals like [Jeremy Samuelson](#) and [Satya](#) out of several thousands of dollars a go. However all that changed after ex-drug dealer and ex-bankrupt Devra Patton West decided to leverage her criminality by attending classes at the '[Robert Jaffe School for Energy Mastery](#)' where she obtained occult (hidden) knowledge that going forward she could use against victims of her criminal racketeering gang. Devra West's criminality is entirely predicated on her ability to commit serious financial crimes and also intimidate the victims and witnesses into silence using murder or the threat of murder against those who go public. The whistleblower John Watson, who was the subject of a murder plot by Devra West (a plot shared with the press by accomplice Geoffrey Reynolds CPA), was not always a believer in West's use of the occult to murder those who oppose her. Though he had his suspicions after the sudden and mysterious death of his friend [Lisa Swidler](#) in 2005 (death caused by internal bleeding) immediately after she fled Devra West's cult. Proof positive did not come until two years later in August 2007. Shortly after Geoffrey Reynolds' off the record comments to the news reporter in August 2007, wherein he stated that the whistleblower would be dead within 12 months after Devra West made her move, which he spelt out in detail in a previous bulletin which you can read by going [here](#).

IN SUMMARY JESUS SAID, "ye shall know them by their fruits." "The good tree can only produce good fruit." "The bad tree can only produce bad fruit." "The good tree cannot produce bad fruit and the bad tree cannot produce good fruit." The fruits of Devra West are theft, fraud, extortion, mental and physical abuse, financial ruin and for those like Lisa Swidler who try to expose her as a card carrying Satanist – death.

Devra West tried to murder the whistleblower; both as revenge for successfully suing her for fraud, and so that she could force down his websites and allow her to move to Arizona with no information about her past available on the web. However, she could not murder him and after eleven plus years of 'under the radar' violence directed at him and his family, she has failed to intimidate him with her use of the occult (hidden) knowledge. This 'truth' campaign will continue until there a criminal investigation is launched into Devra West, her accomplices and her 'world service' efforts. Until then, this Satanist sits in her fake 'Abode of the Masters' in locations in Arizona offering her 'blessings to all souls' when in reality this accursed being destroys everything she touches.

Perhaps the greatest sin of Devra Patton West, in an attempt to lure spiritual seekers into her trap, is to masquerade as the Christ by offering '[Divine Grace Healings](#)' and '[Dispensation of Karma.](#)' Again, the bad tree can only produce bad fruit. To be clear, Devra Patton West, in common with most power grabbing narcissistic psychopaths, is a false messiah; a seed planted here by Satan, Lucifer and Baal. 

Step 2. Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.



Pattern of racketeering activity requires **at least two acts of racketeering activity, one of which occurred after the effective date of this chapter and the last of which occurred within ten years (excluding any period of imprisonment) after the commission of a prior act of racketeering activity.** The [US Supreme Court](#) has instructed federal courts to follow the continuity-plus-relationship test in order to determine whether the facts of a specific case give rise to an established pattern. Predicate acts are related if they "have the same or similar purposes, results, participants, victims, or methods of commission, or otherwise are interrelated by distinguishing characteristics and are not isolated events." ([H.J. Inc. v. Northwestern Bell Telephone Co.](#)) Continuity is both a closed and open ended concept, referring to either a closed period of conduct, or to past conduct that by its nature projects into the future with a threat of repetition.

And...

Under RICO, a person who has committed "at least two acts of racketeering activity" **drawn from a list of 35 crimes**—27 [federal crimes](#) and 8 [state crimes](#)—within a 10-year period can be charged with [racketeering](#) if such acts are related in one of four specified ways to an "enterprise". Those found guilty of racketeering **can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count.** In


addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."

RICO predicate offenses

Under the law, the meaning of **racketeering activity** is set out at [18 U.S.C. § 1961](#). As currently amended it includes:-

- Any violation of state statutes against [gambling](#), [murder](#), [kidnapping](#), [extortion](#), [arson](#), [robbery](#), [bribery](#), dealing in [obscene matter](#), or dealing in a controlled substance or listed chemical (as defined in the [Controlled Substances Act](#));
- Any act of [bribery](#), [counterfeiting](#), [theft](#), [embezzlement](#), [fraud](#), dealing in obscene matter, [obstruction of justice](#), [slavery](#), [racketeering](#), [gambling](#), [money laundering](#), commission of [murder-for-hire](#), and many other offenses covered under the Federal criminal code ([Title 18](#));
- [Embezzlement](#) of [union](#) funds;
- [Bankruptcy](#) fraud or [securities fraud](#);
- [Drug trafficking](#); long-term and elaborate drug networks can also be prosecuted using the [Continuing Criminal Enterprise Statute](#);
- Criminal [copyright infringement](#);
- [Money laundering](#) and related offenses;
- Bringing in, aiding or assisting [aliens](#) in illegally entering the country (if the action was for financial gain);
- Acts of [terrorism](#).

If we just take the most serious crimes committed by Devra Patton West as part of her past **'World Service'** efforts in lifetimes / incarnations **3 & 4** in Montana, we find that there are **NINE** 'Predicate Offenses' that she should be charged under - some of which she has committed multiple times!
