

Subject: Rishi Devra – Clear Evidence of Insanity and Rampant Criminality.

Dear FBI, IRS and Sedona & Scottsdale police departments,





4. Student Lisa Swidler negotiated a short bridging loan of \$30,000 from student [Dave Kushner](#) promising that West would repay the loan within 14 days. After receiving the money West refused to repay it or even discuss it with Dave Kushner in spite of the fact that Devra West had signed a written agreement promising to repay.

5. Student [Marion Cantwell](#) was kidnapped, falsely imprisoned, beaten and only released after handing over tens of thousands of dollars from the recent sale of her property. When she was released she was told that she would be murdered if she went to the police.
6. Student [Beatrice McGuire](#) was attending a seminar in Montreal given by Devra West. During the seminar Beatrice challenged West on an obvious lie and in response, and in front of the entire audience, ripped part of Beatrice's ear away from the side of her head. Beatrice later needed plastic surgery which West paid for!
7. Consultant John Watson was promised pay and shares for setting up for profit and nonprofit corporations for Devra West. After completing the work she refused to pay him saying God had told her shareholding was a thing of the past. Student [Lisa Swidler](#) brokered the bridging loan with Dave Kushner mentioned above in (4.) and was also aware that West kidnapped, falsely imprisoned and extorted money from student Marion Cantwell. Lisa made a break to leave the cult and died suddenly and mysteriously shortly after getting away. We believe that Devra West murdered Lisa to keep her quiet. And why not? The occult weapon West uses to instill fear and discipline in the members of her cult and the victims and witnesses of her crimes is not regarded as a weapon under legal statute!



9. Robert & Tabby Ivy owned a multi-million dollar lakeside property however photographs of their property appeared in Devra West's brochures and on-line on her website. In both cases West inferred that the property belonged to her and not Robert & Tabby Ivy. Over a 2 year period the owners repeatedly asked Devra West not to use images of their property in her marketing material – Devra West ignored their requests as the article in the [Whitefish Pilot](#) about West's criminality makes clear. The Whitefish Pilot news article was published on July 12 2007 which was the same day that West and her son appeared in court as part of a custody hearing. During the hearing West repeatedly lied. For example she stated that she [was a billionaire](#) (when she was broke had [a \\$2,600](#)

[lien](#) against her for unpaid employment insurance) and vehemently [denied assaulting Dr. Cole MD](#) when she wrote to her entire mailing list on 17 April 2006 saying that she did! For the truth of what it is like when Devra Patton West is not masquerading as the Planetary Regent read Jamie Haywood's testimony of what it was like living with Devra West and her porn loving, wife beating son, Chris Haywood.

It should be stated here that West's mantra is that, and I quote, "[The truth does not matter](#)" if she can convince the public that her lies are their truth! The link will take you to an audio recording of West saying that!

10. Mike Hendrickson was a partner in a large Colorado accountancy firm; he was also a student of West's who did the charity's books. After challenging West on money she was stealing from the charity, he was relieved of his position and told to go away until he was prepared to totally submit to her will and accept that the laws of the land do not apply to her. Mike Hendrickson had signed a note guaranteeing the charity's overdraft of \$200,000 however after the whistleblower John Watson reported West's criminality to the authorities her charity was [struck off](#) in January 2004. Devra West immediately emptied the bank account of the [\\$200,000 and put it in a personal trust fund](#) for her and her eldest son Rob Meador. Mike chose not to sue her for fraud as to do so would result in him becoming the subject of an occult 'under the radar' campaign of violence and or be murdered.

In March of 2003, the whistleblower John Watson announced that he was going to sue Devra West for fraud she immediately demanded a private meeting with him at the guest house on his property in Victor MT. Fearing Devra West was going to pull some kind of a stunt he decided to make an audio recording of their face to face meeting as was legal in Montana. The meeting last some 46 minutes during which Devra West used a whole range of tactics against John Watson from bullying, intimidation, threatening and emotional blackmail.

As proof of West's criminality / insanity I wish to share her comments about two of the victims listed above i.e. victim No. 6 Beatrice McGuire and victim No. 7 John Watson the whistleblower.

**6. Beatrice McGuire.** Beatrice McGuire was viciously assaulted in front of scores of witnesses and one of those witnesses was student Debra Coffey. In a notarized statement given to the whistleblower (which can be read in full by [going here](#)) Debra Coffey stated, and I quote:-

***"I was present in Montreal in which Ms. West tore a woman's ear. The woman was kneeling in front of Ms. West and had quietly challenged her authority. Ms. West reacted physically. She grabbed her hair on both sides of her***

***face and shook her and told her to leave. I learned later that the woman was injured. Evidently the woman's ear had been grabbed too and then torn. She underwent reconstructive surgery for the injury."***

Subsequent to the above assault, and as a board director of West's charity in 2002, the whistleblower received a formal letter from Beatrice McGuire informing the board that she was suing Devra West for the cost of plastic surgery. The whistleblower [responded in writing](#) to Beatrice McGuire acknowledging her letter. The whistleblower also [wrote to Devra West](#) about the assault. Devra West wrote a letter to Beatrice McGuire agreeing to pay for the costs of the plastic surgery. In the letter she does not admit the assault or share Beatrice's 'perceptions' of what happened in spite of the scores of witnesses who say what happened! West even goes on to say that she witnessed and experienced something very different!

***"While I cannot share in many of your perceptions and assumptions, I do share in your pain as a human being and the trauma that has been so difficult for you. While I witnessed and experienced something very different in nature than what you expressed, I wish to take full responsibility for any and all problems that take place in the domain of my retreats and classes. Despite the difference in viewpoint, all of us in the Divine Unity family support you in your healing process and offer you the financial sum that you have requested with love and compassion."***

During the March 2003 meeting with Devra West, she implied that if they, she and John Watson, went to court, lots of information (manufactured lies) would come up about the whistleblower. In response the whistleblower mentioned Beatrice McGuire at which point Devra West vehemently denied that she had assaulted Beatrice McGuire and asserted that Beatrice McGuire was mentally ill. The whistleblower then told Devra West that he had spoken to Beatrice McGuire who had confirmed that she had received a financial settlement from Devra West. Devra West, a pathological liar, responded yes (she had given Beatrice a financial settlement) because in a roundabout way someone else had scraped her ear??

**7. John Watson the cult whistleblower.** During the same conversation Devra West described John Watson as 'Prince Charming (1)'. She agreed that she had promised him a salary and shares. She even said that if she was in a court of law she would agree to that however she did not see herself writing out a cheque for him for \$50,000 (2)! Devra West then goes on to ask the whistleblower if he is a 'good listener' then proceeds to talk over him not permitting him to speak! John Watson responds that she is a control freak and that she disposes of people like Kleenex. West acknowledges that she is a control freak and that she has disposed of a lot of people lately (3)! John Watson tells West that she will not do that to him and asks that she pay him so they can both get on with their lives (4).

Devra West then loses it! Having agreed that John Watson was 'Prince Charming,' having agreed that she did promise him pay and shares, having stated that her agreements are worth nothing and having stated that she did not see herself writing out a cheque for the \$50,000 she owed him, she then shows just how mentally unstable she is by asking him if her 'story' matters at all in this conversation. After admitting defrauding the whistleblower she accuses him of exploiting her vulnerability and shoving it up her ass, she also accuses him of, "having some God damn principles while doing it?" She then says that what he is saying to her (about her owing him money) is not true for her and that is the god damn truth, She then accuses him of, and I quote, "Fucking over a Spiritual Teacher for Christ sake (5)!"

The expletive laden conversation continues with Devra West stating that (because she defrauded him out of \$50,000) she feels stabbed in the heart, stabbed in the back and f\*cked up the arse. She goes on to say that she does not feel John Watson (the victims she has defrauded) is listening to her! John Watson eventually loses patience with her diatribe and interrupts her; West realizing that she is not going to be able to bully him into submission leaves the meeting having worked herself up into hysterics (6).

Upon returning to her compound, Devra West calls all of her employees to a meeting at which she tells them that have a choice manufacture fake witness statements about John Watson that she intends to use in court against him or be fired. One employee, Anandra George, later retracted her statement in a letter she sent to John Watson's lawyer. In 2005, cult member Julio Williams MD published a [defamatory statement](#) about the whistleblower on West's website; Williams was a stranger to John Watson but did so on West's instructions. In January 2007, Williams sent a [threatening email](#) to John Watson in which he personally intended to give Devra West \$2,000,000 for her legal fees this was clearly intended to intimidate him into giving up his lawsuit against Devra West his cult leader.

In August 2007, while being interviewed by the [Bigfork Eagle](#) newspaper reporter, senior cult member Geoffrey Reynolds told the reporter that John Watson, the whistleblower, would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family. A few days later Devra West made a failed attempt to murder the whistleblower. In 2008, John Watson won his lawsuit against Devra West for defrauding him. Immediately after the [Ravalli Republic](#) newspaper article was published, Devra West posted the following statement on her website describing Watson's win as a "technical error and a timing matter." She also stated that there were no business contracts between herself and John Watson and that his legal dispute was fabricated by him as part of an extortion scam! She goes on to say that any and all business proposals made by Watson were declined if this was so then why did she [write to her lawyer](#), Tabarrachi, asking him to sever their business connections?

**Millennia Mind Dispute with John Watson:**

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

**TRUTH:** No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

If this is so, why did Devra West's then husband, Jack West, [send a letter](#) to the Immigration and Naturalization Service confirming that Watson was employed, was receiving a salary and was setting up corporations for West? If this was so, then why in their meeting did Devra West agree that she had promised him a salary and shares but did not see herself honoring her agreements to him which she herself described as worthless!

Three years later in 2010, Devra West and Geoffrey Reynolds put plan 'B' into operation as when attending a Montana court in October that year to see what the court was going to award him, for winning his fraud lawsuit against Devra West, both West & Reynolds served him for defamation. The truth is an absolute defense against defamation but only if you can afford to pay the lawyers' fees, the air fares and hotel bills etc. to defend oneself, in this case, against West & [Reynolds' lies](#).

Julio Williams MD a member of west's cult / criminal gang since 2000. Williams posted a defamatory statement about the whistleblower in 2005, sent him a threatening letter in 2007 promising to fund West's legal fees to the tune of \$2,00,000. Williams promotes and supports her claims to be able to deliver 'divine grace healings' and pays for venues for her to interview those prepared to pay \$500,000 for a fake cure!

However just as with John Watson, gang members Reynolds and Williams conspired with Devra West to deny and cover up the vicious assault by West on Dr. Pat Cole MD. We know after the assault in April 2006, the police were called and West was charged with assault. We know that within days of the assault Devra West wrote to her entire mailing list admitting the assault in a missive entitled [The Law of Severity on the Path to Purification](#). That missive alone should give concern to West's mental health. We know while in court on July 12 2007 as a witness for her son, she vehemently [denied assaulting Dr. Cole MD](#). We know that she was found guilty of that assault in April 2008 as this news article in the [Whitefish Pilot](#) bears witness.

However, immediately after the newspaper article appeared Geoffrey Reynolds published four statements of denial on West's website ([1](#), [2](#), [3](#) & [4](#)) and then wrote to the service providers of John Watson's website [claiming copyright](#) over West's April 17 2006 statement she sent to her mailing list wherein she admitted that had assaulted Dr. Cole MD and that the assault was severe. **It should also be noted that Reynolds immediate predecessor resigned rather than be forced to 'manufacture' false invoices to make it look like the \$466,000 extorted by West from Cole was received as 'normal' business receipts. No such problem for Reynolds who proudly told the Bigfork Eagle newspaper that he had money laundered those funds through West's business as payment for an 'internship' and for 'therapy.'**

Williams also posted two statements of denial ([1](#) & [2](#)) even though as a fellow physician, you would have thought that he would have defended Dr. Cole MD.

**Clearly both Reynolds' and Williams' actions were coordinated by Devra West.**

**Court Rules to Dismiss Bogus Assault Case:**

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

**TRUTH:** Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

At the same time West posted a statement on her website, just as she did with John Watson, denying that she had been found guilty of assaulting Dr. Cole MD indeed she stated that the court dismissed the "bogus assault case" against her. She accused Cole of trying to entrap her and, doing what all psychopaths do, she 'mirrored' her own crimes (financial fraud) onto Dr. Cole MD her victim! Devra West, a known psychopath with a history of theft, fraud, extortion and violence against women then impugns Dr. Cole's morality and integrity.



And this between 2005 and 2010 when she operated out of Flathead Lake MT as the Ascended Master **Surya Ma**.






**Step 2.** Those targeted are duped / manipulated / pressured into believing one of the following two scenarios.

1. That they are suffering from a totally non-existent brain tumor or a cancer which Devra West guarantees she can cure for a large fee.
2. That Devra West and the targeted individual were sisters in a former lifetime during which the target is persuaded that she betrayed Devra West in that lifetime and must now, in this lifetime, make financial reparations (for the nonexistent wrongs the target committed).

Devra West has been perpetrating this extortion racket for at least two decades; two of her admin staff who worked for in 2002 overheard her say, after receiving a phone call, that she had just made \$500,000. Apparently, this was the fee paid by one victim who thought they had been cured of a condition that Devra West had in fact given them!
