





Both senior cult / gang members Julio Williams MD and Geoffrey Reynolds CPA are fully aware, like her Brazilian counterpart '[John of God](#),' that Devra Patton West uses her knowledge of the occult to silence (murder) whistleblowers and others who challenge her totally false claims to divinity, and seek to reveal her Satanist credentials. 



My humble salutations to thy lotus feet.” As I try to overcome my reflex action to vomit, I ask the question again: Is Julio Williams mentally ill or a willing accomplice in organized crime?

There is a simple answer to the question as to why senior cult members Julio Williams MD and Geoffrey Reynolds CPA remain cult / gang members, willingly agree to participate in organized crime when asked to do so by Devra Patton West. Such as the plot to murder whistleblower [John Watson](#) when he went public about the cult. Such as the [criminal conspiracy](#) to extort \$10,000,000 from and or bankrupt the whistleblower to silence him after the murder plot failed.

To act as false witnesses and 'liars for hire' when asked to do so such as in the denials that West had [assaulted Dr. Pat Cole MD](#) even though West had admitted the assault in a [letter she sent](#) to hundreds on her mailing list.

The simple answer is that neither Williams nor Reynolds think it is possible for the law to successfully prosecute Devra Patton West for her crimes. The occult is not regarded as a weapon under legal statute, making West's prosecution for theft, fraud, extortion, violent assault and murder very difficult.

Dr. Julio Williams MD hailed from the Dominican Republic where witchcraft and Voodoo are recognized religions. As a 19 year student of Devra Patton West (and senior members of her cult) his loyalty to the leader of his cult / Satanist coven take precedence over morality, the law or any oath he may have signed when becoming a doctor. In short, Dr. Julio Williams MD is well aware that what Jesus stated in Ephesians 6:12 is all too true and he is a willing recruit to the dark side.



Devra Patton West made an unsuccessful attempt to murder the whistleblower John Watson, in August 2007. Williams not only knew about the attempt on John Watson's life but as a senior member of her Satanist cult, took part in the Shamanic visioning sessions that preceded the attempt on Watson's life. Above left: The bullshit and propaganda about Ascension and Divine Grace Healings on West's website are just honey to trap the wealthy into attending 'Private Sessions' with Devra Patton West (see latest con below). Once the wealthy are identified they are subject to a campaign of occult 'under the radar' violence until they 'pay up' to be cured (see the two URL's above this image for details of how this is possible).

Above center: The use of demonic entities to terrorize victims; the source of West's power over the members of her cult and the scores of victims she has robbed, defrauded and extorted money from.

Above right: Julio Williams is a 19 year student of Devra West's occult school and is learning to do this himself. He is aware of West's use of the occult to murder those, like the whistleblower, who go public. He is aware and complicit in her ongoing attempts to intimidate and murder the whistleblower. Below are just some of the occult attacks used by self-appointed deity Devra Patton West, Williams and other members of their Satanist cult to force victims to make large 'donations' to Devra Patton West, via her flashy website ['Pay Portal'](#) that is equipped to take single contributions of up to \$500,000. Coincidentally, that was the amount Devra Patton West was charging for 'Divine Grace Healings in 2002 according to [two of her employees](#). These same attacks are used to [intimidate victims and witnesses](#) into not going to the police or seeking redress through the law courts. John Watson and his family have been subject to a daily / nightly campaign of the following attacks for 13 years since December 2006. This from the whistleblower.

- 1.** Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.
- 2.** Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.
- 3.** Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.
- 4.** Excruciating muscle pain in the legs like cramps on steroids.
- 5.** Extreme back ache such that one could never get comfortable except when lying down in bed.
- 6.** Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!

- 7.** Targeting my heart was, and still is, a favorite target of West's. These attacks gave me the feeling that a stake was being repeatedly pushed into my heart. 13 years ago when these attacks started this was quite worrying however 13 years later I have learned to ignore these attacks in the knowledge that if Ms. West had been able to kill me she would have done so long ago. Long term effects unknown.
- 8.** The Feb / Mar / Apr 2018 long term attack was against my right ankle. Long story short while I slept the pain built up in my right ankle and when I get up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.
- 9.** While employed in 2017 my right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at my place of work noticed that I was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.
- 10.** A sudden spate of nose bleeds. I never get nose bleeds I do not have high blood pressure and yet in 2017 I suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine I do not scare easily and certainly nose bleeds are not going to ruffle my feathers.

- 11.** One of the attacks Devra West uses regularly is against our digestive systems. Like all the other attacks this variety of violent assault is preceded by a loud hissing. Within minutes whatever we have in our stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating the blandest of food, upon hearing the hissing my wife and I would both know what came next.
- 12.** Another favorite attack of Devra Patton West's, also preceded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.
- 14.** Attack to one or both eyes. This felt like someone was pushing a needle through the eye.
- 15.** Irrespective of what region of the body Devra West is targeting there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake Michelle Fetveit who got into a water dispute with West. I interviewed Michelle in 2007 and sure enough she remarked about being woken up at 3.00 am each morning.
- 16.** Nightmares, screaming banshee sounds, voices in one's head foretelling imminent death. All evidence that Devra Patton West is working with demonic entities who are carrying out her bidding.
- 17.** As with Brazilian counterpart 'John of God' the ability to produce 'supernatural effects and adversely affect electrical appliances, computers etc. via demonic entities acting as proxies for the black magicians.

Armed with an occult weapon that the police and courts do not recognize as a weapon Devra Patton West has been on a criminal rampage for the past 27 years.

This has been the case since declaring herself to be an Ascended Master in 1991 after completing a course of training at the [Robert Jaffe School for Energy Mastery](#) between 1990 & 1991. Devra Patton West and her accomplices are estimated to [have extorted \\$30 to \\$50 million](#) from scores of victims in NM, MT & currently AZ with their 'divine being' scam. So confident are Devra Patton West and her accomplices that they were / are totally beyond the reach of the law, that caution has been thrown to the wind for the past two decades with a veritable conveyor belt of victims drawn from employees, students and business consultants. In March of 2007, Devra Patton West's then office manager, Rebecca West (no relation to Devra West) sent a harrowing email, entitled ['Help Me'](#) to whistleblower John Watson.

The first paragraph of this email makes it very clear that Devra Patton West is not a 'normal' employer but a cult / criminal gang leader, who was breaking state and federal employment laws by insisting new employees join her cult or be fired before the first 90 days is up, after which she would have to pay employment insurance.

Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

After receiving tens of emails from employees and students trapped in West's cult, all of which were afraid of being targeted by West in the manner described above, John Watson, himself a victim of fraud at West's hands, decided to go public and share what he had learned while researching his lawsuit with the press. Accordingly, on July 12 2007 and August 9 2007, stories were published in both the [Whitefish Pilot](#) and the [Bigfork Eagle](#) respectively. Because of all the bad publicity and Devra West's regular appearances in court in respect of two arrest warrants, a conviction for assault, becoming the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest and several appearances as the defendant in mainly fraud related lawsuits, Devra Patton West and the cult decided to move away from Montana to Arizona.

Below are a list of some of the scores of victims of organized crime / racketeering at the hands of Devra Patton West and her cult / gang in Montana.







Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortleby issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.




