

Subject: Rishi Devra: Bio-Wars (Biography Wars) Her Totally Fake 'Life History' Part of a Massive Fraud.

Dear FBI, IRS and Sedona & Scottsdale police departments,

We again, come knocking on your doors to ask that you launch an urgent investigation into Devra Patton West's criminal racketeering cult / gang that has operated in three western states these past 27 years. In this edition of our 'truth' bulletin, we provide you with clear evidence of a massive fraud taking place right now in Arizona, as was the case in Montana and New Mexico before. Short of getting signed confessions from Devra Patton West, and her main accomplices Julio Williams & Geoffrey Reynolds CPA, we do not know how we can improve your chances of successfully prosecuting the above individuals for Racketeering and in Devra Patton West's case, attempted murder. In this week's submission we point out in great detail, with over a hundred data points, how Devra Patton West's biography, as shown on her website under the '[Rishi's History](#),' tab greatly differs from actual reality i.e. the FACTS as recorded by legal documents, newspaper articles and witness statements both written and audio. This is not a case of a few mistakes or someone with a memory problem, this is someone who has totally ignored / hidden the facts and replaced them with a fantasy, a pack of lies a massive fraud. To what end? Well Devra Patton West's real bio / history supplies us with the obvious answer – [fraud](#) and [racketeering](#).

Her fake bio / life story, as it appears on the '[Rishi's History](#),' tab is just one leg of a massive fraud scam. The second leg is that she disguises herself as a religious leader and the 'container' for her crimes as a religious organization. The advantage of doing this is that her lies and propaganda are 'protected' by religious freedom laws. However, when you see the huge disparity between the FACTS and her FAKE 'life story' there can be no other reason for the disparity, other than to deceive as part of a massive fraud scam. The third leg, that gives her many lies and propaganda credibility, are the role of 'liars for hire' Geoffrey Reynolds CPA & Julio Williams MD both being senior members of her cult / criminal gang. Both being complicit in many of her crimes, including the failed attempt to murder the whistleblower John Watson in 2007, and the cover up of Devra Patton West's current campaign of intimidation. The fourth leg of her criminal racketeering business model is a weapon she uses to facilitate theft, fraud and extortion and if necessary, the murder of those victims and witnesses that go public. Knowing full well that legal statute does not regard the occult as a weapon, Devra Patton West is free to ply her criminal trade right under the authorities' noses while holding up her middle finger to the police and the judiciary.

At best, Devra Patton West's fake bio / life history (and her entire website) is part of a massive [Wire and Mail](#) fraud scam. A trap that she has been springing for the past 27 years first in New Mexico, then in Montana and now in Arizona. Most victims, and there are scores if not hundreds, are too afraid to go to the police for fear of being targeted for intimidation or murder. When the public becomes too aware that she is not a guru, and that her 'World Service' propaganda is just a front for organized crime, she moves to another western state; states where they turn a blind eye to 'white collar' crime. Upon arrival, Devra Patton West reincarnates herself with a new name, new fake 'Life Story' and repeats the crimes all over again. The near epic range of her global experiences, from her dedication to planetary prosperity [1], to her life-changing quest for the ageless masters who appeared and disappeared into the mists of the high Himalayas is indeed groundbreaking. As a tireless servant of humanity [2], her largess of global awareness is nothing less than remarkable and her life story [3] even more so. Yet, what is inspiring for many seekers, is that Rishi Devra's homage to the divine has always been balanced by the joys and rigors of raising children and grandchildren, which she heartfully continues today as a spiritually awakened household [4].

With her illumination in full radiance, Devra continued to exemplify a 'feet on the ground' approach, expanding her focus for global awareness to a wide range of scientific and technological fields, as well as global financial systems, planetary sustainability and all aspects of human values. Organizing and attending conferences for world peace and humanitarian governance [5] increased her involvement with international leadership groups, humanitarian projects in regions of conflict, environmental initiatives and international think-tanks [6] which enabled her to gain a wide range of insight on the glaring urgency of contemporary global issues. She founded the Peace Promise Initiative in early 2000, a humanitarian endeavor that sponsored expos and seminars for world peace in the Middle East [7]. Her time spent in regions of conflict enabled her to have a visceral appreciation of the human devastation that came with the ravages of war and famine [8], and its inevitable impact on the entirety of the planetary system, all the while continually immersing ever deeper in the Divine [9]. As the founder of our institute for meditative life mastery, her hands on life approach enables her to be especially sensitive to modern life in its full context of demands, at the same time that she brings a profound eloquence to all that she does [10]. She is as practical in her pragmatic logic, as she is sublime in her divine grace.

Many books could easily be filled to the brim with the range and complexity of her global experiences [11], from her educational work on world peace and prosperity, to her life-changing quest for the ageless masters who appeared and disappeared into the mists of the high Himalayas. 
[1] & [2]. There is zero evidence that Devra Patton West has any interest in anyone's prosperity but her own. She is also tireless servant of her own self-interests at the expense of everyone she comes into contact with.

[3]. Her life story is remarkable in that it is totally fake and created from the imagination of a psychopathic / narcissist, who believes that she can intimidate and if necessary, murder those who challenge her version of reality.

[4]. Spiritually awakened household is a massive joke. 
[5], [6] & [7]. Apart from an old circa 2001 photograph of West gate crashing a peace protest in Israel (where she has offshore bank accounts) for a photo opportunity, there is zero evidence that Devra Patton West attends leadership groups, humanitarian groups in regions of conflicts, let alone international think tanks. The whistleblower, John Watson, set up the Peace Promise Initiative in 2002 that non-profit did not exist in the year 2000.

A review of the [last page of the Bylaws](#) clearly show them being signed and dated [May 03 2002] the Bylaws also show the Secretary of State for Montana's date stamp showing May 15 2002. Note Devra Patton West's signature at the top, and the whistleblower John Watson's, underneath hers. Like all the other initiatives and businesses containers, Devra Patton West gets involved with, they quickly become a total financial disaster as she drains them of all finances to fund her lavish lifestyle. The newspaper article published by the [Bigfork Eagle](#) newspaper in August 2007, shows two of her 'businesses never being registered, two of them being involuntarily dissolved and one involuntarily revoked.



[8]. The only regions of conflict that Devra Patton West has spent any time in is her home and business environment. The second part of the [custody hearing transcript](#) held on July 12 2007, makes it clear that Devra Patton West's home life is a war zone. And her work life is no better. Here are three statements from ex-employees; the first her ex-office manager Rebecca West (no relation) her email is entitled '[Help Me.](#)' The second is from ex-employee Carlida Finch, who overheard Devra Patton West planning to murder Dr. Pat Cole MD if Cole did not hand over \$1.3 million to her. Carlida's [Statement of Fact](#) was part of a submission to the authorities about her unsafe working environment. Finally, there is a statement that Dr. Pat Cole gave the [Whitefish Pilot](#) newspaper in July 2007. Cole stated that Devra Patton West repeatedly beat her over the head with the heel of her shoe until blood ran down her blouse. Then, there is Devra Patton West's attack on her student [Beatrice McGuire](#) that left the victim needing plastic surgery which West paid for. Then, there is the vicious attack on employee [Susannah Felder](#) that left Felder partially scalped. Yes, Devra Patton West knows a lot about 'regions of conflict.' If you believe Devra Patton West's lies, she was immersing herself ever deeper in the divine while, robbing, defrauding, extorting, and beating both employees and students to her unaccredited school for occult studies. While immersing herself in the divine, she picked up an arrest warrant for [criminal check fraud](#) in 2008, was forced to sell all her assets (those not hidden) at a [Sheriff's Sale](#) to make her pay past victims of crime \$2,000,000 in court fines and interest. Also in 2002, the whistleblower John Watson was awarded [judgment](#) against Devra Patton West and [awarded](#) \$776,000 after being defrauded by her in 2002. In 2009, she was the recipient of an arrest warrant for [Felony Theft](#). She was the defendant in several fraud related lawsuits in Montana during this time (see below for details) and all this while immersing herself in the divine!




[10]. The reader can get a sample of that profound eloquence and divine grace by listening to just three excerpts of a 45 minute conversation that Devra Patton West had with the whistleblower in March 2003, after he announced he was going to sue her for defrauding him a lawsuit he won in 2008. **WARNING** - eloquent and divinely graceful self-appointed deity dropping the F bomb more than once. Example 1 ([I feel f*cked up the arse](#)). Example 2 ([You are f*cking over a spiritual teacher for Christ sake](#)). Example 3 ([I'll go so f*cking down and dirty](#)) if Watson sues her for fraud after she admits in the same conversation that she did defraud him but does not see herself writing out a check for the money she owes him!


[11]. Many books could be filled about her criminal racketeering business model that has operated so far in three western states. States that either do not understand white collar crime, or do not have the resources to prosecute it successfully. Devra Patton West would not get away with her crimes in the eastern states; Martha Stewart went to jail for far less.

[12]. Devra Patton West is a dangerous psychopath and suspected serial killer. Point [4] above speaks to the sordid home life; the fact that her son has an [FBI record](#) for forgery, dangerous drugs and motor vehicle offenses is a testimony to West's mothering skills. The apple does not fall far from the tree! As far as grandchildren are concerned, there is evidence that Devra Patton West has targeted both of her son's ex-wives in an attempt to intimidate them into giving up their female infant children to West's son, Chris Haywood. Her campaign of occult 'under the radar' violence succeeded in subverting the custody case involving Haywood's first wife Kendal (she lost her daughter to West's son) but did not succeed a second time against Chris Haywood's second wife Jamie, who [wrote an email](#) about it to the whistleblower. She also mentioned the occult attacks in [her testimony](#) at the custody hearing. [13]. As you can see from the above, Devra Patton West is a tireless servant to lining her own financial nest at the expense of everyone she meets; and why not? The weapon she uses to subdue and silence (intimidate and murder) victims and witnesses is not recognized as a weapon under legal statute, so she has been on a criminal rampage for 27 years with no sign of stopping.



[14]. Coherence of authenticity? What a friggin joke. The woman is a pathological liar as the above shows, but here are four more well documented examples that show that Devra Patton West is a pathological liar. Example 1. On April 17 2006, just days after Devra Patton West had assaulted Dr. Pat Cole MD and days after the police carried out their investigation, Devra Patton West writes to her entire mailing list sending a missive entitled '[The Law of Severity on the Path to Purification.](#)' In this missive that Devra Patton West wants us to believe she channeled from the long dead Ascended Master El Morya, she admitted beating Dr. Cole, she admitted that the assault meted was severe but administered with grace. She went on to assert that as the victim was a Nazi in the WWII death camps (in another lifetime) that the assault was long overdue. Did I say that Devra Patton West is criminally insane? No mention of the \$1.3 million she extorted from Dr. Pat Cole. Example 2. When appearing in court as a witness for her son on July 12 2007, West was asked by counsel if she had assaulted Dr. Cole. [Devra Patton West replies](#) No way no how No! Example 3. While in court, she was asked by her lawyer if her business was a multi-billion dollar enterprise. West replied yes. Three weeks later on August 9 2007, a newspaper article was published by the [Bigfork Eagle](#) newspaper which showed that Devra Patton West had just been evicted from two rental properties in quick succession and had a lien for unpaid employment insurance against her in the amount of \$2,287 and had just bounced a check for deposit on the purchase of a property. Example 3. The [Whitefish Pilot](#) published a news article on July 12 2007, the very same day that Devra Patton West was telling lies at the custody hearing for her son Chris Haywood. The article reveals that Devra Patton West was fraudulently using images of a multimillion dollar lakeside property owned by Robert & Tabby Ivy in both her brochures and on her website. She was doing this in spite of the fact that the real owners had for 2 years been asking her not to do so. Clearly, this is all part of a massive fraud to present herself to the public as something she is not. Example 4. What follows are three excerpts from a conversation the whistleblower, John Watson, had with Devra Patton West in March 2003. She did not realize he was recording the conversation. 1. [The truth does not matter](#) (if I can convince the public that my lies are their truth). 2. [My agreements are worthless](#). 3. [I dispose of people like Kleenex](#). This is about as authentic as it gets where Devra Patton West is concerned!



[15] & [16]. Devra Patton West's criminal business model works on many levels. When operating as Devra Ji in Victor MT, she had the cult constantly fund raising for donations to fund her latest greatest save the planet scheme, when in reality, the money went straight in her pocket. The whistleblower knew this and when he tried to fix the problem she constructively dismissed him which led to his lawsuit. About a year earlier, employee [Susannah Felder](#) caught Devra Patton West stealing \$80,000 from her charity and when she challenged Devra Patton West, she was viciously assaulted and partially scalped. When the whistleblower reported the fraud to the Secretary of State for Montana, he struck her charity off the register by [revoking its status](#). Devra Patton West, losing her source of income, stole the charity's main asset (worth \$1,250,000 in 2002) and put it in a personal trust fund for herself and her eldest son, Rob Meador. In 2008, a judge forced the breakup of the trust to make Devra Patton West sell those assets at a [Sheriff's Sale](#) to force her to pay her creditors \$2,000,000 in court fines and interest. In addition to the property that she stole from the charity, \$4,000,000 (as valued in 2002) worth of art work and valuables were stolen and hidden in a lock up for 10 years until the statute of limitations on theft expired. In 2009, while being deposed by the whistleblower's lawyer, Devra Patton West was questioned about these items. In her [statement](#), taken under oath, Devra Patton West denies knowing the whereabouts of these items, acknowledges that they did exist but suggests they were stolen or hauled off. She further stated that she had given up all physical possessions. In 2014, items exactly matching the items presented to West [on a list](#) in 2009, suddenly appeared at [auction](#) and for sale from her website. Today, these items can be seen on her website under the [art gallery](#) tab.

If you have come this far, you will have realized that Devra Patton West is not a guru but an occult predator, who has operated a cult / criminal racketeering gang right under the authorities' noses for the past 27 years since 1991. Armed with an occult weapon (not acknowledged as a weapon under legal statute) Devra Patton West has robbed, defrauded and extorted tens of millions of dollars. Using the same occult (hidden) weapon, she has intimidated both victims and witnesses into not going to the police or seeking restitution through the courts. Those that do go public are deemed to be a serious threat to her criminal business model, are murdered, with the victim's deaths appearing to be caused naturally. To give an indication at how blasé Devra Patton West is about murder, she had asshole Geoffrey Reynolds announce the whistleblower's impending murder to the press in 2007.

The Ascended Master 'Rishi Devra' is the third iteration of Devra Patton West's guru / cult / extortion business model since 1995. A combination of negative press, her regular visits to court (as the defendant in fraud related lawsuits) and the whistleblower's website (revealing her past criminal activities) made it impossible for her to operate in Montana. However, before she could reincarnate in Arizona post 2010 as 'Rishi Devra' she needed to silence the whistleblower John Watson, and bring down his websites; otherwise, no one would believe the bullshit and lies on her website depicting her as a 'divine being.' What follows is a TRUE biography of Devra Patton West's activities in Montana between 1995 & 2010. This biography is based on newspaper articles, legal documents and witness / victim statements in other words it is FACTUALLY accurate.

The Ascended Master Devra Ji (1995 to 2005).

Not much is known about Devra Patton West's reign of terror between her being forced to leave New Mexico in 1995 and the year 2000. Dr. Pat Cole MD, one of Devra Patton West's extortion (\$1.3 million) apparently did have records that indicated dozens of incidences of abuses dating back to Devra Patton West's time in New Mexico. A [statement](#) from Rebecca West (no relation to Devra Patton West) that was sent to the Flathead Police refers to these records. In May 2004, AJ White, ex-board member of Devra Patton West's charity 'The Circle of Divine Unity Foundation,' provided the whistleblower John Watson with a statement to be used in his fraud lawsuit against Devra Patton West. AJ White refers to the period of time starting from the fall of the year 2000. Notable points from her statement are Devra Patton West's draining of the charity's finances which mainly arose from public cash donations. Also mentioned was the theft of an \$80,000 cash donation by Devra Patton West to pay for her son's legal fees of custody court hearings he was attending in respect of an infant daughter from his first marriage. This [bulletin](#) and this [bulletin](#) touches upon this matter, as not only Devra Patton West stealing money from her charity to fund his legal fees, she was also targeting his estranged wife Kendall, daily / nightly with occult 'under the radar' violence designed to make her physically and mentally ill. In the end, the attacks worked and West's porn loving, wife beating son, Chris Haywood, with an FBI record for forgery, substance abuse and traffic violations, got custody from a beautiful, innocent young mother. The West crime family tried the same strategy on Haywood's second wife Jamie when that marriage broke down, however on this occasion it did not work. Court [transcript](#) and Jamie's [email](#) to John Watson attest to her being a victim of occult attacks by Devra Patton West. Did I say that this woman is criminally insane?

John Watson, like many before and since, was recruited as a business consultant after attending one of Jack West's meditation meetings in November 2001. In January 2002, in exchange for the promise of pay and shares, he started work on a 6 month project to setup multiple non-profit corporations and a single for-profit corporation named Millennia Mind. Upon completion of the work in July 2002, Devra Patton West announced that she had spoken to God the night before, who had told her that shares were a thing of the past and so he was not getting the shares promised nor was he going to get paid. Given the ease and comfort with which West announced this, Watson came to the conclusion (rightly) that Devra Patton West had done this many times before (and since as it turned out). Long story short, Devra Patton West, while writing to the cult saying there were no agreements between her and Watson, wrote to her lawyer [Tabarrachi](#) asking him to recover all documents (proving that there was business relationship). In addition to a mountain of documentary evidence, such as [Jack West's](#) letter to the INS showing Watson was a paid employee, Millennia Mind [guarantee](#) note signed by both shareholders and a mockup of stationery and [business cards](#), there was a 45 minute conversation that the whistleblower recorded.

During that conversation, Devra Patton West admitted she had defrauded Watson but did not see herself writing out a check for what she owed him. In 2008, after Watson was granted judgment by the courts, Devra Patton West published the following statement of denial on her website.

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Did I say that Devra Patton West is a pathological liar? In January 2004, and as a direct result of a report that John Watson sent to the Secretary of State for Montana laying out the details of the massive fraud being perpetrated by Devra Patton West and her husband Jack West, 'The Circle of Divine Unity Foundation' (charity) was removed from the Montana registry of charities. Go here to see the [Revocation Certificate](#). Part of the massive fraud being perpetrated by Devra & Jack West revolved around how the charity made its income. The income came from two main sources (1.) cash donations from the public and (2.) the fees charged to students attending Devra Patton West's unaccredited school for occult studies then called the Sacred Arts Institute (SAI). As alluded to in ex-charity board members [AJ White's](#) statement, Devra Patton West had set up an elaborate fraud designed (a.) to keep the charity starved of cash and (b.) when it became time to crash / bankrupt the charity, a series of fake loans in place which would allow Devra Patton West to claim the charity's assets in lieu of the fake loans, amounting to millions.

When the charity got struck off, Devra Patton West crashed / bankrupted the charity by taking over the charity's main asset, a [property on 20 acres worth \\$1,250,000](#) as valued in 2002, in lieu of the fake loans she had put in place for just such an eventuality. The second thing she did was to steal \$4,000,000, as valued in 2002, worth of artwork and valuables and hide them in a lock up for ten years until after the statute of limitations on theft had expired. When questioned about these items in court on October 2009, and showed [a list](#) that had been prepared by the whistleblower in 2002, West denied any knowledge of them, said they were lost or stolen or hauled away. Today, after holding an auction and trying to sell some on-line as part of an '[art moving sale](#)' much of this stolen artwork and valuables, which like the charities property was largely paid for by public donations, can be seen via her '[art gallery](#)' tab on her website.

After her charity was struck off and the charity's assets stolen, put in a personal trust fund or hidden away in a 'lock up' for a decade, Devra Patton West's compound in Victor MT was finished. Instead of announcing that she was near to bankruptcy for the second time instead she wrote to her disciples / students announcing that the pain and concern she was feeling was entirely down to her shift from the [fifth dimension to the seventh dimension](#). She further announced that a new location was being prepared for her by the Masters called Shamballa, and that this location was of a higher vibration to match her ascension to the seventh dimension. And for this reason, she could only take those disciples who were prepared to [devote 66% of their net worth](#) to her. When the move to Shamballa occurred, it transpired that Shamballa was located a mere 100 miles north from Victor Mt to Flathead MT!

At about this time in 2005, Devra Patton West's troubles were to get a lot worse. In an act of what can only be described as 'Karma' Devra Patton West was allegedly defrauded out of \$650,000 by two other fraudsters, Wilson & Ross, who must have been brilliant to be able to hoodwink an Ascended Master. The fraud, [according to court documents](#), occurred in September 2005. Now really desperate for money, Devra Patton West set about 'harvesting' the members of her cult who had been both brainwashed and conditioned into submitting to her will and given examples of how ruthless she could be from overt violence as administered to [Susannah Felder](#) and [Beatrice McGuire](#) to covert violence in the form of murder (using her occult weapon). The following incidents happened in quick succession in 2005. Student [Dave Kushner](#) was defrauded out of \$30,000. Student [Marion Cantwell](#) was kidnapped, held captive (falsely imprisoned), beaten and only released after agreeing to give up tens of thousands of dollars from the sale of her own home. Witness to both of the previous incidents, senior student Lisa Swidler, and the go between who negotiated the two week bridging loan from Kushner, tried to leave the cult and died suddenly under mysterious circumstances. Lisa was a friend to the whistleblower and his wife, and they are both convinced that Lisa was murdered by Devra Patton West to keep her from sharing the location of some of the skeletons Devra Patton West had buried previously.

Watson turns whistleblower in 2006 and in 2007 his impending murder is announced to the press by senior cult member Geoffrey Reynolds CPA. When the murder plot fails, Reynolds joins West in a 2010 conspiracy to bankrupt Watson.

Did I say that this woman sits at the head of a [murderous](#) criminal racketeering gang? To ram the point home that Devra Patton West is not some misunderstood guru, here are some more FACTS to consider from around this time. When the charity was struck off, Devra Patton West moved \$200,000 out of the charity's bank account and put it in the personal trust fund she had set up for herself. Unfortunately, there was not any money in the charity's bank account. However, there was a \$200,000 overdraft facility which was guaranteed by Mike Hendrickson, one of Devra Patton West's wealthy students. Mike and Lori Hendrickson get a mention in the [Whitefish Pilot](#) newspaper article as considering legal action against Devra Patton West; they never pursued that and instead walked away empty handed fearing they would be made ill, injured, maimed or murdered by Devra Patton West. Ex-student [Elaine](#) talks about Devra Patton West avoiding bank accounts and storing her wealth in jewels. Ex-student [Judy Morris](#) talks about Devra Patton West's European students being told to mortgage their homes, as the more money they give to Devra Patton West, the closer to God they would be. [Barbara Costantino](#), Devra Patton West's personal secretary for four years, talks about how after employees or students have been robbed, cheated, defrauded or beaten, Devra Patton West always invents a totally fake reason for their departure to eschew responsibility. Student [Debra Coffey](#) bravely divulges how Devra Patton West orchestrates the members of her cult to target one victim to receive degrading abuse, both mental and physical, as a way of 'breaking' the target's personality, with the aim of making the target an obedient member of her cult. Debra also speaks to the assault on Beatrice McGuire and how Devra Patton West often shifts blame for the violence she metes out to others, as coming from God. Above: Devra Patton West's well-oiled criminal business model. Set up an unaccredited school for occult studies and offer nonexistent jobs to employees. Brainwash and condition both groups in to 'submitting' to her will, then convert them into cash directly or as unpaid slaves before expelling them from the cult. Those that go public are intimidated or murdered.

An [ex-student](#) who wished to remain anonymous to protect herself, claimed that Devra Patton West's mental health was deteriorating. She also claimed that Devra Patton West started to put PhD & D. D. after her name and when asked about this, was told that the Christ awarded her these doctorates in person. Two statements from Devra Patton West's ex-housekeeper, Tanya Hurley ([1](#)) & ([2](#)) speak to the fact that Devra Patton West is mentally ill. The Ascended Master Surya Ma (2005 to 2010)

After moving 100 miles north to Shamballa (Flathead MT) and still desperate for cash to fund her luxurious lifestyle, Devra Patton West set about extorting the entire net worth of one of her more wealthy students Dr. Pat Cole MD. Cole was one of the 'disciples' that had promised 66% of her net worth to Devra Patton West's good causes (herself) but was slow to hand over the cash. The campaign of overt and covert violence directed at Cole to loosen the purse strings, came to a head in April 2006, when Devra Patton West repeatedly beat Cole over the head with the heel of her shoe until blood ran down Cole's blouse. This incident is well covered in two newspaper articles published in the [Whitefish Pilot](#) & the [Bigfork Eagle](#) which appeared on July 12 2007 & August 9 2007 consecutively. Additionally, [a series of emails](#) from Cole's friend Rebecca West (no relation to Devra West) makes it clear that the campaign of violence directed at Cole by Devra Patton West was just a small part of a massive crime wave being committed by Devra Patton West against her employees. A statement to the labor board from ex-employee [Carlida Finch](#) attests to the dangerous working environment as does and email from ex-employee [John Mark Young](#) to the Flathead police.

The following excerpt from a harrowing email from Rebecca West in March of 2007, makes it clear that Devra Patton West had a revolving door policy to employees (and students) where they either submitted to her will (become brainwashed and conditioned) or they were fired before the 90 day period ended after which West would have to pay employment insurance. Here is an excerpt from that email.

Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller [Geoffrey Reynolds CPA] last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

I have written her a letter that I have been hesitant on sending her, as I know it will create **a wave of violent behavior** and I have little to protect myself. My only safety net per law enforcement is to write a "Letter of No Contact" and mail it. If she stalks me, and I have this letter in hand, law enforcement will respond and then maybe the Judge will order a "no stalking order" against her! **I have been hiding in my home for many days now, afraid to go anywhere.**


Further down in this missive she states....

I will not return and subject myself to **her violent and abusive behavior!** I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. **I need support in how to deal with her shamanic witchcraft.** Can you tell me more?

When giving an interview to the Whitefish Pilot newspaper on July 12 2007, West stated and I quote,


West claims to have been trained in **shamanic visioning** and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be **down on your knees crying like a friggin' baby,**" West said.

It is clear that Devra Patton West is terrorizing her Shamballa employees every bit as much as she did to her employees in Victor MT. It is clear that she admits to being trained in Shamanic Visioning (at the Robert Jaffe School for Energy Mastery between 1990 & 1991) and it is clear that she is using that occult knowledge in an attempt to silence both victims and witnesses of crimes she has committed. Introducing Geoffrey Reynolds CPA.




Above Geoffrey Reynolds CPA joined the cult in September 2006, and after being duped into loaning his life savings of \$300,000 to Devra Patton West, became her puppet with West pulling his strings. He quickly excelled himself by money laundering the proceeds of crime through West's business as normal receipts and was complicit in Devra Patton West's plot to murder the whistleblower John Watson. His most memorable quote was, "Rishi Devra has been guiding my life for many years."

Devra Patton West hired Reynolds in September 2006, after his predecessor [resigned](#) rather than be forced to [manufacture fake invoices](#) so that his employer / cult / gang leader could money launder the proceeds of crime through her 'business.' 


