Dear Sir / Madam,

Re: Complaint against Dr. Julio Enrique Williams MD.

I am obliged to make a further complaint against Dr. Julio E Williams MD, in part because the leader of the cult he has been a member of for 20 years, Devra Patton West, continues her campaign of intimidation against me and my family in the hope that I will not be a witness at her trial. I have in previous campaigns provided you with ample evidence of Dr. Julio Williams' involvement with organized crime and you have chosen to ignore that evidence either believing Dr. Williams, who is a prolific liar, or choosing to wait until Dr. Williams is prosecuted for his crimes by the appropriate authorities. While a successful prosecution against Dr. Williams must follow (based on the mountain of evidence against him and the leader of his criminal racketeering gang) I feel that the evidence I am going to provide to you in this complaint may force you to act against him.

Put simply, Dr. Julio E Williams MD has and is promoting a lay person (Patton West), a member of the public, a known and proven con artist as being able to deliver miracle cures for large sums of money.

Indeed there is evidence that the leader of Williams' cult / criminal gang, Patton West, was charging \$500,000 for such cures in 2002. I know this to be true because I was her business manager then, prior to being defrauded by her. I know this to be true because two of her personal staff gave statements to me that they heard her discuss this matter on the phone, receive the funds from a 'patient' and then subsequently go on a spending binge with those funds. I was one of scores of victims of theft, fraud, extortion and mental and physical abuse which is well documented by the press and law courts.

So without further ado, let me provide you with a timeline and documentary evidence (much of it from Dr. Julio Williams himself) which overwhelmingly supports my assumption that Dr. Williams was, and still is, a senior member of a cult / criminal racketeering gang led by the con artist and violent convicted criminal Devra Patton West. What follows is the evidence to back up my claims that in contravention of all regulatory norms, Dr. Williams is funding and actively marketing Patton West as capable of delivering 'divine grace healings' (miracle cures) to cancer patients who are able to afford her six figure price for a 'cure.'

1. First of all, let me establish a timeline for Dr. Williams' involvement with Patton West's cult / criminal gang. Below here is an excerpt from a statement Dr. J Williams published on Patton West's website in 2007.

It was in the fall of 2000 when I first came into contact with Dr. Devra West, whom we graciously and fondly call "Surya Ma" (a name reflecting high honors on the spiritual path) during a transformational training at her retreat center in Montana. I quickly came to recognize that she is one of her kind among the few contemporary illumine minds here in the west. She is a modern day pioneer and visionary who lives her life as an example in service for the greater good of humanity. It was as if I had been ignited to see and know and experience at all new levels of possibility, and as a physician, I felt privileged to receive the gold that her teachings have to offer. And I have been inspired to pass on to society at large, the tools that have empowered me to engage the philanthropic spirit in service to humanity and more over into my medical practice. She is a Master Healer because she is a Master Soul. Her very presence is a healing presence. Because she heals from a greatness of heart, she has opened my sight to my own greater capabilities as a human being.

I am delighted and honored to further her work in all ways possible and for the opportunity to serve as board member of the Global Guardianship Initiative and look forward to becoming a dynamic force in the implementation of the different projects on a long-term basis.

2. After I was defrauded by Patton West in 2002 and announced my intention to sue her in 2003, Patton West mounted a campaign of 'dirty tricks' against me in an attempt to intimidate me into dropping my fraud lawsuit against her. A lawsuit I won in 2008. One of the dirty tricks was to manipulate three perfect strangers into publicly defaming me from her website. Accordingly in 2005, she got three physicians (all recruited into her cult for the latest get rich quick scheme) to publish a defamatory statement against me from her website. The three physicians were Dr. Cornell, Dr. Cole and Dr. Julio E Williams MD. You can read the entire statement by going [here](#). Below here is a short excerpt of a statement Dr. Julio Williams made.

I, Julio Williams MD have also been a long time student of Surya Ma and I stake my honor and credibility on defending her personal integrity and establishing the truth. I am proud to serve on the Board of Directors of the Global Guardianship Initiative.

Note two things from this statement. The first is that Dr. Williams MD stakes his honor and credibility on defending her (Patton West's) personal integrity and establishing the truth. Patton West between 2007 & 2008 alone was the subject of two arrest warrants (one for [criminal check fraud](#) and one for [felony theft](#)) and was [convicted for assaulting](#) Dr. Pat Cole MD (newspaper article announces her conviction). Additionally, Patton West was forced to sell all her assets at a [Sheriff's Sale](#) to pay past victims of crime \$2,000,000 in court fines and interest and was the defendant in several fraud related lawsuits including my own ([judgment](#) and [award](#)).

The second point to note from Dr. Williams' statement is that he says he is proud to serve as a board director of Patton West's Global Guardianship Initiative. As the [Bigfork Eagle](#) newspaper article published in August 2007 was to point out, the 'Global Guardianship Initiative' was involuntarily dissolved as were several other of her criminal business 'containers.' This included the charity, The Circle of Divine Unity, which was [struck off](#) the Montana charity register for fraud.

Shortly after this statement was posted in 2005, Dr. Cornell realizing she was part of a criminal organization left. In 2006 Dr. Pat Cole MD became the victim of a vicious assault by Patton West. Fourteen years later, Dr. Julio Williams remains a senior member of Patton West's cult / criminal racketeering gang.

3. In January 2007, fearing that I was going to win my lawsuit against the leader of his cult, Julio Williams MD sent me a lengthy email whose obvious intention was to intimidate me into dropping my lawsuit against Patton West. If what you are after is money (and /or the Victor property) it is going to take a lot of your own personal money to try and get it. **I have personally allocated Two million dollars for Dr. West defense and legal expenses.**

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. **You fuck with me and you will meet your match.**

If this does not implicate Dr. Julio Williams as a member of Patton West's cult / criminal gang, I would like to hear your explanations as to why a total stranger to me would risk being jailed for 'witness tampering' and why a total stranger to me would offer up \$2,000,000 of his personal fortune to fund Patton West's legal fees in a lawsuit I brought against her. Which I won in 2008.

4. A month before the [Bigfork Eagle](#) newspaper article was published on August 9 2007, the [Whitefish Pilot](#) newspaper published their own story on July 12 2007 about the crimes being committed by Patton West and her cult and by extension Dr. Julio Williams MD. The paper led with the story of Patton West's vicious assault on Dr. Pat Cole MD while in the process of extorting her entire net worth amounting to \$1.3 million. However, there was a statement made by Patton West, while being interviewed by the paper, that is central to my complaint against Dr. Julio Williams MD. Here is an excerpt from the interview that Patton West gave to the Whitefish Pilot newspaper on July 12 2007.

An author and speaker, West claims she recognized her clairvoyant and healing gifts at age six when she began "interacting and communicating with archangel Michael," according to her book "The Christ Heart." West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives.

She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.

So, we have Patton West claiming to be able to “heal” people with cancer. She also states that she plans to teach cardiologists and other physicians. This statement is totally in-line with the fact that in 2005 she had three physicians associated with her. However, by the time she gave this interview, the only physician left out of the three she recruited was Dr. Julio Williams MD and it is no coincidence that Dr. Julio Williams MD is a cardiologist!

5. After the three very negative newspaper articles were published by the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) newspapers and after multiple appearances in court by Patton West as the defendant in fraud related lawsuits Patton West’s criminal business model, whose center piece was her claim to being a ‘divine’ being, was dead in Montana.

The above header depicting Patton West with her hand out is from a propaganda piece (1) that she posted on her Facebook pages in June of 2018. Below that on the left is a small image of the full posting which you can review full size by [going here](#). I have numbered five idiotic statements that Patton West made in this propaganda piece which are as follows:-

1. As the light that stands behind leaders and world servers from across the globe.
2. She has been prepared for thousands of years to guide humanity through the coming times....
3. As a planetary regent.
4. A conveyor of holiness and spiritual initiation.
5. As an instrument of mercy she offers the phenomena of 'divine grace healing' and the 'karmic resolution' of divine dispensation.

The one I want to bring to your attention is item (5.) **"As an instrument of mercy she offers the phenomena of 'divine grace healing' and the 'karmic resolution' of divine dispensation."** i.e. her claim to be able to deliver 'divine grace healings' (miracle cures) as well as dispense with karma – for a price!

Why is someone like Dr. Julio Williams MD even associated with a con artist like Patton West? If nothing else, it shows a complete lack of judgment and discernment. A con artist who claims include, that she is single handedly holding open the gates of time, was given her two fake doctorates by the Christ in person, is a self-proclaimed planetary regent, has been preparing for thousands of years to lead humanity, is the light that stands behind leaders and world servers across the globe and, in spite of the two arrest warrants in Montana, a conviction for assault in Montana, being forced to sell her assets to pay past victims of crime \$2,000,000 in court fines and interest, claims to be a "conveyor of holiness and spiritual initiation."

Why is an apparently well-educated professional person like Dr. Julio E Williams associated with an obvious con artist like Patton West?

After a failed murder plot on my life by Patton West and another cult member [Geoffrey Reynolds CPA](#), Williams did make available \$2,000,000 of his own money so that Patton West could fund multiple frivolous lawsuits against me which resulted in my websites being forced down in 2010. The image (above left) was copied from Patton West's Facebook page in 2018. The two idiotic testimonials given by Dr. Julio Williams, that appeared on her website at the time, were added by me. Now I pose the question. Given that these 'Sacred Sundays with Rishi' were actually hosted at a property owned or rented at the time by Dr. Julio Williams MD does one think that Dr. Julio Williams MD was present at the time? Or does one think that Dr. Julio Williams MD vacated the property while the con artist leader of his cult interviewed wealthy cancer patients during 'private sessions' at which she offered cures for six figure sums? Of course Dr. Williams was present what is the point of having a brain washed and conditioned physician and a heart surgeon if she does not use him to market / sell her as someone capable of delivering a miracle cure. Is this legal?

Do you think it is a coincidence that Williams and two other physicians were recruited in the early 2,000's for purposes that Patton West made perfectly clear in an interview she gave to the Whitefish Pilot newspaper in July 2007? Let me remind you what she said.

In addition, Dr. Williams continues to throw caution and his career to the winds by continuing to post what can only be described as idiotic testimonials on her Facebook page with the obvious intention of using his perceived respectability to lure wealthy cancer patients into meeting Patton West. I repeat, I was Patton West's business manager in 2002 and I know what she was charging then for her miracles. Neither Julio Williams or Patton West are saying that the information on this new [website](#) is false only that Patton West has an injunction that forbids Watson from sharing the truth with the public! If one goes to Patton West's website by following [this link](#) you'll see a tab entitled 'LEGAL UPDATE.' This like the rest of the content on Patton West's website is a total pack of lies however this particular pack of lies is published by Dr. Julio Williams MD (see below here) who signs off as a 'Board Director' of the Omni Institute of Divine Sciences. This is a total repeat of his status as a 'Board Director' of the Global Guardianship Initiative as mentioned in item (2.) above. You may recall that the 'Global Guardianship Initiative' was the 'container' used by Patton West's criminal business model in 2007.

Dr. Julio E Williams MD allows his perceived reputation as a physician and a thoracic surgeon to be shamelessly used by con artist Patton West to promote herself in the public's eyes as a 'divine' being capable of delivering miracles. Finally, my previous complaints have been ignored / dismissed leaving me with the feeling that self-regulated bodies like the Medical profession exist to protect rogue and corrupt physicians like Dr. Julio Williams MD from the public instead of protecting the public from crooks like Dr. Julio Williams MD. What I have not told you is that both I and my family remain the target of intimidation at the hands of Patton West – the person that Dr. Julio Williams wants us all to believe is a divine being capable of dispensing miracles (to the wealthy).

Over the past 3 to 4 years I have sent some 400 emails to Dr. Julio Williams complaining about this ongoing campaign of intimidation. Perhaps you should ask Dr. Julio Williams MD why he has not passed these emails on to the police or the authorities. The obvious answer is that Williams is up to his eyes in the cult's crimes, as his own written documents show. If it helps, I can provide you with samples of or all of the emails I have sent Dr. Julio Williams.
