

Dear FBI, IRS and Sedona & Scottsdale Police Dept.

We write again to ask you to launch a criminal investigation into Devra Patton West's cult / criminal racketeering business model which has now operated over the past 28 years in three western states. Ms. West has previously operated in New Mexico, Montana and for the past 8 years or so Arizona. She seems to know that western states either do not understand 'white collar' crime, or do not have the resources to prosecute it. So after committing crime on an industrial basis and overstaying her welcome in one state, she simply moves onto the next and reincarnates herself with a new name, new fake identity and ever more outrageous claims to divinity. Apparently, she is currently calling herself the 'Regent of the Spiritual Hierarchy of the Western Hemisphere' and, being an 'instrument of mercy' she is able to offer the phenomena of divine grace healings to those cancer patients who can afford to pay the six figure sums she asks for her miracle cures.

Dr. Julio E Williams MD, a 20 year member of her cult, is on hand to affirm her ability to deliver these miracles and has even has made his home available as a venue for what is obviously a massive fraud.

We know it is fraud because we had a man on the 'inside' and when that man on the inside was himself defrauded and went public as a whistleblower, Patton West, aided and abetted by Williams and senior cult member Geoffrey Reynolds CPA, conspired with Patton West to murder that individual. When the murder plot failed, all three conspired to bankrupt the whistle-blower, with Dr. Julio Williams putting up \$2,000,000 of his own money to fund multiple frivolous lawsuits by Patton West & Reynolds.


Patton West's criminal business model is predicated on lies and propaganda that portrays her as a 'divine being' who has been preparing to lead humanity for thousands of years. Any whiff of the truth getting out, and mention of scandal threatens the multi-million dollar a year cash flow. Which is why the whistleblower had to die and why Lisa Swidler was murdered by Patton West when she attempted to leave the cult with evidence of Patton West's criminality.

For the last 13 years, the whistleblower and his family have been subject to a campaign of violence directed by Patton West. Dr. Julio E Williams, her main accomplice, has received 400 plus emails from the victim over the past 4 years complaining about it. The reason Williams has not gone to the authorities is because to do so would implicate himself, Reynolds and Patton West in murder and racketeering. We estimate that Patton West has netted between \$30 to \$50 million dollars, with most of it going offshore or converted into precious stones / precious metals. If murder is of no interest to you, perhaps the \$30 to \$50 million will be?

Why a Criminal Investigation into Julio Williams MD & Geoffrey Reynolds CPA is the Key to Bringing Criminally Insane Narcissist Devra Patton West to Justice for Racketeering & Murder.



Williams is a brainwashed member of Patton West's cult and Reynolds is a mercenary.

Before delving into the important role that Williams and Reynolds have played in two of Patton West's most serious crimes I would first like to:-

1. Share a brief history of how Patton West, a pot growing, drug dealing, ex-bankrupt and con artist elevated herself to the status of Regent of the Spiritual Hierarchy of the Western Hemisphere.
2. Prove that Patton West is either criminally insane or so confident of her ability to avoid prosecution that she does not care who knows that she is a dangerous psychopath and a pathological liar. In fact, Patton West often boasts that she does not care who knows the truth because the public can be persuaded [to swallow her lies and propaganda](#) as the truth.

BRIEF HISTORY. Prior to 1990, Patton West would pick off individual victims one at a time like [Jeremy Samuelson](#) (defrauded out of \$10,000) or [Satya](#) (defrauded out of \$6,000). Since acquiring occult (hidden) knowledge between 1990 & 1991 at the [Robert Jaffe School for Energy Mastery](#), Devra Patton West has been at the head of a criminal racketeering business model, guilty of crime on an industrial basis with 90% of the victims being members of her own cult. Since 1991, Patton West has operated in three western states NM, MT & AZ and has changed her identity 4 times. In recent times, she has used 8 different corporate 'containers' from which to operate her cult / criminal racketeering business model, the latest being [the Omni Awakening](#). View the 2007 [Bigfork Eagle](#) news article for the names of seven other corporate identities; some of which were involuntarily revoked or dissolved.



The cult is largely populated by spiritual seekers who, believing they need an external teacher, walk into the trap set by fake guru Devra Patton West. The rest of the numbers are comprised of employees who responded to fake 'career opportunities.' After the new arrivals have been brainwashed and conditioned, all too late they realized that they have been inducted into a cult where they are corralled as a financial 'resource' to be harvested by Devra Patton West as and when she chooses.

CRIMINALLY INSANE OR A COLD BLOODED KILLER? I will share three examples, that to my mind, indicate that Patton West may be criminally insane.

1. Beatrice McGuire – Viciously Assaulted.

In early 2002, while attending a seminar in Montreal Canada with scores of her Canadian and US students in attendance, Patton West viciously assaulted Beatrice McGuire. Apparently, Beatrice called Patton West out in an obvious lie in front of 50 to 60 of her students. Patton West, then calling herself the Ascended Master Devra Ji, reacted by ripping part of Beatrice's ear away with the result that Beatrice needed plastic surgery to repair the damage. This is how one of the other students, Debra Coffey, witnessed the event.

I witnessed three occasions in which Ms. West violently pulled the hair, of three female staff members. In each case the hair was pulled and the head was shaken forcefully from side to side. On some occasions she would hit people in the face. I witnessed one occasion in which she hit a man in the forehead, leaving an abrasion where her ring cut the skin. She said afterwards, that she didn't do it, God or a deity of God did it. This was the rationale she often used to justify her own violence. I was present in Montreal in which Ms. West tore a woman's ear. The woman was kneeling in front of Ms. West and had quietly challenged her authority. Ms. West reacted physically. She grabbed her hair on both sides of her face and shook her and told her to leave. I learned later that the woman was injured. Evidently the woman's ear had been grabbed too and then torn. She underwent reconstructive surgery for the injury. I was present in the room on two different occasions (but did not witness the precise moment) in which Ms. West hit students in the face. One of those women reportedly suffered a dislocated jaw, the other was hurt but not injured.

After receiving a letter from Beatrice McGuire's lawyer, Patton West agreed to pay for the victim's medical expenses.

In a letter she sent to the victim, Patton West stated that her recollection of events was different from that of the victim's but agreed to pay. You can read Patton West's correspondence in full by going [here](#). Below is an excerpt from that correspondence.

*"While I cannot share in many of your perceptions and assumptions, I do share in your pain as a human being and the trauma that has been so difficult for you. **While I witnessed and experienced something very different in nature than what you expressed,** I wish to take full responsibility for any and all problems that take place in the domain of my retreats and classes."*

In her correspondence, Patton West appears to deny that she had assaulted Beatrice (in spite of their being 50 to 60 witnesses) but in an attempt to take the 'moral high ground' agrees to pay for Beatrice's medical treatment anyway! In March of 2003, the whistleblower John Watson, in a private meeting with Patton West that resulted in the whistleblower suing Patton West for fraud, quizzed her about her assault of Beatrice McGuire (in front of 50 to 60 witnesses). Patton West's response was to deny she had assaulted Beatrice McGuire and to insist that Beatrice was mentally ill! Below is an excerpt from that conversation which the whistleblower recorded with a hidden digital tape recorder.

[Patton West denies assaulting Beatrice McGuire and accuses the Victim of being mentally ill.](#)

As you will see from the next example, it is Patton West who is mentally ill / criminally insane.

2. DR. PAT COLE MD – VICIOUSLY ASSAULTED ON MULTIPLE OCCASIONS, LINED UP TO BE MURDERED & \$1.3 MILLION EXTORTED FROM HER.

After Patton West defrauded the whistleblower John Watson in 2002, he a) launched a fraud lawsuits and b) shared what he had learned with the authorities about Patton West's cult / criminal racketeering business model. As a result, in January 2004, Patton West's charity 'The Circle of Divine Unity,' was struck off for fraud. Immediately after this occurred, Patton West decided to steal millions of dollars of assets from the charity that had been largely paid for with public donations. The biggest single asset, a property on 20 acres in Victor MT valued at \$1,250,000 in 2002, was passed into a trust fund for Patton West and her eldest son, Rob Meador. Similarly, artwork and valuables belonging to the charity valued at \$4,000,000 in 2002, were secreted away and hidden in a lock up for ten years until after the statute of limitations on theft had passed. The main reason for hiding these assets was to protect them from the courts, as in addition to defrauding the whistleblower, Patton West had other victims of fraud who had successfully prosecuted her. In 2008, a judge 'broke' open the trust fund and the property (belonging to the charity) was sold at [a Sheriff's Sale](#) to pay past victims of crimes \$2,000,000 in court fines and interest. It is unclear whether the victims of fraud actually received 100 cents on the dollar or less. Had they known that Patton West had hidden millions of dollars of assets (stolen from the charity) in a lock up, they might have fared better.

Having vacated the Victor MT property and having hidden millions of dollars of assets away in a lock up, Patton West was a) short of cash and b) having to move to another location. Knowing that most of her cult would swallow her lies as truth, Patton West wrote to her mailing list stating that the pain she was feeling had nothing to do with her legal troubles but rather, due to the fact that she was [passing from the fifth dimension to the seventh](#). She went on to say that because of her Ascension to a higher level of divinity, that she would need to move to an area with more rarefied vibrations. She stated that a new ashram had been prepared for her by the Masters called Shamballa and that, because of the rarefied vibrations she could only take with her 12 disciples and only those who would [commit 66% of their net worth](#) to her good causes (herself). Dr. Pat Cole MD was one of the 12 disciples that made the cut and was allowed to move 100 miles north to Shamballa! In effect, they had all moved from Victor MT to Kalispell MT.

Unfortunately for Dr. Cole MD, she was a bit slow in handing over 66% of her net worth to Patton West, who tired of waiting, conspired to extort Cole's entire net worth estimated at \$1.3 million. This was achieved with the help of other members of the cult, who joined in a campaign of mental and physical abuse orchestrated by Patton West against the victim, Dr. Cole MD.

This kind of conspiracy was used regularly by Patton West, either to rob victims of their money or to break their will as a prelude to becoming low paid or no paid slaves. Below is how one student, Debra Coffey, described the process she was forced to participate in.

I was personally involved, as were others, in what I will call public humiliation or degradation rituals. The pattern of dominance, humiliation and "bonding" was essentially the same in all cases. In my case, I had just moved to Montana two days prior to the incident to build a life among the other members of the group and contribute to the goals of the organization. That day, and for the first time, I became the focus of degradation. My apparent flaws and failings were paraded by Ms. West in front of the group. It was personally shocking and humiliating. She continued until I was sufficiently disorientated. Then at a strategic moment, she began to build me back up. Because I had nothing left of myself to stand on, I connected to her to make it through. In this way a false bonding to her, the teacher/leader occurred. She said afterward to me that she did it with love. She often said this to people whom she abused. I witnessed many of these kinds of "treatments".

Another witness, employee Carlida Finch, [gave a statement to the authorities](#) wherein she overheard Patton West talking about murdering Dr. Pat Cole MD. Below is an excerpt from her statement which clearly shows the violent nature of Patton West towards Cole.

Left Employment Due to Dissatisfaction with Working Conditions

What working conditions were you not satisfied with?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.

The campaign of violence towards Dr. Pat Cole MD came to a head in early April 2006, when during one of the sessions described by Debra Coffey above, Patton West repeatedly hit Dr. Cole MD over the head with the heel of her shoe until blood ran down the victim's blouse. Below is how the victim described the assault to the [Whitefish Pilot](#) newspaper.

"She has told me that she has the 'spiritual' power and authority to 'take me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself."

Photos taken after the alleged beating were submitted to the sheriff's office.


The police were called and Patton West was charged with assault. In March 2007, the whistleblower John Watson was contacted via his website by Rebecca West (no relation to Devra Patton West). Rebecca supplied the whistleblower with [a series of harrowing emails](#) that showed beyond doubt that Patton West was running a cult and that she was robbing, defrauding and extorting money from her employees. Because of the severity and scale of these crimes, the whistle-blower shared his information with the press, in the hope that a criminal investigation would follow.

The first of two articles was published in the [Whitefish Pilot](#) on July 12 2007, the main feature of which was Patton West's assault on Dr. Pat Cole MD, though several other crimes being commissioned by Patton West at that time were also mentioned. On August 9 2007, the [Bigfork Eagle](#) newspaper published their story about Patton West's criminality.

Immediately after the Whitefish Pilot story was published, Patton West had several members of her cult all publish statements of denial on her website. The most prolific of the 'liars for hire' employed by Patton West was Geoffrey Reynolds CPA, who 'distinguished' himself by posting four statements of denial, with 'liar for hire' Dr. Julio Williams MD posting two statements of denial. At the same time that scum bag Geoffrey Reynolds CPA was vehemently denying that Patton West had assaulted Cole, Reynolds was desperately lobbying the service providers of Watson's website [demanding in an email](#) that they remove a copy of Patton West's written statement wherein she admits she had assaulted Cole.

Indeed, in a move worthy of Dumb & Dumber, Patton West claims copyright of her admission of guilt entitled 'The Law of Severity on the Path to Purification.'

We review the contents of this missive lower down in this bulletin and present it as evidence of Patton West's insanity, and Reynolds & Williams collusion in her criminal racketeering gang. Below are links to the statements that all magically appeared on Patton West's website the day after the Whitefish Pilot newspaper article appeared.

After two years of trying to intimidate the victim and witnesses into withdrawing their statements, Patton West was convicted of assault in April 2008.



Above: Patton West, then calling herself the Ascended Master Surya Ma, found guilty of assaulting Dr. Pat Cole MD. Patton West was awarded a 6 month suspended jail sentence and given a \$500 fine. She did not appear in court saying she was making a film documentary in the Yucatan. No such documentary was ever aired – just another lie!

Within days of her conviction Patton West issued a statement on her website stating that she had not assaulted Cole and that Cole's bogus assault claims were "dismissed" by the court. Remember, Patton West believes that [the truth does not matter](#) if she can convince the public that her lies are their truth.

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

As with all psychopaths, Patton West mirrors the crimes she has committed on to her victim. So in Beatrice McGuire's case, where Patton West assaulted her, the victim Beatrice is deemed to be mentally ill for accusing Patton West of assaulting her. In the case of Dr. Cole MD, where Patton West was using violence to extort \$1.3 million from Cole, Patton West accuses the victim of "financial fraud."

The above demonstrates that Patton West is a pathological liar. The following missive entitled 'The Law of Severity on the Path to Purification' penned by Patton West days after the assault in April 2006, shows that Patton West is mentally ill or criminally insane.

Within days of the vicious assault upon Dr. Pat Cole MD in early April 2006, Patton West wrote to her entire mailing list 'admitting' the assault. However, Patton West sought to 'justify' the assault in the eyes of the other cult members by asserting that her actions were sanctioned and approved by other long dead Ascended Masters that Patton West maintains that she is in communication with. These are the imaginary voices in Patton West's head that she uses to justify her behavior. In an attempt to justify the vicious assault on Dr. Cole MD, Patton West invoked the imaginary 'El Morya' to come forward and pronounce an opinion on her behalf. According to pathological liar Patton West, El Morya did just that by channeling a message entitled '[The Law of Severity on the Path to Purification.](#)'

And in the case of Patton West's rapacious appetite for other people's money, El Morya came forward again in a message entitled '[Financial Form Building](#)' to tell her it was OK to fill her financial coffers with (other people's) money.

Nothing else demonstrates Patton West's level of insanity or depravity more than the missive below.

The Law of Severity on the Path of Purification

[1] Response to the Call of Master Surya Devi for Review

April 17, 2006 From Master El Morya of the Shamballa Counsels

Dear Ones,

We offer our compassion during this dark night of the soul passage that sets the stage for the possibility of group formation around the Master Teacher Surya Devi, or in contrary and in inadequate measure fails to meet the requirements than can allow this most essential embodiment to transpire. This advent is given our full illumination and direction of wisdom and is a major aspiration to which all who seek liberation are advised to serve.

- [2] We are called today to deliver our determination on the altercation that has taken place that is the cause of both pain and concern and to make clear to you the higher laws that are brought into effect as we have come together to review and consider the matter. We have gathered in response to Surya Ma's request for an overview that the record be set straight in the case of the challenges that disciples often make in their refusal of the Law of Severity as a necessary and governing element within the greater influences and causal factors of creation. In all instances of our considerations, we are regulated by the Christ Universal and therefore our overview represents this wisdom as well.

What must be taken into account in all matters of review on the part of the Shamballa Counsels is the surrounding circumstances and the root motivation that is at play within any given matter of cause and effect or in the case of Surya Ma's actions the matter of singular cause aligned in Divine Will. We therefore have come to the following determination:

- [4] At no time has Surya Ma's intentions been rooted in anything other than the highest of grace despite the seeming severity that was meted. And we are witness to the sacrifices that she has made on behalf of the awakening of those who are placed in her charge and on behalf of the Divine Plan itself. She has offered up very resource and body, mind and soul and has offered her flesh to our purposes and to the purposes of the Christ, as a form of testament to the existence of the higher realities, should that be required to achieve the planetary transition that is underway and to which she is assigned. Her generosity to Dr. Cole has been boundless, for which Dr. Cole has given little due and therefore remains wanting in her own accounting of right and reciprocal relationship, not only with The Master Teacher Surya Ma but with humanity as a whole

Dr. Cole has made minimal sacrifices during her intensive engagement with Surya Ma despite her belief to the contrary and has been problematic at every turn in her willingness to risk all, in the saving of her vices of pride and jealousy. The lack of vigilance and the indulgence in neglect has also been resultant of a substandard effort befitting a disciple that is being made privy to the inner workings of an executor of the Divine Plan. We therefore do not look favorably on the circumstance that has surrounded Surya Ma, through no fault of her own. The circumstances have been untenable for some time and it is this that we seek to aright. The force with which Surya Ma has sought to bring Dr. Cole into realization of the pain which she has so consistently caused members of the human family is in right reflection and is solely designed to spare Dr. Cole of the otherwise karmic cycles due her that would occupy some twenty to thirty years of her earthly time to bring into balance.

- [7] Dr. Cole is long over due in the sound arighting of her soul with its Creator. Her role in the death camps of Europe during the reign of the Nazi defilement is as yet unrectified. The suffering that was administered directly from her hand was an unconscionable infliction of brutality and evil and more over was resultant in the compromise of her very soul of its inherent link with the light of God. This is a rift in time of planetary karma and many souls have been lost to this rift and remain entrapped in the astral planes of this horror of human disgrace. Her continued denial of this samsara remains a factor to be rectified and she cannot progress until she comes to terms with her compulsions of victimhood rationale, that are merely smokescreens that veil her memory of her perpetrations against her fellow human brethren.

Had she accepted the intervention that Surya Ma has offered time and time again much could have broken free within her and the problem of veiled light remedied. Surya Ma has worked diligently to bring about healing and release from this entrapment in the refusal to atone for ones own perpetrations, for indeed the execution of the innocent established the passive - aggressive miasma in its present state of involution on this planet. As souls were sacrificed in mass, without so much as a flicker of recognition on her part, she, Dr. Cole in like measure sacrificed her own humanity. For what you do unto others, you do unto yourself, and you do unto the whole of creation.

Her denial is a miasmatic condition, which she must take dynamic measures to cure and transform into the clear sightedness that is so vitally needed by all who seek to serve the Christ and His Plan. In so much as she remains blind to her own motivations so will she remain blind to the motivations of others whether positive or negative. And in this regard she has cut herself off from her inborn instincts of discernment and this remains as a severe detriment to her ability of be of service and is far more severe than any severity that she erroneously has judged as being uncalled for and applied to the person of Surya Ma, and it is this problem that continues her cycle in the Halls of ignorance and prevents her full progression into the Halls of Learning that lay the keys of entry into the hands of the trusted disciples that the Halls of Wisdom might be entered.

[8] Surya Ma has earned her rank of honor amongst us in admirable fortitude and compliance with all tests that have served to prove her ability to unify with the One Law, the One Word and the One Life to which we, the Brotherhood of the Life Universal, are sworn to uphold. Our determination is thus spoken is not retractable but rather is the Living Word delivered unto the form worlds that are enlisted unto our care. And in this way the Christ Universal within all beings is thus served and sustained, illumined and acknowledged as the shining light that moves through all suns, for all universes, for all time.

All blessings, we remain in The Unity from which our considerations and dispensement of wisdom has moved. Let now the work proceed in all haste as we are amplifying all matters of benefit that might further the purposes of Surya Ma Devi for the remainder of her walk upon Earth, as a Destiny Soul and externalizing Master of the Lodges of Melchizedek.

Let us now analyze some of these statements. Statements that came out of the head of a criminally insane psychopath who wants us to believe that her vicious assault (and the extortion of \$1.3 million) upon Dr. Pat Cole MD was sanctioned by the Gods.

[1.] 'Response to the call by Master Surya Devi for Review.' Since declaring herself an Ascended Master in 1991, Patton West has awarded herself ever more ridiculous titles and accolades, including 'Regent of the Rishis' and 'Planetary Guardian' and 'Regent of the Spiritual Hierarchy of the Western Hemisphere.' Lately, she has announced herself to be a 'Blessing to all Souls' and an 'Instrument of Mercy' able to deliver the phenomena of 'Divine Grace Healings' and 'Dispensation of Karma.' All for a large six figure sum, for which the pay portal on her website is set up to receive. Patton West is a psychotic, with huge delusions of grandeur. The personalities she creates (and forces others to accept as real) are all in her head.

[2.] Who is called today? None of this is real. It is all going on inside the head of a mentally ill narcissist, who believes because she has occult hidden knowledge and uses it to enforce her will on others, that this makes her a minor deity.

[3.] What this lunatic is saying, is that the imaginary non-existent voices in her head are representative of the Christ, and therefore their determination should be regarded as wisdom.

[4.] Patton West, according to the non-existent voices in her head, had at all times acted with grace despite the severity that was meted. The severity that was meted while the lunatic Patton West was repeatedly hitting Dr. Pat Cole over the head with her shoe, watching the blood from Cole's wounds run down the victim's face on to her blouse?

[5.] The voice in the lunatic Patton West's head, says that Patton West's generosity to Cole has been boundless. Let me see. According to witnesses, Patton West viciously assaulted Cole on many occasions. Patton West, according to [Rebecca West](#) (no relation to Devra West) extorted 1.3 million from Cole, which included forcing Cole to sign over her home valued at \$750,000. Patton West also forced her to pay \$436,000 in cash for 'therapy' and an 'internship' according to the [Bigfork Eagle](#) newspaper. According to Dr. Cole's aunt, Cole also borrowed \$50,000 from her which went into Patton West's pocket. Again, being criminally insane, Patton West in her addled mind thinks she is being generous to Dr. Cole MD.

[6.] Patton West refers to the pain that Dr. Cole MD has allegedly caused the 'human family.' Patton West goes on to assert that her violence towards Cole (while extorting \$1.3 million from her) was designed to save her 20 to 30 years of earthly time to bring into balance. I invite the reader to review the number of victims at Patton West's hands in Montana alone during 1995 & 2010, and suggest that using Patton West's own logic, that many tens of thousands of years would be needed to burn off her karma.

[7.] This shows beyond doubt, the level of insanity and depravity of Patton West. To justify her campaign of vicious assaults and her plans to murder Cole, Patton West asserts that Cole was a Nazi in the WWII death camps in another lifetime.

I am not a psychiatrist, so I will not analyze the level of mental illness that would have one human being say these things about another human being. Given 28 years of organized crime committed on an industrial basis in three western states by Patton West against scores of victims of theft, fraud, extortion, mental and physical abuse and, given the fact that Jack West stated in 2002 that those who opposed his then wife, had a habit of dying suddenly, who do you think was a Nazi in the WWII death camps in another lifetime? The obvious answer is Patton West!

[8.] Surya Ma has earned her rank of honor amongst us. There are only two ways I know to make sense of this statement, given that Patton West sits at the head of a dangerous cult / criminal racketeering gang and is suspected of multiple murders. In 2009, she was the subject of an arrest warrant for felony theft. There were numerous other occasions where Patton West appeared in court as the defendant in fraud related civil lawsuits.

Business partner of Victor Guru wins lawsuit

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court.

Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment.

The case was heard in Ravalli County because West's home and business operations - the Divine Unity Foundation and the Sacred Archives Institute - were in Victor, where Watson also lived.

Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines.

West did not attend Thursday's hearing. Her business manager, Geoff Reynolds, attended but declined to comment and said West would not comment.


Patton West's response to Watson's win in court was to publish a statement on her website denying that there were any business connections between the two of them, and stated that Watson's win was due to a technical error! 



Patton West's power over others comes from her use of occult knowledge to manipulate, intimidate, make ill, injure and if necessary murder those who go public about her criminality. In 2002, John Watson, later turned whistleblower, was told by Jack West that those who opposed his then wife had a habit of dying suddenly. Even after his friend Lisa Swidler died suddenly and mysteriously in 2005 he could not be sure that Patton West was responsible. Watson later found out that Lisa had witnessed Patton West commit two serious crimes against two of her students Dave Kushner & Marion Cantwell. [Dave Kushner](#) was defrauded out of \$30,000 and [Marion Cantwell](#) was kidnapped, held captive and only released after she agreed to give up tens of thousands of dollars from the sale of her home to Patton West. After witnessing these two crimes, Lisa Swidler fled the cult and shortly afterwards died of internal bleeding. Watson could not be sure Patton West was responsible for her death but that all changed in August 2007, when Patton West made a failed attempt to murder him by attempting to suffocate him while he slept.

Below are some of the violent occult attacks described by the whistleblower and others as used by Patton West against victims in the course of robbing them, defrauding them, extorting money from them or used to intimidate them into silence.

- 1.** *Migraine headaches that start with the scalp burning such that the victim has to apply a cold wet towel to the head to stop the burning sensation. These migraines are so bad that the victims have to take pain killers for days until the pain subsides only to be targeted again and again.*
- 2.** *Acid reflux attacks that continue for months causing one to have to take powerful drugs to stop their stomachs digesting itself.*
- 3.** *Sinuses constantly running. When I say running I mean that one has to walk around with a cup in one's hand to drain the sinuses into.*
- 4.** *Excruciating muscle pain in the legs like cramps on steroids.*
- 5.** *Extreme back ache such that one could never get comfortable except when lying down in bed.*
- 6.** *Attacks to the genitals. This form of violent attack seems to have been directed at all members of the family simultaneously. A clear sign that the whole family was under attack came when different family members separated by hundreds, in one case thousands of miles, acquired the same symptoms on the same day!*
- 7.** *Targeting my heart was, and still is, a favorite target of West's. These attacks gave me the feeling that a stake was being repeatedly pushed into my heart. 13 years ago when these attacks started this was quite worrying however 13 years later I have learned to ignore these attacks in the knowledge that if Ms. West had been able to kill me she would have done so long ago. Long term effects unknown.*
- 8.** *The Feb / Mar / Apr 2018 long term attack was against my right ankle. Long story short while I slept the pain built up in my right ankle and when I get up it was painful to walk. Throughout the day the pain subsided somewhat (a moving target is harder to hit) but overnight the occult thief / suspected serial killer works on it again.*
- 9.** *While employed in 2017 my right knee and ankle were targeted simultaneously; these attacks continued for several weeks and everyone at my place of work noticed that I was limping for weeks. Eventually Devra West must have got bored or whatever spell / software / visualization she was using wore out. Perhaps she just moved on to another target.*

- 10.** A sudden spate of nose bleeds. I never get nose bleeds I do not have high blood pressure and yet in 2017 I suddenly had seven or eight in quick succession all within a month. Part of West's strategy is to try and frighten the target into submission by having them believe the attacks, especially the attacks to the heart and head, might prove fatal. Having been a marine I do not scare easily and certainly nose bleeds are not going to ruffle my feathers.
- 11.** One of the attacks Devra West uses regularly is against our digestive systems. Like all the other attacks this variety of violent assault is preceded by a loud hissing. Within minutes whatever we have in our stomachs starts gurgling loudly, followed by severe stomach pains (gas) then diarrhea. Even after eating the blandest of food, upon hearing the hissing my wife and I would both know what came next.
- 12.** Another favorite attack of Devra Patton West's, also preceded by a loud hissing, is where one's energy is drained, to the point of wanting to go to sleep.
- 14.** Attack to one or both eyes. This felt like someone was pushing a needle through the eye.
- 15.** Irrespective of what region of the body Devra West is targeting there is always the sleep deprivation. This has been consistent throughout the 13 years and commented on by other victims including West's neighbor in Flathead Lake Michelle Fetveit who got into a water dispute with West. I interviewed Michelle in 2007 and sure enough she remarked about being woken up at 3.00 am each morning.
- 16.** Nightmares, screaming banshee sounds, voices in one's head foretelling imminent death. All evidence that Devra Patton West is working with demonic entities who are carrying out her bidding.
- 17.** As with Brazilian counterpart 'John of God' the ability to produce 'supernatural effects and adversely affect electrical appliances, computers etc. via demonic entities acting as proxies for the black magicians.

Patton West is not shy about her occult abilities. While being interviewed by the [Whitefish Pilot](#) newspaper in July 2007, she made the following statement.

West claims to have been trained in shamanic visioning and healing by Native American elders and to have been both a Cheyenne medicine woman and General George Patton in past lives. She also claims her "gifts" can heal people with various illnesses, including leukemia, and she plans to teach what she knows to cardiologists and other physicians when her plan for healing spas unfolds. "If you ever saw me heal, you'd be down on your knees crying like a friggin' baby," West said.



Above: While Patton West is likely criminally insane, Dr. Julio E Williams and Geoffrey Reynolds CPA are not. Both, being total strangers to the whistleblower, neither have any motive for becoming complicit in the murder of Watson or their subsequent attempts to bankrupt him. Their actions were obviously coordinated by Patton West there is no other explanation.

Not everyone recruited via Patton West's criminal business model immediately becomes the victim of crime. Some, like Dr. Julio Williams MD and Geoffrey Reynolds CPA, are used by her in her efforts to attract more victims to the cult. Or in the case of her vendetta against the whistleblower John Watson, used by her as proxies to stand between her and her enemies. In 2008, after Watson had successfully sued Patton West for fraud, after she had been convicted of assaulting Dr. Pat Cole MD, after two arrest warrants (one for criminal check fraud and one for felony theft, after being compelled to sell her assets at a Sheriff's Sale to pay past victims of crime \$2,000,000 in court fines and interest, and after three newspaper articles were published in the [Whitefish Pilot](#), [Bigfork Eagle](#) and [Ravalli Republic](#) Patton West's cult / criminal business model was dead in the water in Montana.

After all the revelations in the press and after multiple appearances in court as the defendant in fraud related lawsuits, no one believed the lies and propaganda about her being a 'divine being.' With the loss of millions of dollars a year in ill-gotten gains, desperate measures were required to silence whistleblower John Watson. She also needed to force down Watson's websites which contained a library of information about Patton West's past criminal activities in Montana between 1995 & 2010, and [New Mexico](#) between 1991 & 1995.

ENTER PROXIES DR. JULIO WILLIAMS MD & GEOFFREY REYNOLDS CPA.

According to Dr. Julio E Williams' [own biography](#), he was recruited by Patton West in the year 2000 and, along with two other physicians Cornell and Cole, were intended to be the forefront of Patton West's then latest 'get rich quick' scheme involving her miracle cures for cancer patients. In 2005, two years after the whistleblower issued legal proceedings to sue Patton West for fraud, she manipulated the three physicians into posting a [defamatory statement](#) about John Watson from her website. The statement was written by Patton West and signed off by the three physicians. The statement sought to describe Patton West as a saint, while vilifying Watson for interfering with her 'world service' efforts (organized crime).

Shortly after the statement appeared on Patton West's website, Dr. Cornell left the cult, and 18 months later in early 2006, Dr. Cole became the victim of a vicious assault as part of a campaign of violence orchestrated by Patton West, whose objective was to separate Cole from her \$1.3 million fortune. This left only Dr. Julio Williams to market Patton West's claims to be able to deliver miracle cures to cancer patients. A claim Patton West repeated in an interview she gave to the [Whitefish Pilot](#) newspaper in July 2007.

In January 2007, just one month after Patton West launched her campaign of occult under the radar violent attacks against Watson and his family, Williams sent a threatening expletive laden email to Watson. The email was an obvious attempt to intimidate Watson into dropping his lawsuit against Patton West. Within the email, an excerpt of which is below, Williams told Watson not to 'f*ck' with him and that if he did Watson would get his day in court. If what you are after is money (and /or the Victor property) it is going to take a lot of your own personal money to try and get it. **I have personally allocated Two million dollars for Dr. West defense and legal expenses.**

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. **You fuck with me and you will meet your match.**

Dr. Julio E Williams' threatening email failed to deter Watson. In August 2007, Patton West's other proxy Geoffrey Reynolds CPA, while being interviewed by the [Bigfork Eagle](#) newspaper, let it be known in what he thought was an 'off the record' conversation that the whistleblower John Watson, would be dead within 12 months. He also stated that if not dead, Watson would be jailed for reacting to what Patton West was going to do to his wife and children.

Geoffrey Reynolds was clearly referring to campaign of occult 'under the radar' violent attacks used against countless other victims and used by Patton West to murder Lisa Swidler and, according to Jack West, used to murder others who opposed Patton West.

The plot to murder Watson in August 2007 failed, and in 2008, Watson won his fraud lawsuit against Patton West. Accordingly, Dr. Julio E Williams carried out his threat and made some or all of the \$2,000,000 available to Patton West so that she could fund multiple lawsuits against Watson with the intent of bankrupting him and forcing down his websites. The motive for murder and criminal conspiracy? The millions of dollars Patton West would continue to lose while Watson's websites were up. In 2010, while attending court to see what the appeal judges were going to award him Watson became the subject of a conspiracy to bankrupt him. The conspiracy orchestrated by Patton West, funded by Julio Williams and involving senior cult member Geoffrey Reynolds, resulted in Watson being served multiple times for defamation.


