In 1995, just four years after Patton West formed a cult around her delusions that she was a god on a mission to lead humanity, Devra Patton West was chased out of that state by one victim wielding a loaded gun. According to Patton West's ex-husband, those who opposed his wife had a habit of dying suddenly. Fearing the police were helpless to protect him against Patton West's [Secret Weapon](#), the victim in question clearly decided to act in self-defense as was his right. She charged one victim \$500,000 in 2002!
