We once again urge you to investigate Devra Patton West who has operated a cult / criminal racketeering gang in three western states over nearly three decades. In 2002 Patton West's then husband [Jack West](#) told John Watson, a victim of fraud turned whistleblower, that those (victims) who opposed his wife had a habit of dying suddenly; that was in 2002. In 2005 student Lisa Swidler [died suddenly and mysteriously](#) after trying to leave Patton West's cult after witnessing two very serious crimes that were committed by Patton West against two other students. In 2006 an employee of Patton West's, Carlida Finch, overheard Patton West [talking about the murder](#) of her business partner Dr. Pat Cole MD. After a series of [vicious assaults](#) by Patton West Cole got a reprieve after paying Patton West \$1.3 million which included [signing over her home](#) worth \$750,000 to Patton West. In 2007 another of Patton West's employees was threatened with murder in [an email](#) (it's a good day to die) after going public about the violence meted out by Patton West against Dr. Cole and other employees.

In 2007 Patton West made a failed attempt to murder John Watson after he went public and put up a website about Patton West's crimes in Montana. So confident were the cult that the murder would be successful that they got senior cult member [Geoffrey Reynolds CPA](#) to announce Watson's murder and a campaign of hidden intimidation against Watson and his family to the press on August 9 2007. When the murder plot failed another senior member of Patton West's cult [Dr. Julio Williams MD](#) put up \$2,000,000 of his own money so that Patton West could mount multiple frivolous lawsuits against Watson whose objective was to bankrupt Watson into silence where the murder plot failed. Williams spells out the plan he funded in a [threatening email](#) he sent Watson in January 2007. As we write in July 2020 Williams is totally aware of the ongoing campaign of intimidation being directed at Watson and his wife and children. The same campaign Reynolds announced would occur in August 2007.

This is an average of at least one murder a year from 2005 to 2007. How many more have been murdered over the past 13 years? There is little doubt that Patton West is a serial killer. Clearly her ex-husband Jack West thinks so and clearly Geoffrey Reynolds thinks so too as why else would he confidently announce Watson's murder to the press? Clearly Dr. Julio E Williams thinks so too as after receiving 450 emails from Watson about the ongoing campaign of intimidation over the past 4 plus years Williams has refused to hand the emails over to the police. Clearly Williams, a 20 year student of Patton West's, is hoping she may yet murder Watson.

In one of the postings made on her website in 2007, she stated that she was single handedly [holding open the gates of time](#).

After her Victor MT charity was [struck off for fraud](#) in January 2004, she declared that she needed to move from Victor MT to Flathead MT because she was [moving from the 5th dimension to the 7th dimension](#) and needed to move to a new location where the vibrations were higher. She further announced that the new location, a hundred miles north of her current location in Victor MT, was to be called Shamballa and that she could only take 12 disciples with her and only those willing to [dedicate 66% of their net worth to her](#). Patton West goes on to inform those trapped in her cult that she will not tolerate 'financial withhold' and that it will be [their privilege to seed her financial transition](#). 1. Note to the right of the red arrow Patton West threatens to take a hammer and break every bone in Pat Cole's hands. The following day Carlida notices that Dr. Cole comes to work with bruises on her hands and wrists.
2. Patton West commented to Carlida later that she did not care if she killed Cole because as an enlightened being she has no ego and could just as easily spend the rest of her life in prison as in a \$6,000,000 mansion! Of course being insane Patton West does not comprehend that enlightened beings are non-violent!
3. Note next to the yellow arrow. Carlida then refers to a document written by Patton West who alleges asking the 'Masters' about the altercation with Dr. Cole. She also believes that her employees have no value. When in court on July 12 2007 Patton West was asked about the many statements posted on the whistleblower's website. Statements from ex-employees that allege they were mentally and physically abused and in some cases victims of theft and extortion. Patton West's response was to say that the employees mentioned were '[fabricated and fictitious](#).' From a pathological liar who believes that her employees have no value this was to be expected I suppose.

Business partner of Whitefish guru denies assault

The former business partner of a self-styled spiritual guru in Whitefish pleaded guilty in 2007 to a misdemeanor assault on a doctor in Whitefish.

Geoff Reynolds, a financial adviser for Devra Patton West, pleaded guilty to a misdemeanor assault on Patricia Cole, a Whitefish doctor, in 2007.

The man who took the photos, however, tells a different story about the alleged assault. He claims West profanities and was shouting the words with Cole while he assaulted someone with West. He said he was assisting when Cole appeared wearing a bloody corset.

The man said they cleaned some of the blood off Cole's body and then took photos of Cole, as a doctor, could see her injuries and decide how to treat the wound. Cole said West hit her on the head with a shoe, the woman said.

Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

Geoffrey Reynolds CPA a totally corrupt individual who, for \$300,000, agreed to be complicit in a murder plot and criminal conspiracy.

This is Williams' 'day job.' In January 2007, when it looked like Watson was going to win his fraud lawsuit against her, Patton West persuaded senior cult / gang member Dr. Julio E Williams MD to send a threatening email to Watson in an obvious attempt to intimidate Watson into withdrawing his lawsuit. 

According to the link below, Reynolds was allegedly involved in stealing '[Stealing Industrial Injuries Benefits](#)' (copy and paste link into your browser to open) this is small fry for Reynolds, who in 2006, fraudulently applied for \$30,000,000 in government grants.

On August 9 2007 while being interviewed by the Bigfork Eagle newspaper, Geoffrey Reynolds CPA announced, in what he thought was an 'off the record conversation,' that Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him and his family. According to Reynolds, these attacks were intended to provoke Watson into reacting in a way that would send him to jail. The Conspiracy by Patton West Williams & Reynolds to Bankrupt Watson.

Williams' and Reynolds' involvement in Patton West's conspiracy to murder Watson and, when that failed, bankrupt him into silence is spelt out in detail in a previous bulletin entitled '[Gang Members.](#)' The obvious motive, apart from Patton West's desperate need to be worshipped, is the millions of dollars a year she normally gets from organized crime.

In 2010, when Watson attended court to see how much he was going to get for winning his fraud lawsuit against Patton West, she and her accomplices successfully executed 'Plan B.'

Having moved abroad in 2005, Watson could not afford to travel to the US to defend the two frivolous lawsuits that Patton West & Reynolds had launched against Watson. 




