Memo to Coconino Health and Human Services, Coconino Law Enforcement & Arizona AG's Office regarding 'Rishi Devra' AKA con artist and suspected serial killer Devra Patton West.



There is a mountain of compelling evidence likely to prove either one or both of the following:-

1. That Devra Patton West is and has been engaged in Racketeering (theft, fraud, extortion, violent assaults, threats of murder, one well documented attempted murder and several suspected murders) over the past 30 years in three western US states.
2. That Patton West is criminally insane and therefore, should be confined in a mental institution, as she presents a huge risk to the public. The following is taken from the Maricopa County's [website](#). We have highlighted the relevant sections. We feel certain that Coconino County and the state of Arizona has similar provisions to protect its population from those suffering from mental illness, who represent a clear and present danger to the public.

Application for Involuntary Evaluation

Any responsible individual may submit an application for involuntary evaluation of a person who is alleged to be, as a result of a mental disorder, a danger to self or to others, persistently or acutely disabled, or gravely disabled and who is unwilling or unable to undergo a voluntary evaluation. The responsible individual submitting an application for involuntary evaluation may be someone such as a family member, case manager, or any other person in the community. The responsible individual must present facts to support the allegations made in the application.

Application for Emergency Admission

An application for involuntary evaluation may be accompanied by an application for emergency admission if the person is an immediate danger to self or others. An emergency application may be submitted when the proposed patient is likely to suffer serious physical harm or serious illness or is likely to inflict serious physical harm upon another individual if not immediately hospitalized. The application for emergency admission must state the specific nature of the danger and a summary of the observations upon which the statement of danger is based.

WE MAKE THAT APPLICATION NOW BASED ON THE FOLLOWING EVIDENCE.

5. [As an instrument of mercy she offers the phenomena of divine grace healing \(and dispensation of karma\).](#) Fact. There is nothing divine or graceful about Patton West. On the contrary. Patton West is a vicious and cruel psychopath and quite possibly a serial killer. Here are four examples of Patton West's violent assaults upon members of her cult or cult member's children. Dr. Pat Cole MD repeatedly hit over the head with the heel of Patton West's shoe until blood ran down the victim's blouse. The [Whitefish Pilot](#) newspaper has details. Susannah Felder partially scalped by Patton West after Susannah questioned Patton West about an \$80,000 donation Patton West stole from the charity she later bankrupted. Read what witness / charity board member [AJ White](#) had to say. Beatrice McGuire had part of her ear ripped off after calling out one of Patton West's lies in front of an audience of scores of attendees to one of Patton West's gatherings. 6. The Rishi Collection. Fine Art, Sacred Heirlooms and Antiquities. Fact. After Patton West's charity was [struck off](#) for fraud in January 2004, and with several lawsuits against her, she defrauded the charity out of its largest single asset; a property worth \$1,250,000 (as valued in 2002). This asset's ownership was transferred to a private trust fund she had set up for herself and her eldest son, Rob Meador. The purpose of the trust fund was to hide the asset from her creditors which did not work, as in 2008, a judge arranged for the sale of the property at a [Sheriff's Sale](#) to force Patton West to pay for \$2,000,000 worth of court fines and interest that she owed her creditors. Also in 2004, Patton West stole \$4,000,000 in art work and valuables owned by the charity, which like the property, were largely funded by public donation. When questioned about the art work and valuables in court under oath in 2009, Patton West denied their existence stating that they were lost or stolen or carted away. In 2014, after the expiration of the statute of limitations on theft, the items magically appeared being offered as part of a [moving sale](#). 2. The [weapon](#) she uses to intimidate and murder those who oppose her, is not recognized as a weapon under legal statute, so Patton West's 'extra judicial' killings (multiple murders) are not investigated by the authorities because the deaths appear to be as a result of 'natural causes.'

Patton West's stock in trade are lies, propaganda, disinformation and, to those who would reveal her criminality / insanity to the public, are subject to defamation from her website, threats, violent assaults and murder. If Patton West was just a guru, why would she need to murder John Watson for publishing the truth about her? After John Watson, a business consultant hired for projects by Patton West between January 2002 & August 2002, was defrauded by her, he decided to fight back. He did so by sharing evidence of organized crime with the Secretary of State for Montana which resulted in Patton West's 'charity' being [struck off](#) the charity register in Montana. Watson also contacted the IRS which resulted in Patton West being audited but not before she has her employees [shred](#) all the incriminating documents and falsify others. Watson also sued her for defrauding him out of pay and shares; [a lawsuit he won](#) in 2008 with the judge [awarding Watson](#) \$760,000 in damages and costs. Watson was one of several victims of crime at Patton West's hands in Montana, as is made clear by the publication of three newspaper articles.



Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.

Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.

After entering her plea, Devra West was sentenced to

a six-month deferred jail term and fined \$500.

Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.

Justice of the Peace David Ortley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.

West's trial was postponed

from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.

West's trial originally was scheduled for April 2007.

Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

The 2007 [Whitefish Pilot](#) and [Bigfork Eagle](#) newspapers articles, though covering many of her other criminal activities at that time, mainly focused on a series of vicious assaults by Patton West on Pat Cole MD, her business partner. The assaults were part of a campaign to separate Pat Cole from \$1.3 million, which Patton West succeeded in doing at a cost of a \$500 fine and a 6 month suspended jail sentence. Judgement against Patton West for assaulting Cole was published in April 2008 in the Whitefish Pilot newspaper (see above). In 2008, the [Ravalli Republic](#) newspaper published a news article about Watson's win in court against Patton West. With a huge amount of negative press in Montana and with Watson's website up providing the public with hundreds of pages of evidence about Patton West's crimes in Montana and New Mexico, Patton West's criminal racketeering business model was 'dead in the water' in Montana.


Above: As long as Watson's website was up Patton West's criminal business model was 'dead in the water.' The loss of millions of dollars a year from organized crime, her charity struck off for fraud, Watson's fraud lawsuit against her and her 'forced' move from Montana to Arizona – all motives for murder. Clearly, Patton West had to move on to a third western state (Arizona) but could not reincarnate herself there with a new name, new identity and new fake [bio / life story](#) until Watson's website was forced down. In January 2007 Dr. Julio E Williams MD, clearly at Patton West's behest, sent an [expletive laden threatening email](#) to Watson in an attempt to get Watson, the plaintiff in a fraud lawsuit against his cult leader Patton West, to drop the lawsuit. In this email Williams told Watson that he had allocated \$2,000,000 for Patton West's defense fund / legal expenses. Williams did this knowing that there was an audio recording of Patton West [admitting she had defrauded](#) Watson (but did not see herself writing out a check for what she owed him) up on Watson's website.

This was not Williams' first intervention on behalf of his cult / gang leader, as in 2005, Williams posted a statement on Patton West's website defaming Watson. This was probably propaganda intended for the consumption of her rank and file cult members; an attempt to portray Watson as the villain and Patton West the victim, a tactic Patton West uses regularly according to her ex-secretary [Barbara Costantino](#). What Williams said in his statement was:-

I, Julio Williams MD have also been a long time student of Surya Ma and I stake my honor and credibility on defending her personal integrity and establishing the truth. I am proud to serve on the Board of Directors of the Global Guardianship Initiative.

The above is an excerpt from a lengthy [statement](#) posted on Patton West's website in 2005 by Williams and two other cult members.

With Watson refusing to drop his lawsuit against Patton West and declining to take down his website detailing many of Patton West's crimes in Montana and New Mexico, Patton West conspired with [Dr. Julio E Williams MD](#) & [Geoffrey Reynolds CPA](#) to murder Watson.

Patton West, Williams & Reynolds continue to rely on the fact that for the past 30 years, the authorities have not believed what the victims have said or dismissed their claims as too fantastical. Where they were believed, as was the case in Montana in 2007 when multiple victims contacted the police, the response is that because the '[secret weapon](#)' Patton West is using, is not regarded as a weapon under legal statute, there is nothing the police can do. In this regard, the police and authorities in New Mexico, Montana and more recently Arizona, have failed to protect their populations from a suspected serial killing predator. Patton West and her accomplices are relying on the fact that the authorities will continue to ignore victims and witnesses of crime and the mountain of evidence that makes it obvious Patton West sits at the head of a criminal racketeering operation.

We will leave it up to law enforcement and the psychiatrists to decide which of the two options is the truth...

1. That Devra Patton West has been engaged in Racketeering (theft, fraud, extortion, violent assaults, threats of murder, one well documented attempted murder and several suspected murders) over the past 30 years in three western US states.

2. That Patton West is criminally insane and therefore should be confined in a mental institution as she presents a huge risk to the public.

Finally, the cult whistleblower John Watson, stands ready to act as a witness for the prosecution and to help join the dots. He can do so in the matter of Patton West's attempt to murder him (aided and abetted by Williams & Reynolds) and also in many other areas including the following matters:-

1. Patton West's then husband in 2002, Jack West, told John Watson that those who opposed his wife had a habit of dying suddenly. 3. The planned murder of Dr. Pat Cole MD that fellow employee Carlida Finch overheard Patton West talking about. Carlida made a [Statement of Fact](#) to the authorities about this matter at the time. Cole got a reprieve from death after agreeing to hand over her net worth of approximately \$1.3 million to Patton West.

As [witness explained](#) this included Cole signing over her own home worth \$750,000 and being forced to sign a quit no claim deed.
