- Police questioning Faria said electrical items began to malfunction in the room


Detectives questioning a celebrity medium in [Brazil](#), accused of sexually abusing more than 300 women, have reported **spooky goings-on** during their two hour interrogation.

**Unexplained incidents** ranging from a 'bizarre' computer crash to wiring on electrical appliances suddenly 'short circuiting' appears to suggest supernatural forces were at play during the interview. The mysterious problems **unnerved cops** but didn't deter them from collecting the testimony from faith healer, João Teixeira de Faria, who is known as João de Deus – John of God on Sunday night in Goiânia.

Detective Karla Fernandes, responsible for coordinating the task force investigating the allegations, claimed that as the spiritual guru began to speak, **strange things started to happen**. She said to Folha de Sao Paulo: 'Suddenly the computer that was being used to transcribe the suspect's answers to the allegations seemed to **have a life of its own** and the commands on the keyboard wouldn't work. 'When the clerk tried to enter the medium's statement, the keys locked on a **specific letter** and 'OOOOOOO' was recorded continuously on the screen for a few seconds.' Although this has never happened before, bemused agents put the incident down to a faulty computer. But when the printer in the room began to **print without receiving a command and a fridge blew up**, their thoughts turned to **paranormal interference**.

Det. Fernandes said: 'It was hot in the interrogation room and I decided to turn on the air conditioning. 'I plugged the lead into an extension shared with a mini-fridge and the **electrical wiring suddenly exploded, burning out the fridge**. Everyone in the room **screamed with fright**.' According to the officer, the 76-year-old spiritual healer, who is accused of sexually molesting women during private consultations at his clinic, stayed silent. She said: 'Although these things happened and surprised us, they failed to interfere with our work. He (John of God) didn't say a word.'


A woman who helped to bring down a Brazilian faith healer accused of sex abuse has taken her own life in [Spain](#). Sabrina Bittencourt, 38, died at her home in Barcelona just days after accusing John of God – real name Joao Teixeira de Faria – of running a 'sex slave farm'. She claimed young girls were held captive in a farming operation which exported babies on the black market.

## **THIS IS THE EXACT PLAY BOOK / STRATEGY USED BY SELF APPOINTED DEITY & SUSPECTED SERIAL KILLER DEVRA PATTON WEST**

Let us review the similarities.

1. The Brazilian Occultist, Joao Teixeira de Faria, refers to himself as 'John of God.' Patton West refers to herself as 'the revered executor of the divine plan' and the 'sanctified regent of the New Americas.' She also states that she has been preparing to lead humanity for thousands of years. LOL.
2. They both use the occult to manipulate their victims. The occult knowledge they both possess can be used to subtly manipulate their targets or if more persuasion is needed, the occult can be used to target victims with violence or even murder. For those who do not believe that the occult is real, then ask yourselves why Hollywood is obsessed with it and why all Super Bowl half time 'entertainment' consists of scantily clad 'artists' performing Satanist rituals.
3. Sabrina Bittencourt died at home in Barcelona just days after accusing 'John of God.' They say she committed suicide. It is much more likely that she was murdered either by John of God using occult knowledge or by the demonic entities working with/and for him. In 2003, fraud victim John Watson issued a lawsuit against Patton West. In 2005, Watson moved with his family to Nova Scotia Canada fearing for his safety. In 2006, Watson put up a website about Patton West's activities in Montana.



In August 2007, senior cult member Geoffrey Reynolds CPA announced Watson's impending murder to a local newspaper reporter, in what Reynolds thought was an 'off the record' conversation with the reporter. Days later and almost asleep, Watson distinctly heard the voice of Patton West's then husband, Jack West, telling him that he would be dead within a week. In addition to announcing Watson's imminent murder by Patton West, Reynolds also declared that Watson would be in jail within 12 months for reacting to, and I quote, what Patton West was going to do to him, his wife and children." End quote. In the earlier part of this missive, we outlined the 'paranormal' events the Brazilian police were subject to at the time of 'John of God's' arrest. Clearly, Reynolds knew Patton West was capable of doing the same (as John Watson and others can bear witness too; others like Rebecca West who in a [harrowing email](#) asked Watson for help with Patton West's "shamanic witchcraft".) Though Reynolds left the cult in 2014, Reynolds is well aware that Patton West's attempts to 'silence' Watson by murder or by intimidation continue unabated. For this reason, we suggest that the prosecutors throw the book at Reynolds who was not only totally complicit in the attempted murder of Watson, but remains silent about Patton West's ongoing efforts to carry out what Reynolds announced publicly in August 2007.



A week after Reynolds' announcement of Watson's impending murder, Patton West made a failed attempt on Watson's life. It happened like this. While almost asleep, Watson found he could not breathe because it felt like there was a very heavy weight was on his chest. Eventually after what seemed like an eternity, Watson could suddenly breathe. Had he not been so well trained, Watson would have succumbed and appeared to have died in his sleep. The point being, whether in Bittencourt's case or Watson's case distance is no object to those with the occult skills like John of God and Devra Patton West obviously possess. It is my belief that Bittencourt was murdered in Spain by 'John of God' located in Brazil while, had Watson died, it would have been achieved by Patton West based in Montana while Watson was located thousands of miles away in Nova Scotia, Canada.

To be clear, both 'John of God' and Devra Patton West can cause illness, injury and death with apparent impunity and with total deniability. In Patton West's case, she had clearly murdered several others before she got around to dealing with Watson. **Senior Cult Member Geoffrey Reynolds CPA** responds by announcing the following to a local newspaper in 2007. When both murder and intimidation failed Reynolds doubled down on his treachery in 2010 by making totally false statements to a Montana court. In 2007, after several very negative newspaper articles were published about Patton West's criminal activities Jack West posted a lengthy statement on Patton West's website which stated... **Senior Cult Member Dr. Julio E Williams MD**, is a 22 year member of Patton West's cult / criminal racketeering gang who sent an expletive laden email to the whistleblower telling Watson not to fu\*k with him or else! Williams also announced that he had pledged \$2M of his personal fortune to fund multiple frivolous lawsuits against Watson as part of Patton West's conspiracy to bankrupt Watson into silence. Williams has played a central role in Patton West's attempts to extort millions from cancer victims by selling them 'miracle cures.'

**Senior Cult Member Corinne Coffin**, is a multi-millionaire and a three decade member of Patton West's cult / criminal racketeering gang. She witnessed Patton West defrauding the whistleblower. In spite of this Ms. Coffin continued to fund Patton West's criminal activities. For example shortly after the whistle-blower was defrauded out of pay and shares Ms. Coffin rewarded Patton West by giving her \$736,000. This so that Patton West could continue to rob, defraud and extort money from victims which is exactly what she is now doing in Arizona.

Above from left to right: Career criminal Patton West masquerading as a guru. (1) Lisa Swidler murdered to keep her from going to the police. 
**EXAMPLE 1. The Murder of Student Lisa Swidler.** Lisa was murdered in 2005 to stop her going to the police about crimes committed against fellow students, [Dave Kushner](#) (defrauded out of \$30,000), [Mike Hendrickson](#) (defrauded out of \$200,000) and [Marion Cantwell](#) who after selling her home was the victim extortion. Lisa was also aware of the [brutality](#) being meted out to Dr. Pat Cole MD by Patton West, while in the process of extorting \$1.3 million from Cole.

**EXAMPLE 2. Marion Cantwell Kidnapped and Falsely Imprisoned and the Victim of Extortion.** After the sale of her home, student [Marion Cantwell](#) was kidnapped, falsely imprisoned and beaten. After being forced to make a 'donation' of tens of thousands of dollars, Marion was told she would be murdered if she went to the police.

**EXAMPLE 3. The Planned Murder of Dr. Pat Cole MD.** Patton West was overheard by employee, [Carlida Finch](#), talking about the murder of her business partner Dr. Cole. Cole was viciously assaulted several times (the [Whitefish Pilot](#) newspaper has the details) by Patton West while extorting the victim's entire net worth from her, which included Cole being forced to sign over her \$750,000 home to Patton West. West was convicted in 2008 of assaulting Cole. Cole was not murdered, getting a reprieve after emptying her bank account into Patton West's.

**EXAMPLE 4. The Attempted Murder of Fraud Victim turned Whistleblower John Watson.** When fraud victim, John Watson, put up a website about Patton West's criminal activities in Montana, one of her cult / criminal gang members, Geoffrey Reynolds CPA, [announced Watson's impending murder](#) to the local press. After a failed attempt on Watson's life by Patton West, and after Watson won a [fraud lawsuit](#) against Patton West, the cult rallied around its leader, Patton West, who came up with Plan 'B..' However, this career criminal IS offering to both *heal cancer* and dispense karma for a six figure sum which [in 2002 in Montana](#) was available at a cost of \$500,000!

In October 2009 Patton West was deposed by the whistleblower's lawyer. During the [statement she gave](#), Patton West admitted she was \$2M in debt and that the artwork and valuables (now being portrayed as the 'Rishi Collection') did not exist. In 2008, Patton West was the subject of a '[Sheriff's Sale](#)' to force her to pay past victims of organized crime \$2,000,000 in court fines and interest. 



**When is the 'Racketeer Influenced and Corrupt Organizations Act' (RICO) going to be applied to Patton West and her Accomplices?**

[Racketeer Influenced and Corrupt Organizations Act \(RICO\)](#). U.S. federal [statute](#) targeting [organized crime](#) and [white-collar crime](#). Since being enacted in 1970, it has been used extensively and successfully to prosecute thousands of individuals and organizations in the [United States](#). Part of the Organized Crime Control Act of 1970, the Racketeer Influenced and Corrupt Organizations Act (RICO) makes it unlawful to acquire, operate, or receive income from an enterprise through a pattern of [racketeering](#) activity.

Geared toward ongoing organized criminal activities, the underlying tenet of RICO is to prove and prohibit a pattern of crimes conducted through an “enterprise,” which the statute defines as “any individual, partnership, corporation, association, or other legal entity, and any union or group of individuals associated in fact although not a legal entity.”


In order for an individual or organization to be convicted of racketeering under RICO, there must be proof of a “pattern” of illegal offenses, which RICO defines as the commission of at least two identified criminal offenses within a 10-year period. RICO defines racketeering in an extremely broad manner and includes many offenses that do not ordinarily violate federal statutes, such as any act or threat involving [murder](#), [Kidnapping](#), [gambling](#), [arson](#), [robbery](#), [bribery](#), [extortion](#) or dealing in narcotic or other dangerous drugs.

**From the above description of the RICO Act we can draw a number of conclusions:-**

**1. The “enterprise” can be any individual, partnership, corporation, association, or other legal entity, and any union or group of individuals associated in fact although not a legal entity.”** Patton West, Jack West, Julio Williams, Geoffrey Reynolds and Corinne Coffin were clearly acting together in an “enterprise” described by Patton West as ‘World Service.’ It does not matter whether that relationship was legally formalized, though we can easily prove that Jack West, Julio Williams, Geoffrey Reynolds and Corinne Coffin were at times either formally employed, were partners, directors and officers in the various vehicles Patton West used as ‘containers’ for her criminal racketeering business model. There is also plenty of evidence to prove that Williams & Coffin funded Patton West’s criminal activities to the tune of millions of dollars.

**2. There must be proof of a “pattern” of illegal offenses, which RICO defines as the commission of at least two identified criminal offenses within a 10-year period.** Hell, you could probably prove that Patton West commissioned two criminal offenses within a week or a month, let alone ten years! Lower down in this bulletin is a short list of some of the crimes Patton West committed in Montana. That list is the tip of the iceberg. Below is a list of some of the crimes committed by Patton West over the last three decades or more. That there is a three decade “pattern” of criminality in three western states cannot be disputed. THESE INCLUDED TWO CHILD CUSTODY CASES – COUNTLESS ACTS OF **FRAUD** INCLUDING AGAINST THE IRS, STATE AND LOCAL GOVERNMENTS.



Let’s review her rap sheet. Several suspected murders prior to 2002 (according to her ex-husband Jack West). How many counts of murder since? One count of kidnapping. Several threats of murder. Tens or scores of examples of fraud and extortion. Several attempts to subvert civil lawsuits brought against her. A conviction for assault. Several well documented incidents of violent assault against female members of her cult. Scores or hundreds of victims subject to relentless campaigns of occult hidden **terror attacks**. ## MORE ON THE CULT / GANG MEMBERS.

**DR. JULIO E WILLIAMS MD.** Dr. Williams has been a disciple, student, accomplice of Patton West's since the year 2000 and remained so until 2021. In 2005, Williams posted a [statement](#) on Patton West's website in response to fraud victim John Watson's decision to sue Patton West for defrauding him a lawsuit Watson won in 2008.

Since Williams remained a disciple of Patton West's between 2000 and 2021, it is clear that Williams has no honor or credibility. Why would Williams, a total stranger to Watson, send an expletive laden [threatening email](#) to Watson in January 2007? Why would Williams pledge \$2M of his own fortune to fund Patton West's legal fees so as to block Watson's and other victim's lawsuits against Patton West? This [document](#) from an employee of Patton West's evidences a \$100,000 payment to Patton West in early 2007. This payment was made shortly after Patton West viciously assaulted Dr. Pat Cole MD and months before Patton West was convicted of that assault.



I, Julio Williams MD have been a long time student of Surya Ma (now calling herself the Ascended Master Rishi Devra) and I stake my honor and credibility on defending her personal integrity and establishing the truth.

Why in 2018, would Williams propagate the [lies posted online](#) by Patton West that her two\* defamation lawsuits against Watson (which Williams funded) were about cyber-crime? Why would Williams post a [statement](#) online that totally misrepresents the injunction that Williams' money 'bought' for Patton West? Williams knows that the truth is bad for his cult leader's business (theft, fraud and extortion) so, in addition to attempting to quash the truth about Patton West's crimes, Williams also posted a series of fake, idiotic ['testimonials'](#) on her website. (\*Reynolds' pleadings were a copy of Patton West's hence the two defamation lawsuits brought against Watson but funded by Williams.

**GEOFFREY REYNOLDS CPA.** Why would [Geoffrey Reynolds CPA](#), a total stranger to John Watson, announce Watson's impending murder to a local newspaper reporter while being interviewed by the Bigfork Eagle newspaper on August 9, 2007? When the 2007 murder plot failed, why would Reynolds double down on his lies and treachery and make a [totally false statement](#) to a Montana court in 2010, as part of a \$10M extortion scam orchestrated by Patton West? It is clear that Reynolds' pleadings to the court were not his but an exact copy of Patton West's pleadings.

If Reynolds joined Patton West's cult / criminal gang in September 2006, how could he have been 'defamed' by Watson between 2002 & 2006? He couldn't have been. Reynolds is a pathological liar, who would sell his wife and children if the price was right.

**JACK WEST.** [Jack West](#) has been a willing accomplice in his ex-wife's criminal racketeering business model for many decades. An ex-friend, [Jeremy Samuelson](#), described Jack West as a weak minded person who was being 'run' by his wife, Patton West. Jeremy also says that the couple defrauded him out of \$10,000. A similar claim was made by [Satya](#), who says that Patton West defrauded her out of \$6,000. Both these victims indicate that Patton West has made a living from organized crime for at least 3 or 4 decades.

**CORINNE COFFIN AKA TANMAYO.** Corinne Coffin had been a disciple / student of Patton West's going back to the 1990's. Ms. Coffin is a Brazilian heiress, who has been funding Patton West's activities for decades. John Watson (the whistleblower) worked with Patton West as a 'business consultant' between January 2002 to August 2002. During that time, Watson was aware that Ms. Coffin had given one of her credit cards to Patton West, which Patton West used to fund many of her day to day expenses. This seemed odd to Watson, as at the time, there were capital controls on the outflow of monies from Brazil?

Allegedly, much larger sums of money were passed to Patton West from Brazil via an intermediary in New York. During the Spring of 2002, Watson and Coffin ended up being selected by Patton West as business 'partners' (directors and shareholders) in Millennia Mind Inc. Below, are copies of the business cards that a Colorado design agency created for that project.



Up until that time, Watson believed that he was working for a respectable charity and that the charity's finances were all above board. While setting up for profit and non-profit corporations for Patton West, Watson discovered that Patton West and her then husband, Jack West, were using the charity's bank account as their personal accounts. When Watson brought this to the attention of Patton West, explaining that if any large donors to her charity were to take her seriously, they would need to see proper sets of accounts showing the charity's finances. Fearing that she was going to lose access to hundreds of thousands of dollars a year from donations, Patton West made up totally false grounds which she used to constructively dismiss Watson. This resulted in the Watson being defrauded out of shares and pay.

Patton West's personal secretary, Barbara Costantino, shared a [written statement](#) with Watson in which she made clear that every time someone challenges or opposes Patton West's crimes, Patton West gets rid of them and then manufactures a totally false narrative about the departing individual to cover up her crimes. Ms. Coffin at the start of this project in the Spring of 2002, confided in Watson that she was glad he was onboard, as she did not trust Patton West to use the \$1,000,000 she was going to donate for the purpose the money was intended for.

Unfortunately, after Watson was gotten rid of by Patton West, Ms. Coffin swallowed all of Patton West's lies about his departure and went ahead with the project without Watson's involvement. Here is a [document](#) evidencing payments totaling nearly \$750,000 to Patton West. 
