- 2010** Watson could not afford to travel back to the USA to defend against Patton West & Reynolds' lies.
- 2010.** Because Watson failed to turn up West & Reynolds were awarded undefended \$5,000,000 each.
- 2023.** Patton West makes a second failed attempt on Watson's life in October 2023.
- 2024.** The shamanic / black magic attacks continue unabated as they have since December 2006. See below here...



Above: Giving a criminally insane narcissist like Patton West occult knowledge is like giving a rabid gorilla a loaded machine gun. For 32 plus years Patton West has used that knowledge as a weapon to rob, defraud, extort and violently assault victims in three western states. Those who oppose her are subject, like Watson and family, to violence and murder. Because the weapon used to facilitate serious crime is not a knife, a gun, poison etc. the police have done nothing – so far.

Patton West acquired occult (hidden) knowledge while attending the [‘Robert Jaffe School for Energy Mastery’](#) for eighteen months between 1990 & 1991. Since then she has been operating her own school for occult studies. The attacks directed at John Watson include the following:-

Attacks to the head – serious headaches / migraines / feeling your scalp is on fire.

Attacks to the heart – feeling your heart is bruised.

Attacks to the internal organs – kidneys etc.

Attacks to the digestive system – sudden diarrhea / forced to empty ones bowels immediately.

Sleep deprivation – woken up at 3.00 am every morning.

Shamanic / Black Magic Rape – occurs while you are sat down or in bed.

Regarding the allegations of rape. The very strong feeling that someone or something is forcing its way into your rectum. These attacks are designed to keep you awake for 4 to 5 hours as you try to resist someone or something trying to force itself inside you. The after effects of these attacks are a sore rectum. I suspect Patton West wants the victim to know she can force herself on to them as often as she pleases with impunity. I have no doubt this kind of brutal attack and the humiliation has been used by Patton West against countless other victims. Indeed during a March 2003 meeting with Watson Patton West declared that, and I quote, **“I feel fu*ked up the arse by you John, fu*ked up the arse. If you sue me I’ll get so down and fu*king dirty huge expenses coming out of your pocket not mine.**

Note the comment about being “fu*ked up the arse.” Is this the kind of thing a ‘World Server’ would say? Patton West said those words in March 2003. How many has she “fu*ked up the arse before and since?



Above: Imagine giving a criminally insane narcissist the codes to a nuclear bomb. This is the equivalent of what Patton West acquired between 1990 & 1991 while attending the ‘Robert Jaffe School for Energy Mastery.’ Being criminally insane she has used this occult (hidden) knowledge for the past 28 years to feather her own financial nest at the expense of scores of others.

Unfortunately for Patton West fraud victim turned whist blower John Watson has ways to mitigate the severity of these attacks but others might not. Unfortunately for Patton West Watson is an ex-marine who once tasked with a mission they complete it or die trying. Watson has made this clear to Patton West over the past 17 plus years which explains the two desperate attempts by Patton West to murder Watson. There is much more that can be said about the occult violence but it is being saved for the inevitable criminal investigation.

As the title indicates this is about one man’s journey through the meat grinder.

Long story short Patton West recruits Watson as a Business Consultant and tasks him with setting up multiple non-profit corporations and one for profit corporation called Millennia Mind. Watson is also tasked with teaching her 'employees' to create financial budgets. Because this was a new business 'start up' there would be no capital to fund wages until Corinne Coffin funded Millennia Mind with \$1,000,000 seed capital. So Watson proceeded on the basis of getting paid once the corporation was funded. After completing his tasks Watson was told by Patton West that God has spoken to her on the previous night and told her that shares were a thing of the past so he was not going to get paid the salary he was promised or receive the shares he was entitled to.

Once Watson announced he was going to sue Patton West for fraud she insisted on a private meeting at which she basically admitted defrauding him but made it clear that she had no intention of paying him and asked him to prove they ever had any agreements. 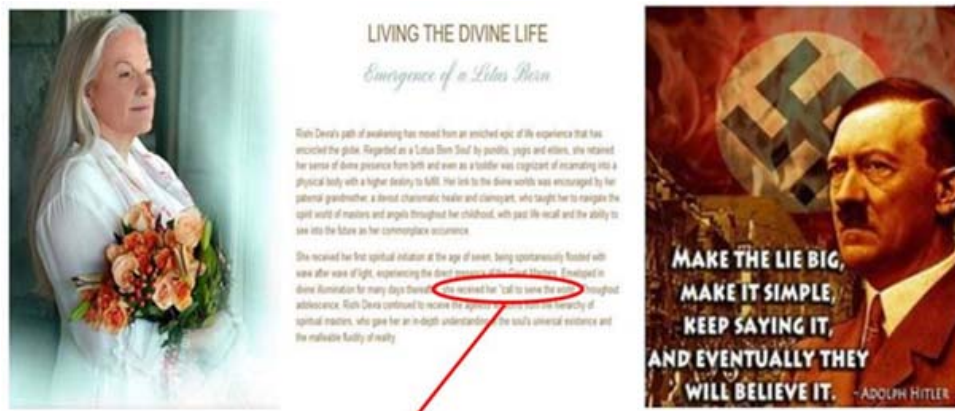

Here are two more big lies...

When Patton West is found guilty of defrauding Watson and the verdict is published in the [local newspaper](#) Patton West responds with this big lie posted on her website...

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

And when Patton West was found guilty of assaulting her business partner Dr. Pat Cole MD...

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

If anyone reading this still believes Patton West is a 'World Server' then they are seriously gullible!

Items 04, 05, 07, 09, 15, 16 & 22. After using Watson's expertise for 6 months on a joint venture involving three 'partners' (herself, Coffin and Watson) Patton West now explains that she "**Does not want partners.**" Explains that her "**Agreements are worthless.**" West "Agrees that she and Watson did have a business relationship but, "**Does not see herself writing out a check for what she owes Watson.**" This is blatant fraud from a career criminal who believes she is totally beyond the reach of the law. We intend to see that she and her accomplices are jailed.

So we have Patton West admitting she defrauded Watson but says she does not see herself paying him. Let us now look at what Patton West said when Watson informed Patton West he was going to sue her for defrauding him in spite of her threats.

Items 10, 11, 12, 17 & 26. Watson insists that he was defrauded, the evidence is clear and Patton West just admitted that she defrauded him. That is the truth. Patton West being a pathological liar as well as being seriously mentally ill tries to persuade Watson that the work he was doing was all his idea – not hers. Everyone knows that Patton West is a total control freak and **in item 17 above she actually agrees that she is a control freak.** No one in her cult / criminal racketeering gang has discretion to do anything unless she approves it in advance.

In item 11 Patton West asserts that Watson is "**fu*king over a Spiritual Teacher.**" Have you ever heard a 'spiritual teacher' speak like that?



Above: Narcissist occult thief Patton West who believes that she is a god on a mission to save humanity. In fact she stated (see above) on one of her websites that she had been preparing to guide humanity for thousands of years. In reality she sees herself as a superior being whose right it is to prey on the herd. The herd being anyone who swallows her lies and propaganda.

In item 10 Patton West threatens to get, and I quote, “down and dirty huge expenses coming out of Watson’s pocket but not hers.” This turned out to be one of the few truthful statements that Patton West made as in March 2007 senior cult member [Dr. Julio E Williams MD gave Patton West \\$100,000](#) to fund her legal costs against Watson and several other plaintiffs suing Patton West for fraud and assault. Additionally between 2003 & 2007 senior cult member Corinne Coffin, a joint national (USA & Brazil), gave Patton West [approximately \\$7436,000](#) to fund her criminal activities (racketeering and domestic terrorism) inside the USA. We estimate that Coffin has funded Patton West’s criminal activities in total to way above a million dollars even breaking Brazil’s capital control laws to get funds to Patton West in the USA.

In items 12 & 26 the real Patton West shows her face. Watson is going to sue Patton West for fraud whether she likes it or not. Not only does he have all the evidence to prove it he now has Patton West’s voice on a digital recording admitting she defrauded him. Patton West insists in item 12 that she is being “fu*cked up the arse by Watson?” She insists that she is not going to stand for it and that she is going to get so fu*cking down and dirty etc. In item 26, having seen that bullying does not work, Patton West tries another approach and pretends to break down and cry. This creature is beyond evil.

Now let us define what Patton West means by “getting so fu*cking down and dirty.”

1. Defamations of Watson from Patton West’s website by her and her accomplices Reynolds, Williams and ex-husband Jack West.
2. A campaign of under the radar occult (hidden) violence directed at Watson, his wife and children.
3. A threatening [expletive laden email](#) from senior cult member Julio Williams intended to intimidate Watson into dropping his lawsuit against Patton West at the eleventh hour. Watson won the lawsuit in 2008.
4. A murder attempt in August 2007 that senior cult member [Geoffrey Reynolds announced](#) to the Bigfork Eagle newspaper reporter one week before Patton West’s failed attempt on Watson’s life.
5. In 2010 Patton West with stooge Reynolds issued two defamation lawsuits against Watson gambling that he would not return to the USA to defend them. The worst part about this conspiracy is that Reynolds did not join Patton West’s ‘employ’ until September 2006 and yet he testified that he was defamed between 2002 & 2006. His pleadings were an exact copy of Patton West’s. This is a conspiracy to defraud.
6. A second murder attempt failed in October 2023.
7. For the past month Watson has been subject to daily / nightly occult rapes by Patton West hoping to deter Watson from ever getting justice. Justice for the many serious crimes committed against him and scores of other victims in three western states over the past 33 years.

The above is what just one victim is having to endure for telling the truth about Patton West’s cult / criminal racketeering gang. Is it any wonder that 95% of victims choose to walk away empty handed.

In case anyone doubts Watson's claims about two murder attempts here, coincidentally, is more evidence that murder is used as a tool. The ability to use her occult [secret weapon](#) to commit murder and commit scores of lesser crimes and get away with it for 32 plus years, is all the justification Patton West needs to elevate her status to that of a minor deity! Below here are a small portion of her victims subject to threats of violence and murder...

CRIMINALLY INSANE NARCISSIST



In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. In response Patton West used her 'secret weapon' against Rebecca who asked the whistleblower for help dealing with Patton West's "Shamanic witchcraft." In her email Rebecca wrote about the huge turnover in employees. New recruits had their wages and benefits cut on day one of their employment. Patton West subsequently wrote to Rebecca stating that it was, and I quote, "A good day to die."



Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

MURDER AN ACCEPTABLE COST OF DOING BUSINESS?



In 2005 Lisa Swidler, a student and teacher at Patton West's unaccredited school for occult studies, died suddenly and unexpectedly leaving behind two small children under the age of 10 years. Maybe it was a total coincidence that at the time of her sudden death Lisa had fled the cult and was likely going to the police to report three serious crimes she had witnessed Patton West committing against other 'students.' Dave Kushner was defrauded out of \$30K. Mike Hendrickson defrauded out of \$200K. And last but not least Marion Cantwell was kidnapped, held hostage and beaten until she agreed to make a large donation to Patton West from the sale proceeds of her house.

MURDER AN ACCEPTABLE COST OF DOING BUSINESS?



After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 66% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carilda Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

Above left to right: Senior cult members Julio Williams (2000 to 2021), Geoffrey Reynolds (2006 to 2014), Corinne Coffin (1995 to 2021) and last but not least Jack West (1970's to present day). None of the aforementioned rats were bothered about the murders or crime being committed on an industrial basis by Patton West. They worshipped Patton West's ability to murder with impunity. Williams & Coffin only decided to leave the cult in 2021 after Patton West defrauded the US government out of \$500K in SBA Loans understanding that unlike individual victims the US Gov. has endless resources to prosecute organized crime.

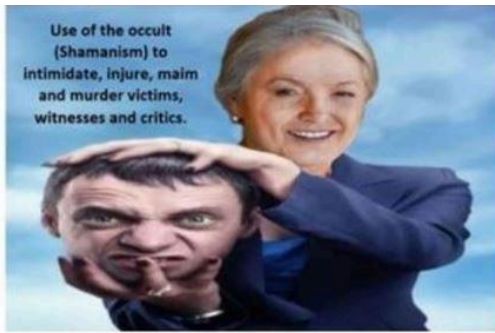
In summary we would make the following two points about cult members Julio Willams, Geoffrey Reynolds, Corinne Coffin and Jack West..

2. RACKETEER INFLUENCED AND CORRUPT ORGANIZATIONS (ACT)

Under RICO, a person who has committed "at least two acts of racketeering activity" drawn from a list of 35 crimes—27 federal crimes and 8 state crimes—within a 10-year period can be charged with racketeering if such acts are related in one of four specified ways to an "enterprise".^[citation needed] Those found guilty of racketeering can be fined up to \$25,000 and sentenced to 20 years in prison per racketeering count.^[citation needed] In addition, the racketeer must forfeit all ill-gotten gains and interest in any business gained through a pattern of "racketeering activity."^[citation needed]

When the U.S. Attorney decides to indict someone under RICO, they have the option of seeking a pre-trial restraining order or injunction to temporarily seize a defendant's assets and prevent the transfer of potentially forfeitable property, as well as require the defendant to put up a performance bond. This provision was placed in the law because the owners of Mafia-related shell corporations often absconded with the assets. An injunction and/or performance bond ensures that there is something to seize in the event of a guilty verdict.

We estimate that Patton West is guilty of no less than EIGHT ACTS of RACKETEERING activity within a ten year period. As [this email](#) shows Jack West has been directly involved for at least 30 years maybe 40 years so he should be tried under RICO statutes. With Reynolds and Willaims guilty of at least three ACTS of RACKETEERING each. Ms. Coffin has been funding these crimes (as has Williams) for 2 or 3 decades.
