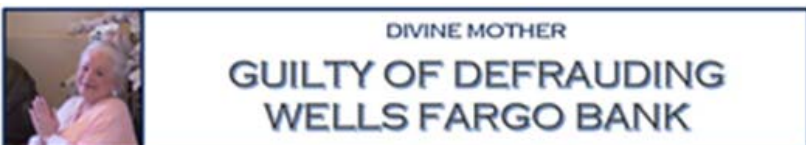

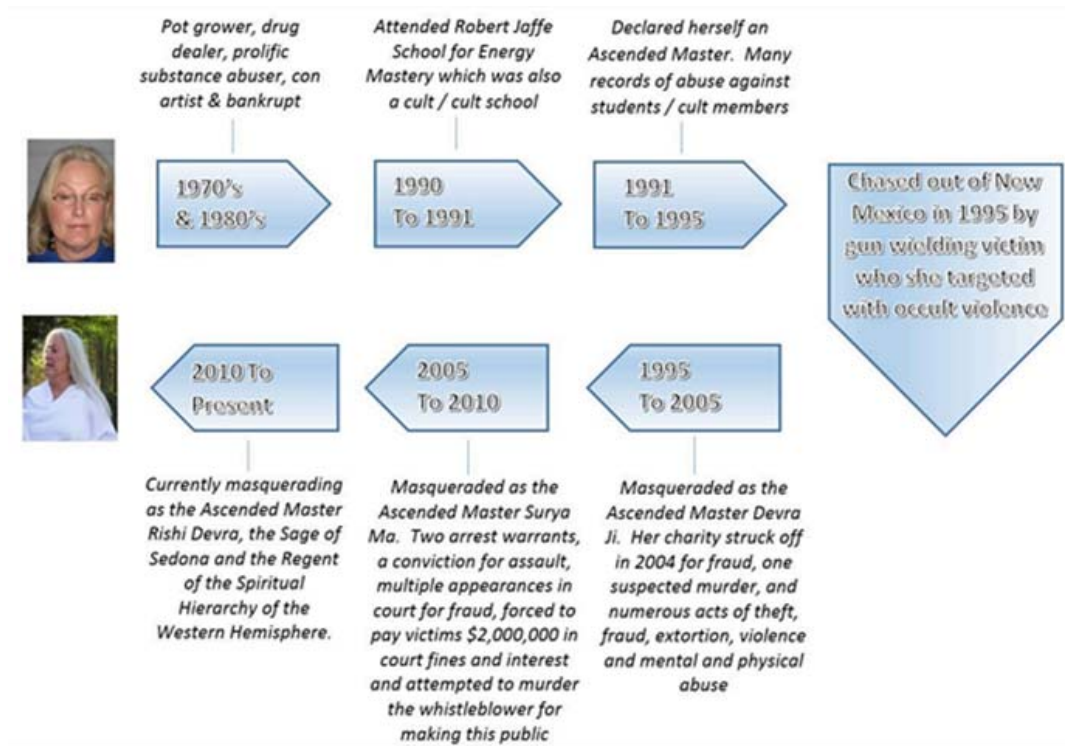



Jack West is a pathological liar who has been intimately involved with Patton West's criminal activities for several decades. His PhD was given to him by his ex-wife and as with all of her titles and accolades it is fake.. Telling lies in public and in court is his speciality. In 2008, when the truth went public about Patton West criminal activities in Montana, Jack West issued a statement on Patton West's website. In the statement Jack West stated that his ex-wife was, and I quote, "Utterly free of wrongdoing and as ethically virtuous as any human being can be." End quote. **We beg to differ.**

In 2008, Patton West was the subject of an arrest warrant for criminal check fraud, was convicted of assaulting her business partner Dr. Pat Cole MD and was also convicted of defrauding an earlier business partner John Watson. Also in 2008 Patton West was the subject of a Sheriff's Sale to force her to pay \$2,000,000 in court fines and interest to previous victims of organized crime. In 2009 Patton West was the subject of a second arrest warrant for felony theft. This is the tip of the iceberg. Jack West is a pathological liar who in recent years has tried to distance himself from his ex-wife' ongoing crime spree.

There is not much to say about Jack West that his old friend Jeremy Samuelson has not already said. "A timid man with little experience of a woman who was 'overwhelmed' by Devra West who was soon running him."



In 2002 Devra West stated that her then husband, Jack West, would be hanging onto her skirts for decades to come, which turned out to be the case. Jack West's function was to embed himself amongst the cult and report on any disaffection amongst the ranks and like his then-wife, he was and still is a compulsive liar. Here is how former board member of the charity, 'The Circle of Divine Unity' described 'liar for hire' Jack West.

"In late July 2001, while I was on a business trip to Denver, Susanna Felder, a committed assistant for over 9 years and editor of Devra's writing, called me. She called me in severe distress as she had gotten into a heated discussion with Devra on whether or not I should be put on the BOD – there was no Foundation BOD at that time. Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head. This was severe abuse and ultimately led to Susanna leaving DU within the month. I returned to the office several days later and the first thing I did was to address this abuse in a staff meeting with Susanna in attendance.

Jack West, who was present at the event, categorically denied it happened while Anandra accused Susanna of causing the problem. This collaborative deception was so shocking that I resigned, effective immediately. The cover-up was endemic and serious abuse issues were lied about and swept under the rug. The lack of integrity by Devra, her impropriety around money and her physical and verbal abuse of individuals were the reasons for my leaving."

In July 2007 and August 2007 respectively two news articles were published by the Whitefish Pilot and Bigfork Eagle about Patton West's crimes in Montana. In addition to having two newspaper articles revealing details of Patton West's criminal activities there was in the two years following much publicity around some of the crimes themselves. For example, Patton West was the subject of multiple arrest warrants (1) & (2), a [conviction for assault](#), a conviction for [defrauding the whistleblower](#) and was the subject of a [Sheriff's Sale](#) to force Patton West to pay past victims of crime \$2,000,000 in court fines and interest. In response Jack West, like other senior members of the cult (Geoffrey Reynolds & Julio Williams) published his own totally dishonest and full of lies statement of denial from West's website.



"To All Who Value the Truth,

My name is Jack West and as a previous board member of the non-profit Divine Unity and Sacred Arts Institute (struck off the Montana charity registry after it was discovered that Jack West and Devra West had defrauded it out of hundreds of thousands of dollars) I offer my statements to refute the despicable and unfounded accusations that John Watson has made about Dr. Devra West-Surya Ma. Even though I am her ex-husband, I am stepping forward because I am outraged that he has orchestrated an implausible raft of tabloid-style allegations, based solely on his own malicious scripting of trumped-up gossip and calculated deception. There is nothing in his account of Dr. West's circumstances that bears any resemblance to the truth of her situation. She remains as utterly free of wrongdoing and as ethically virtuous as any human being can be."

CORINNE COFFIN AKA 'TANMAYO'

For two or three decades, Ms. Coffin has been a senior member of a US based cult / criminal racketeering gang headed by self-appointed 'Planetary Regent' Devra Patton West. During her tenure Ms. Coffin has financed the cult / gang's criminal activities to the tune of millions of US dollars. Ms. Coffin is a Brazilian citizen and yet during capital controls meant to stem the flow of capital out of Brazil at the beginning of this century Ms. Coffin kept the flow of funds into the USA via intermediary's thus circumnavigating Brazilian capital control laws.

Between 2004 and 2009 only Patton West's charity was struck off for fraud in 2004. She was the subject of two arrest warrants one in 2008 and one in 2009. She was convicted in 2008 of assaulting her business partner Dr. Pat Cole MD. In 2008 she was also found guilty of defrauding another business partner John Watson. Also in 2008 Patton West was the subject of a Sheriff's Sale to force her to pay past victims of crime \$2,000,000 in court fines and interest. In spite of knowing about all the criminal acts committed by Patton West Ms. Coffin continued to fund Patton West's criminal acts (Racketeering & Domestic Terrorism) and remained as 'treasurer' of Patton West's 'front company' until 2021. 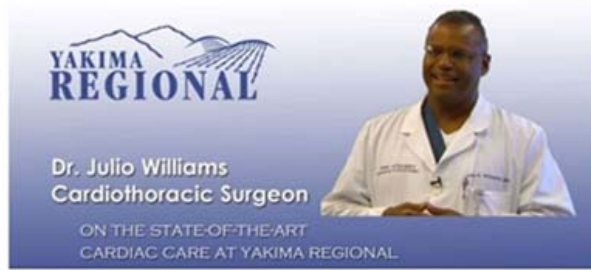

Geoffrey Reynolds CPA currently working for McSwain & Co accountants. In 2006 he money laundered \$460,000 that his 'employer' extorted from a local doctor. In 2007 Reynolds was complicit in a plot to murder a witness who turned whistleblower against his cult leader Devra Patton West. When that failed in 2010 Reynolds agreed to be part of a \$10,000,000 extortion scam to bankrupt the whistleblower.

Reynolds is a totally corrupt individual lacking a moral compass and a single shred of integrity. The Urban dictionary defines the word 'scum' thusly:-

(adj.) Possibly the worst word you can have your name associated with. It is hard to define the word, but it is basically used to describe someone so disgraceful that they are seen as the lowest form of life. "Worthlessness", "waste of skin", "dirt". "Nothing". Far worse than most other insults, where the victim is often just referred to as genitalia.


Reynolds was a total stranger to fraud victim-turned-whistleblower, John Watson, and yet Reynolds, after being duped by Patton West into loaning her his life savings, agreed to be an accessory to be complicit in a plot to murder Watson in 2007. Reynolds even announced Watson's impending murder to a local newspaper reporter. On August 9 2007 Reynolds stated, and I quote, "Watson will be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children." Reynolds was clearly 'in the know' about Patton West's ability to use her occult knowledge to murder those who oppose her with impunity (so far).




When the murder plot failed, Reynolds doubled down on his treachery by partnering with Patton West in a 2010 criminal conspiracy to extort \$10,000,000 from Watson. This is what criminals do if they cannot silence you by intimidation or murder, they then go to law and outspend you in court. Reynolds' part in the plot was to make totally false statements to a Montana court declaring that he had been defamed by Watson between 2002 and 2006. A total lie, not least because Reynolds did not move from California to take up his new employment with Patton West until September 2006. A fellow employee stated that she thought Reynolds was blackmailed into a life of crime after he was duped into loaning his life savings to Devra West and the only way to get his money back was to agree to murder a total stranger, and when that failed, conspired to bankrupt him. Reynolds' price to be complicit in murder, racketeering and domestic terrorism was \$300,000.



In summary and about multiple suspected murders....

While Geoffrey Reynolds got the 'credit' for announcing Watson's impending murder the the local Montana press in August 2007 there have been several other suspected murders. According to her ex-husband Jack West there were at least two murders prior to 2002 and Lisa Swidler and Joseph Costantino bring that total up to at least 4. Then there have been two attempts on Watson's life one in 2007 that Reynolds announced and one in 2003. Apparently the TRUTH is bad for Patton West's criminal racketeering business model!

CRIMINALLY INSANE NARCISSIST



In March 2007 one of Patton West's employees, Rebecca, went public about the crimes being committed by Patton West on an industrial scale against her own employees. In response Patton West used her 'secret weapon' against Rebecca who asked the whistleblower for help dealing with Patton West's "Shamanic witchcraft." In her email Rebecca wrote about the huge turnover in employees. New recruits had their wages and benefits cut on day one of their employment. Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

MURDER AN ACCEPTABLE COST OF DOING BUSINESS?



In 2005 Lisa Swidler, a student and teacher at Patton West's unaccredited school for occult studies, died suddenly and unexpectedly leaving behind two small children under the age of 10 years. Maybe it was a total coincidence that at the time of her sudden death Lisa had fled the cult and was likely going to the police to report three serious crimes she had witnessed Patton West committing against other 'students.' Dave Kushner was defrauded out of \$30K. Mike Hendrickson defrauded out of \$200K. And last but not least Marion Cantwell was kidnapped, held hostage and beaten until she agreed to make a large donation to Patton West from the sale proceeds of her house.

After Patton West's charity was struck off for fraud in January 2004 Patton West had no choice but to move her cult / criminal operations to a new location. Accordingly she wrote to all of her cult members telling them that she was moving to 'Shamballa' and that only those willing to commit 66% of their net worth were allowed to follow her there. Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

In 2005, having just sold her home, Marion Cantwell was kidnapped by Patton West, falsely imprisoned and beaten until she agreed to make a large donation to Patton West's good causes (herself). Upon release Marion was told that she would be murdered if she went to the police. Some months later the whistleblower had a phone call from Marion's new employer. Apparently Marion had shared her experiences with her new employer who wanted to make sure that Marion was indeed a victim and not an active member of Patton West's cult / criminal racketeering gang. The whistleblower was happy to confirm that Marion was indeed a victim.

After being defrauded out of wages and shares fraud victim turned whistleblower sued Patton West a lawsuit he won in 2008.
