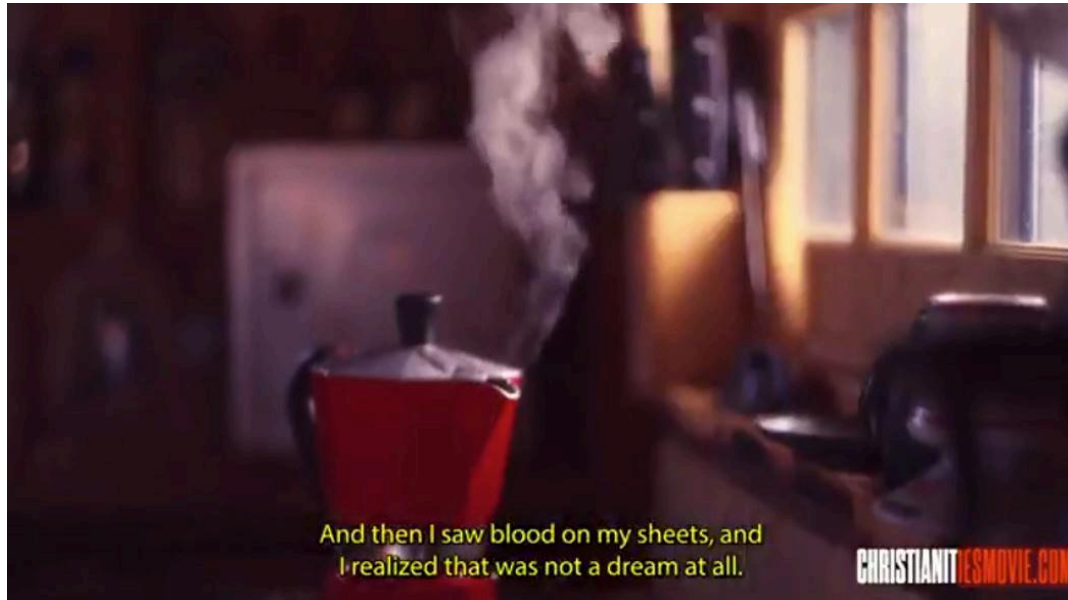

### Spiritual guru pleads guilty in assault

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.  
Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.  
After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.  
Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.  
Justice of the Peace David Ortle issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.  
West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.  
West's trial originally was scheduled for April 2007.  
Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

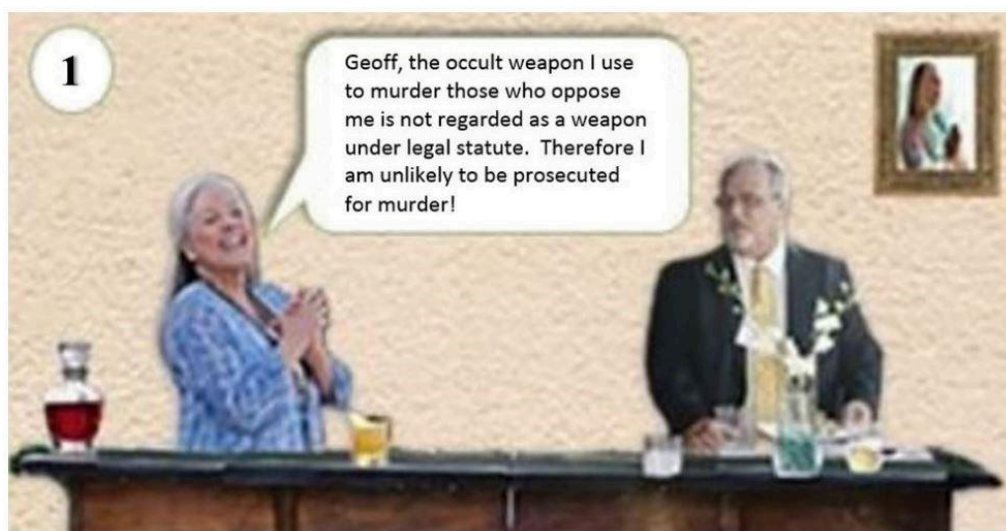

However getting a successful prosecution for multiple murders may be difficult or impossible as her victims all appear to have died of 'natural' causes or died in their sleep. The first attempt to murder the whistleblower in 2007 involved 'paralyzing' (just as with Tucker Carlson) Watson while he was half asleep. Basically he was unable to breathe as though he had a very heavy person sat on his chest. Eventually Watson broke free of the spell and started to breathe again....



This explains why Reynolds so confidently announced Watson's impending murder to a local newspaper in August 2007. He knew that in spite of his comments no one would be able to prove Patton West did it.

If Patton West's use of occult knowledge as a weapon to gain control of other human beings sounds far fetched I can assure you it is not. Hollywood and the District of Columbia (Washington DC) are somewhat riddled with Satanists and Black Magicians any cursory glance at the news shows this to be the case. Detectives questioning a celebrity medium in Brazil accused of sexually abusing more than 300 women, have reported spooky goings-on during their two hour interrogation. Unexplained incidents ranging from a 'bizarre' computer crash to wiring on electrical appliances suddenly 'short circuiting' appears to suggest supernatural forces were at play during the interview. The mysterious problems unnerved cops but didn't deter them from collecting the testimony from faith healer, João Teixeira de Faria, who is known as João de Deus – John of God on Sunday night in Goiânia.

### The bullet points are...

**Computer Crash.** Unexplained incidents ranging from a 'bizarre' computer crash to wiring on electrical appliances suddenly 'short circuiting' appears to suggest supernatural forces were at play during the interview.

**Keyboard Commands did not work.** Detective Karla Fernandes claimed that as the spiritual guru began to speak, strange things started to happen. 'Suddenly the computer that was being used to transcribe the suspect's answers to the allegations seemed to have a life of its own and the commands on the keyboard wouldn't work. 'When the clerk tried to enter the medium's statement, the keys locked on a specific letter and 'OOOOOOO' was recorded continuously on the screen for a few seconds.' 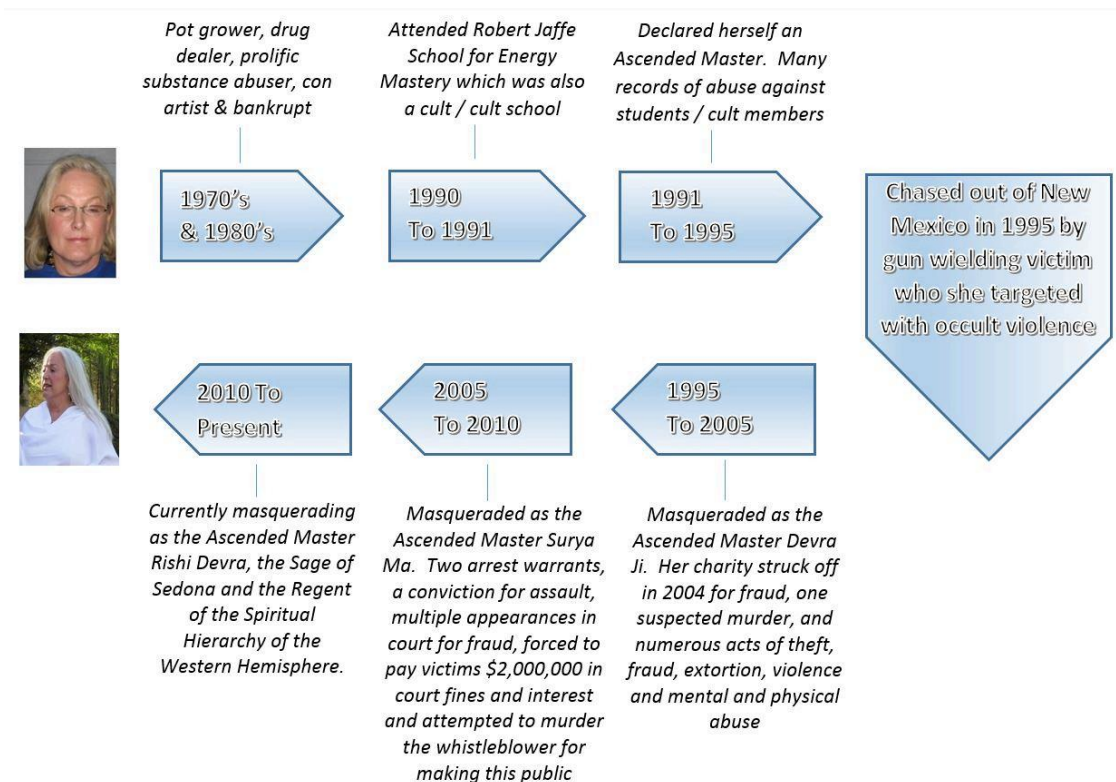
**The bottom line is that Williams, Reynolds, Coffin and Jack West are all willing accomplices in Racketeering, Domestic Terrorism & Murder!**
