Subject: Siberian cult leader masquerading as Jesus arrested. American cult leader Rishi Devra AKA Patton West still at large in Sedona AZ.

Once again, we make the case that you urgently investigate Devra Patton West and her quasi-religious operation which we maintain, and can prove, is a 'front' for a criminal racketeering business. This criminal business model has operated in three western states over the past three decades since 1991. After being literally chased out of New Mexico at the point of a gun, she moved to Montana in 1995. After a victim of fraud at her hands put up a website about her criminal activities, she was forced to leave Montana in 2010. She is currently preying on the spiritual / metaphysical communities in Sedona AZ.

Like the Russian 'Jesus' who has just been arrested in Siberia, Patton West dresses in white and masquerades as a deity while mentally and emotionally manipulating those in her cult, in the process of extorting money from them. What makes Patton West much more dangerous is that she is in possession of a <u>secret weapon</u> and is suspected of being a serial killer. A theory confirmed by her exhusband and senior cult member, Geoffrey Reynolds, who announced one victim's murder days before Patton West's failed attempt on the victim's life. We have a mountain of evidence to share with you some of which is posted on two websites. We also have the testimony of a victim of fraud at Patton West's hands who, after turning whistleblower, survived the attempt on his life by Patton West, Julio Williams and Geoffrey Reynolds. The latter being senior members of her cult / gang.



Sergei Torop, the Siberian 'Jesus' had his 'awakening' in 1991 and as far as we know he and his two accomplices are charged with mainly financial crimes i.e. extortion. There is no question at this stage of either Torop or his accomplices having committed murder.

Patton West's two accomplices, Dr. Julio E Williams MD & Geoffrey Reynolds CPA, have not been arrested even though they are both complicit in the attempted murder of John Watson a victim of fraud who turned whistleblower and went public about Patton West's crimes.

Patton West declared herself to be an Ascended Master in 1991 after completing eighteen months of training at <u>'The Robert Jaffe School for Energy Mastery.'</u> Shortly afterwards she formed a cult around herself and began to acquire wealth at the expense of those she mentally and physically abused. In 2002 her then husband Jack West, told the whistleblower John Watson, that those who opposed his wife had a habit of dying suddenly. In 2005 a student who witnessed two serious crimes died suddenly and mysteriously. In 2007 Geoffrey Reynolds announced the impending murder of John Watson days before Patton West made a failed attempt on Watson's life. More about that below.

Russian 'Special Forces' have arrested a man in Siberia who has been masquerading as Jesus for 30 years. It appears he is guilty of the mental and emotional abuse of those in his cult while extorting money from them.

We know Patton West is guilty of doing the same for 30 years but on a much larger scale. Her cult / criminal racketeering gang has operated in three western states and, in addition to theft, fraud and extortion includes several suspected murders and one well documented attempted murder. Many of Patton West's crimes are well documented with the victim of the failed murder attempt ready to give evidence.




"The withhold of personal resources must be corrected!"

"It will be your privilege to seed my financial transition." & "The withhold of personal resources must be corrected." Were messages sent to those trapped in her cult in Montana.

Both quotes came from the same document entitled 'Financial From Building' and can be found in paragraphs 7 & 10 numbered in red. Those not emptying their bank accounts into Patton West's bank account in a timely manner were subject to violent assault and threats of murder.

What happens to those withholding personal resources? Read two witness accounts about what happened to Dr. Pat Cole MD when she did not transfer her entire net worth to Patton West fast enough. Employee Rebecca West (no relation to Devra West) writes about Cole being brutalized and being forced to sign over her home (worth \$750,000) to Patton West. Carlida Finch talks about Patton West planning Cole's murder, Threatening Cole with violence and then seeing Cole come into work the next day with bruises on her wrist after Patton West hit her with a hammer. The Whitefish Pilot & Bigfork Eagle newspapers detail how Patton West repeatedly hit Cole over the head with the heel of her shoe until blood fan down Cole's blouse.

When confronted about the violence meted out towards Cole Patton West issued a statement entitled <u>'The Law of Severity on the Path to Purification.'</u> The statement, which she claimed was channelled from a long dead Ascended Master El Morya, asserted that Cole was a Nazi in the WWII death camps in another lifetime. Therefore the severe beating was not only appropriate but long overdue. No mention of the estimated 41.3 million Patton West extorted from Cole. If anyone still doubts that Patton West is criminally insane this missive should convince them. Now 25 year after being chased out of New Mexico at the point of a gun and 10 years after being forced to leave Montana due countless scandals, several negative newspaper articles and several visits to court as the defendant.

What happens to those who go public, go to the police or seek restitution through the courts? They are threatened with murder like Marion Cantwell or Patton West's attempts to murder them like she tried to do with John Watson or she succeeds in murdering them like she did with Lisa Swidler. But that was all ten years ago before she moved from Montana to Arizona in 2010. Before she changed her name to 'Rishi Devra' and elevated herself to 'Planetary Regent.' From the cash donations she invites from the public based on lies, up to the extortion of millions of dollars a year for fake miracle cures. Scores of victims of theft, fraud, extortion and numerous victims of violent assault while operating in three western states with most victims too afraid to go to the police because they know the police cannot help or protect them.

Let us review some of her biggest lies that she believes are 'protected' under religious freedom laws even though the obvious motive for the lies is fraud and extortion.

3. As the light that stands behind leaders and world servers across the globe. Fact. Patton West is a pariah amongst real service to other entities. If she were involved with any 'leaders' or 'world servers' you can bet that she would shamelessly use their names images on her website. The fact is, that like her other claims that she was "holding open the gates of time" and that "the Christ gave her two doctorates in person" it is all lies and propaganda.

4. As a planetary regent her auspicious presence offers the rare opportunity for private mentoring and audiences for initiates world servers and spiritual protégées. Fact. This is all bullshit. In reality, these lies and the accompanying propaganda are used by Patton West to attract potential victims into the 'kill zone.' Once the wealthy amongst attendees to her 'private sessions' have been identified, they are targeted for fraud and or extortion. Review this posting made by Patton West of 'Sacred Sundays' to be held at the home of senior cult member, Dr. Julio E Williams MD. Victims are made ill by Patton West using her secret weapon and then asked to pay six figure sums to be cured. Patton West was charging \$500,000 for this 'service' in 2002. Listen what Patton West's personal assistant had to say about this.

5. As an instrument of mercy she offers the phenomena of divine grace healing (and dispensation of karma).

Fact. There is nothing divine or graceful about Patton West. On the contrary. Patton West is a vicious and cruel psychopath and quite possibly a serial killer. Here are four examples of Patton West's violent assaults upon members of her cult or cult member's children. Dr. Pat Cole MD repeatedly hit over the head with the heel of Patton West's shoe until blood ran down the victim's blouse. The Whitefish Pilot newspaper has details. Susannah Felder partially scalped by Patton West after Susannah questioned Patton West about an \$80,000 donation Patton West stole from the charity she later bankrupted. Read what witness / charity board member AJ White had to say. Beatrice McGuire had part of her ear ripped off after calling out one of Patton West's lies in front of an audience of scores of attendees to one of Patton West's gatherings. As witness Debra Coffey points out, the victim needed plastic surgery for her injuries. Then there is Ingrid Smith's six year old son who was assaulted by Patton West.

Then there is the murder of student <u>Lisa Swidler</u>, who was silenced to stop her going to the police about crimes she witnessed against other cult members.





**6.** The Rishi Collection. Fine Art, Sacred Heirlooms and Antiquities. Fact. After Patton West's charity was struck off for fraud in January 2004, and with several lawsuits against her, she defrauded the charity out of its largest single asset; a property worth \$1,250,000 (as valued in 2002). This assets ownership was transferred to a private trust fund she had set up for herself and her eldest son, Rob Meador. The purpose of the trust fund was to hide the asset from her creditors which did not work, as in 2008, a judge arranged for the sale of the property at a Sheriff's Sale to force Patton West to pay for \$2,000,000 worth of court fines and interest that she owed her creditors. Also in 2004, Patton West stole \$4,000,000 in art work and valuables owned by the charity, which like the property, were largely funded by public donation. When questioned about the art work and valuables in court under oath in 2009, Patton West denied their existence stating that they were lost or stolen or carted away. Read the court transcript of her statement given while being deposed by the whistleblower's lawyer. In 2014, after the expiration of the statute of limitations on theft, the items magically appeared being offered as part of a moving sale. Many of these items were featured on her website.

Is Patton West criminally insane? If so, she should be taken off the streets for her own protection and the public's protection. We suspect that Patton West knows what she is doing and like her accomplices, Julio Williams, Geoffrey Reynolds and Jack West, she relies upon the fact that her obvious lies are 'protected.'



Patton West was / is aided and abetted by the senior members of her cult, who act as 'liars for hire.' These are all willing accomplices in what is obviously a criminal racketeering business model, disguised as a quasi-religious organization. They all actively promote Patton West to the public as a minor deity and, when things go wrong, which is often, they publicly deny any wrongdoing on her part, however compelling the evidence against her might be.

The above photo of Patton West is from a 2009 <u>arrest warrant</u> issued in Montana for Felony Theft. The arrest warrant issued just one year before she left Montana for Arizona, and just two years before, she announced that she had been elevated to the status of Planetary Regent and Mother of Ten Thousand Suns

The attempted murder of John Watson AKA the whistleblower. John Watson, a business consultant working for Patton West between January 2002 and August 2002, was defrauded out of pay and shares by Patton West. After researching his fraud lawsuit against Patton West, he found out that he was one of scores of victims of theft, fraud, extortion and violence at Patton West's hands. In 2006, in order to counter the lies and propaganda being posted by Patton West on her website, Watson put up his own website posting details of Patton West's many crimes in Montana & New Mexico. Because this was a direct threat to Patton West's multi-million dollar a year criminal business model, Patton West decided to silence Watson by any means.

In that regard, she recruited two senior members of her cult, Dr. Julio E Williams MD and Geoffrey Reynolds CPA to threaten Watson, announce Watson's impending murder to the press ahead of Patton West's attempt on his life and, when the murder plot failed, participate in a criminal conspiracy orchestrated by Patton West to bankrupt Watson into silence. Both Williams and Reynolds were total strangers to Watson, but both clearly under Patton West's control.

# <u>Dr. Julio Williams MD & Geoffrey Reynolds CPA's role in Patton West's past, present and ongoing conspiracy to silence / murder John Watson.</u>



1. January 2007. Dr. Julio E Williams MD, prompted by Patton West, writes a lengthy expletive laden email to Watson telling him, and I quote, "not to f\*ck with him or else." An obvious clumsy attempt to intimidate Watson into dropping his lawsuit against Williams' cult leader Patton West. The 2007 email followed an earlier defamatory statement made about Watson that Williams posted on Patton West's website in 2005 immediately after Watson announced his decision to sue Patton West for fraud.

1. Above: Here is a link to Williams' expletive laden threatening email to Watson sent in January 2007. Here is a link to the defamatory statement that Williams (and other cult members) posted on Patton West's website immediately after Watson announced his intention to sue Patton West for fraud; a lawsuit he won in 2008.



2. August 2007. After it was clear that John Watson was not going to be intimidated into dropping his lawsuit against Patton West senior cult member Geoffrey Reynolds CPA announced Patton West's plan to murder Watson to the press. While being interviewed by the Bigfork Eagle newspaper Reynolds announced, in what he thought was an 'off the record' conversation, that Watson would be dead within 12 months or jailed for reacting to what Patton West was going to do to his family.

2. Above: Geoffrey Reynolds announced in what he thought was an 'off the record' conversation, that Watson would be dead within 12 months or in jail for what Patton West was going to do to him and his family. Reynolds made these comments while being interviewed by Constance See the reporter for the Bigfork Eagle newspaper. She took the threat seriously and passed it on to a federal agent investigating patton West at the time. A full review of Reynolds' 'on the record' comment made on behalf of his cult leader, Patton West, can be reviewed by following this link to the Bigfork Eagle newspaper article. It is worth pointing out that in his interview, Reynolds basically admits 'money laundering' \$463,700 of the \$1.3 million that was extorted from Dr. Pat Cole by Patton West through West's business as normal business receipts. Reynolds told the reporter that this money was owed by Cole for 'therapy' and an 'internship.' What Reynolds did not know was that his predecessor resigned rather than be forced to 'manufacture' false invoices for 'therapy' and an 'internship?' No problem for bottom feeder Reynolds.



3. October 2007. The 2007 murder plot failed and Watson's websites remain up on the internet warning the public about the dangers of associating with Patton West. Dr. Julio E Williams puts up \$2,000,000 of his own money so that his cult leader Patton West can fund multiple frivolous lawsuits against Watson. The motive being to bankrupt Watson into silence where intimidation and murder failed. This is exactly what Dr. Julio E Williams threatened to do in his January 2007 email to Watson.

**3.** Above: Williams followed through on his promise to fund Patton West's legal costs, just as he indicated he would in his January 2007 threatening email to Watson. Below is a short quote from Williams' email:-

I have personally allocated Two million dollars for Dr.

West defense and legal expenses.

If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down. Mr. Watson, You will have your date in court. You fuck with me and you will meet your match.

Julio E. Williams, MD

Quite by coincidence (or not) this is exactly what Patton West said would happen at a meeting she had with Watson in March 2003. A meeting called by her to see if she could threaten / intimidate Watson into not suing her for fraud. Patton West told Watson at the meeting that if he sued her, she would get so f\*cking down and dirty, huge expenses coming out of his pocket but not hers. Not hers, because members of her cult would pay her legal expenses. You can hear Patton West say this in her own voice by following this link, as Watson recorded the entire exchange between him and Patton West on a digital tape recorder. I guess this officially makes Dr. Julio E Williams a member of her cult. You heard it from the horse's mouth.



4. October 2010. Watson journeys to the USA from abroad to see what the Montana court is going to award him for winning his fraud lawsuit against Patton West. Upon arrival at the court Patton West and her accomplice Geoffrey Reynolds had Watson served with multiple frivolous lawsuits. As Watson could not afford to travel to and from the USA to defend against their lies Patton West and Geoffrey Reynolds were awarded \$5,000,000 each even though Reynolds' pleadings to the court were 100% false.

**4.** Above: Geoffrey Reynolds CPA left his employment in California to take up the position of 'Finance Controller' with Patton West's corporation in September 2006. Watson's tenure of employment ended over four years before Reynolds' tenure of employment began in 2006. This is made clear by the resume posted on Reynolds' own personal website.

However, after the murder plot (that Reynolds announced to the press in August 2007) failed, Geoffrey Reynolds agreed to be part of a criminal conspiracy to bankrupt Watson into silence. Geoffrey Reynolds' role in the conspiracy was to make totally false pleadings to a Montana court, which he did by submitting a carbon copy of Patton West's pleadings. Reynolds could not have been 'defamed' by Watson because Reynolds was working in California between 2002 & 2006 and did not know that Watson existed until Patton West briefed him post September 2006. Reynolds' treachery is spelt out in these three webpages. (1), (2) & (3).



5. The loss of millions of dollars a year from organized crime (theft, fraud and extortion) is motive enough for murder. The legal outcome that Dr. Julio E Williams MD 'bought' for Patton West enabled her to relocate her criminal business model to Arizona where she is now targeting the spiritual community in Sedona. Dr. Julio E Williams was complicit in Watson's murder, Dr. Julio E Williams funded the conspiracy to bankrupt Watson into silence and Dr. Julio E Williams is fully aware of the ongoing campaign of intimidation against Watson and family.

**5.** Above: Dr. Julio Williams MD remains central to Patton West's criminal business model to this day. Williams, a 20 year member of her cult, and right at the forefront of her criminal activities for 15 years. Williams continues to provide Patton West with a series of 'fake' testimonials whose clear objective is to lure more victims into the 'kill zone.' Rather more serious, is his role in marketing Patton West to the public and to cancer patients as being able to deliver miracle cures for six figure sums. Below, is a recent posting from Patton West's Facebook pages, wherein Patton West is inviting people to attend 'Sacred Sundays with Rishi.' These gathering to be held at the home of Dr. Julio E Williams MD. We have no doubt that Williams, her brainwashed and conditioned Physician, is on hand to persuade victims to part with their money.

In another Facebook posting, con artist Patton West is seen to be advertising 'miracle cures' though she is careful not to actually say 'miracle cures but instead refers to 'divine grace healings.' As for Dr. Julio E Williams' involvement, once again we have Patton West to thank for joining the dots. In her 2007 interview with the Whitefish Pilot newspaper, Patton West makes the following statement:-

She also claims her "gifts" can heal people with various illnesses including leukemia (cancer), and plans to teach what she knows to cardiologists and other physicians etc...

Well, quite by coincidence (or not) Dr. Julio E Williams is a cardiologist and a physician. He is also a 20 year student of her cult. Which probably explains why, against all norms and medical standards, Williams is aiding and abetting a con artist and violent convicted criminal to sell her wares to the public.

Finally, and most serious of all, is the fact that over the past 4 to 5 years Dr. Julio E Williams MD has received some 400 to 500 emails from the whistleblower complaining about the ongoing campaign of intimidation being directed at him and his family by Patton West. This is the very same campaign of intimidation (along with Watson's impending murder) that Geoffrey Reynolds announced to the press on August 9 2007. So far, Dr. Julio E Williams MD has failed to share any of these emails with the police or the FBI, in spite of being asked to do so repeatedly by Watson. This, along with several other examples, clearly show Williams' complicity in racketeering and murder. Of course neither Williams or Reynolds can go to the police because to do so, would immediately make them complicit in Patton West's past and ongoing attempts to intimidate / murder Watson.

Since the campaign of intimidation against Watson and his family / attempts to murder Watson that Reynolds announced on August 9 2007 never stopped, and are ongoing, the statute of limitations does not apply.

However, Watson and his family are just one set of victims. There are scores, maybe hundreds of victims and if Patton West's ex-husband is to be believed, several murders passed off as death by 'natural causes.' And this is going on NOW in Arizona, right under the authorities noses. Below, is just a very small sample of crimes that were committed in Montana by Patton West. Crimes committed on an industrial basis by a criminally insane narcissist, who believes she is totally beyond the reach of the law.


Treating the image below as a 'clock face', let's review some of the crimes committed in Montana by Patton West between 1995 & 2010.

At 1.00 Patton West arrives in Montana in 1995. After being chased out of New Mexico by a gun wielding victim who knew the police were unable or unwilling to help. Upon arrival in Montana, Patton West calls herself the Ascended Master Devra JI and sets about building a cult around herself.

At 2.00 business consultant John Watson is defrauded out of pay and shares (see above). In 2008, Watson was granted judgment against Patton West and was awarded over \$700,000 in costs and damages by a Montana court.



At 3.00 Kendall Haywood lost her daughter. A child custody court case was totally subverted by Patton West, who mounted a campaign of violent intimidation against a clean living, decent honest mother, so that Patton West's porn loving, wife beating son, could get custody of an infant female child from its mother. How do you persuade the court that a porn loving, wife beating parent, Chris Haywood (Patton West's son), who had an FBI record for forgery, substance abuse and traffic violations should be given custody over the mother who was decent and honest? How do you persuade the court that the father, who just before the court hearing forced his underage girl friend to have an abortion because it would look bad when he was attending the child custody hearing, to give the father custody. Patton West turns the mother into a basket case by targeting her for months on end before the court hearing with a campaign of occult 'under the radar' violence, that has the poor girl thinking she is mentally ill. In addition to the relentless violence, Patton West puts up as a witness for her son, a physician, who just happens to be a senior member of her cult. Not surprisingly, the physician Dr. Pat Cole MD, tells the court exactly what Patton West wants the court to hear. Result? Patton West's son gets custody. Kendall Haywood loses her daughter. Patton West tries the same strategy a few short years later, when wife number two, Jamie Haywood sues for divorce. Only this time, Jamie Haywood escapes with her infant daughter. At 4.00 Mike Hendrickson victim of Fraud. Mike signed a note guaranteeing a \$200,000 overdraft for the charity Patton West ran with her husband, Jack West. Patton West empties the bank account into a personal trust fund for her and her eldest son, Rob Meador, with the result that Mike Hendrickson has to pay the bank \$200,000 to cover his guarantee. This is mentioned briefly in the Whitefish Pilot news article. At 5.00 Dave Kushner victim of Fraud. Dave agreed to loan Patton West \$30,000 for two weeks and even got a signature on a loan agreement from Patton West, agreeing to repay the loan within the stated time period. Once Patton West got the money, she refused all contact with Dave Kushner and refused to repay the loan to him. Dave, like many victims of fraud / extortion, had a choice to make; walk away and write it off to experience or become a victim of intimidation, violence and or murder. 

At 7.00 Lisa Swidler murdered to keep her quiet. Lisa was murdered by Patton West after attempting to leave the cult. Lisa was a witness to the crimes committed against Dave Kushner and Marion Cantwell. Because the weapon used to murder Lisa (and others) is not regarded as a weapon under legal statute, the murder was treated as a death resulting from 'natural causes.' Though why the sudden mysterious death of a young healthy mother of two, resulting from internal bleeding, should occur is a mystery. Ten years later, art work and valuables all turned up after the statute of limitations on theft expired and were featured on her website as part of a 'moving sale.' The items all matched a list Watson had compiled in 2002, as part of calculating the value of the charity's assets. 9.00 Patton West changes her name to the Ascended Master Surya Ma. After her charity was struck off for fraud, Patton West announces that due to the fact she is moving from the 5th to the 7th dimension, she needs to move to a location with higher vibrations. Accordingly, Patton West moves her cult from Victor Mt to Flathead Lake MT. She also announces that she can only take 12 disciples with her and only those willing to commit 66% of their net worth to her!







<u>10.00 Patton West viciously assaults her business partner Dr. Pat Cole MD</u>. The <u>Whitefish Pilot</u> newspaper gave an account of the victim's ordeal. What follows is an excerpt from that article.

Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on the top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads. "She threatened to kill me with a gun to my head, 'blowing my brains out,' and advised me to commit suicide by slitting my wrists, after I'd taken out an insurance policy on myself." Photos taken after the alleged beating were submitted to the sheriff's office.

Cult members, **Dr. Julio Williams** (<u>1</u> & <u>2</u>), **Geoffrey Reynolds CPA** (<u>1</u>, <u>2</u>, <u>3</u> & <u>4</u>) & **Jack West** (<u>1</u>) all deny assault on Dr. Pat Cole knowing about <u>Devra's West's email</u> to her cult mailing list wherein she admitted the assault. 
